H-GAC presented the air quality analysis results to the committee and explained that for the years 2011 and 2014 there has been no changes in the transportation networks. The results from 2011 are the same as in the previous conformity because it was not impacted by the changes due to the 2012 registration distribution, diesel fractions and TxLED adjustments.

H-GAC also explained that the emissions went up due to the use of the new registration distribution that shows that the fleet is older than before.

2. Discussion

It was announced that H-GAC had two public meetings on November 13th, at noon and at 6 pm, for which only two people came.
