### 2. Discussion of "HGB Pre-analysis Consensus Plan for Transportation Conformity"

The document was approved with the following changes:

- Use of the MVEB from the 2008 RFP SIP
- Update the VMT mix using new available data from 2007.
- Update the seasonal factor using new available data from 2007. (TTI will provide the new factor.)
- It was agreed to use the same HPMS factor that was used in last conformity because it is a validation to the 2002 base year, but to expand this figure to 5 decimal places for consistency with the other factors.
- To change "Calendar dates: August 30" to "Calendar dates: ozone seasonhourly averages from 10 highest ozone excedence days from 2003-2005". There will be no calendar dates, only averages.
- Use of the same meteorological data as the 2008 RFP SIP.
- H-GAC will reorder the TIP and RTP project listings.

### 3. Timeline

All the calculations will be finished by the beginning of June. This allows a 30 day comment period to start and end by the beginning of July. The document will be presented to TAC and TPC in June during the com comment period.
