

INTERNATIONAL TRADE & EXPORTS

Texas continues to rank as the number one exporter in the United States for 18 straight years. The Lone Star State exported more than \$328.8 billion in goods in 2019 and continues to be a global leader in international trade.



For the 7th consecutive year, Texas leads the nation in high-tech exports, totaling \$49.4 billion.



Texas leads the nation in jobs supported by exports at more than 910,000 jobs.



Small businesses account for nearly 93% of the more than 400,000 Texas exporters.

TEXAS ECONOMIC IMPACT



Texas civilian labor force is now 14.4 million (up from 13 million in May).



In August, Texas added 106,800 nonfarm jobs.



Between June and July, Texas exports increased by \$7.6 billion, or approximately 7%.



State sales tax revenue for the three months ending in August was down 2.7% compared to last year.

In July, Texas led the nation in job creation over the last 10 years.


TEXAS ECONOMIC OUTLOOK



Texas added a total of 163,500 jobs in June through August, after leading the nation in job creation in May with 237,800 jobs added.





FY2020 PROJECTS






TEXAS UNEMPLOYMENT

Texas' Unemployment




National Unemployment

Texas factory activity expanded in August, for the third month in a row. The production index is down slightly from July, but still indicative of moderate growth.






TEXAS SERVICE SECTOR OUTLOOK



Activity in the Texas service sector held mostly steady in August.






TEXAS RETAIL OUTLOOK



Retail sales activity declined in August, though at a much slower pace than July.





STATE REVENUE ESTIMATE

On July 20, 2020, Comptroller Glenn Hegar released an update to the Certification Revenue Estimate (CRE), originally published in October 2019.

- Texas will now have an estimated \$110.19 billion in General Revenue-related (GR-R) funds available for the 2020-21 biennium (down \$11.57 billion, or 9.5%, from the October estimate).
- This does not account for the previously requested 5% reduction and is based on numerous assumptions
- This results in a projected deficit of \$4.58 billion (previously projected surplus of \$2.89 billion).

INITIAL STATE RESPONSE TO COVID-19

The Governor issued a series of waivers to help increase the speed of supplies and assist our state's businesses:

- Creating Supply Chain Strike Force
- Allowing Restaurants to Sell Bulk Products to Consumers
- Allowing Delivery of Alcoholic Beverages with Food
- Allowing Trucks from Alcohol Industry to Deliver Grocery Supplies
- Certain State Trucking Regulations


The Governor requested a disaster declaration so that Texas businesses could be eligible to apply for federal funding through the Economic Injury Disaster Loan.





APRIL 27 & MAY 5

• Governor Abbott announced Phase I of business openings with certain occupancy limitations.

MAY 18 & MAY 26

• Governor Abbott announced Phase II of expanded business openings.

JUNE 3

 Governor Abbott announced Phase III, which allowed all businesses to operate at 50%, with very limited exceptions.*

JUNE 26

- Governor Abbott paused the reopening process in order to limit the spread of COVID-19.
- Bars and rafting/tubing establishments were ordered to close.

*Subject to the minimum standard health protocols outlined by the Texas Department of State Health Services.

SEPTEMBER 17

- The Governor announced select expanded businesses openings for hospitalization areas with low COVID-19 hospitalization rates (below 15%).
- Effective September 21, the following entities may operate at 75% capacity:
 - Gyms & Exercise Facilities
 - Manufacturers
 - Museums & Libraries
 - Office-Based Employers
 - Restaurants
 - Retailers
