The presiding officer, Chair David Robinson called the Transportation Policy Council (TPC) meeting of November 17, 2023 at 9:30 a.m. to order.

ITEM 9. TRANSPORTATION AIR QUALITY CONFORMITY UPDATE, MR. ANDREW DECANDIS, H-GAC

Mr. Andrew DeCandis, H-GAC, gave an update on the Transportation Air Quality Conformity. Mr. DeCandis informed the Council that staff had received concurrence from FHWA on November 1, 2023 and the Conformity Lapse Grace Period has ended. TIP/RTP amendments are allowed. Projects that have been amended and included in the TIP/STIP can now be formally approved. Mr. Craig Raborn, H-GAC concluded the presentation with additional information regarding the Air Quality Conformity.

ITEM 10. AMENDMENTS TO THE 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM AND THE 2045 REGIONAL TRANSPORTATION PLAN, ADAM BECKOM, H-GAC

Mr. Adam Beckom, H-GAC gave a presentation on the Amendments to the 2023-2026 Transportation Improvement Program and the 2045 Regional Transportation Plan. A summary of the proposed revisions to the 2023-2026 TIP and 2045 RTP is included below:

- Program the Houston-Galveston Area Council's Regional Transportation Models and Tools project (MPO ID 19006) in FY 2024 with \$5.5M of federal Surface Transportation Block Grant (STBG) funds matched with 1.1M Transportation Development Credits. (+\$5.5M; Total: \$5.5M)
- Add \$6.8M of STBG funds to the City of Baytown's FY 2025 Garth Road widening project (MPO ID 17096) to cover estimated cost increases caused by inflation of several construction components. The City will match \$5.4M of federal funds with \$1.4M of local funds. (+\$6.8M; Total Cost: \$48.5M)
- Delay the City of Pearland's Transportation Alternative Set Aside (TASA) funded Clear Creek Trail
 construction projects (MPOIDs 7127, 7641) from FY 2023 to FY 2025 to allow for completion of
 design work. (Total Cost: \$9.1M)
- Delay the Port of Houston's locally funded Broadway Street widening project (MPOID 7510) from FY 2023 to FY 2024 due to readiness. (Total Cost: \$2.6M)
- Delay the Port of Galveston's locally funded Cruise Terminal Parking Garage project (MPOID 7566) from FY 2023 to FY 2024 as it is awaiting federal approval. (Total Cost: \$7.9M)
- Delay the Port of Galveston's STBG funded Downtown Livable Communities Initiative project (MPOID 7739) from FY 2023 to FY 2026 to allow for completion of design work. (Total Cost: \$3.5M)
- Delay the Port of Galveston's locally funded 51st Street Flyover project (MPOID 15492) from FY 2023 to FY 2024 due to readiness. (Total Cost: \$17.0M)
- Delay METRO's Congestion Mitigation/Air Quality (CMAQ) funded Diesel Bus Purchase project (MPOID 15243) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$29.2M)
- Delay METRO's CMAQ funded US 290 Ramp construction project (MPOID 17041) from FY 2023 to FY 2024 due to readiness. (Total Cost: \$41.9M)

- Delay METRO's CMAQ funded METRO Star Vanpool Program (MPOID 18355) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$2.4M)
- Delay METRO's STBG funded Regional Vanpool Program (MPOID 18367) from FY 2023 to FY 2024 due to sponsor priorities. (Total Cost: \$3.8M)
- Delay METRO's locally funded Transit Center Modifications project (MPOID 18371) from FY 2023 to FY 2024 as it had to await federal approval. (Total Cost: \$1.4M)
- Delay METRO's CMAQ funded Regional Fare System (MPOID 18846) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$5.0M)
- Delay the Harris County Toll Road Authority's locally funded SH 225 Direct Connectors construction project at SL 8 (MPOID 16340) from FY 2023 to FY 2024 due to readiness. (Total Cost: \$29.0M)
- Delay the Harris County Toll Road Authority's TASA funded Galveston Road Pedestrian Bridge construction project (MPOID 18030) from FY 2024 to FY 2026 to allow for completion of US Army Corp of Engineers permits. (Total Cost: \$737K)
- Advance the Harris County Toll Road Authority's locally funded SH 225 Direct Connectors construction project at SL 8 (MPOID 18883) from FY 2028 to FY 2026 due to increased priority and readiness. (Total Cost: \$24.0M)
- Delay the City of League City's TASA funded Bike Lane construction project (MPOID 17117) from FY 2023 to FY 2025 to allow for completion of design work. Also, change project limit. (Total Cost: \$2.9M)
- Delay the City of Houston's TASA funded Memorial Park Bicycle/Pedestrian Connection construction project (MPOID 18146) from FY 2023 to FY 2025 due to railroad coordination requirements. (Total Cost: \$3.2M)
- Delay City of Bellaire's CMAQ funded Wireless Communications project (MPOID 18020) from FY 2024 to FY 2025 due to timing of the Advanced Funding Agreement. (Total Cost: \$867K)
- Delay Fort Bend County Public Transportation's CMAQ funded Bus Purchase (MPOID 18238) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$476K)
- Delay the Houston-Galveston Area Council's CMAQ funded Clean Vehicles Program (MPOID 18853) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$8.0M)
- Delay the Houston-Galveston Area Council's CMAQ funded Commuter and Transit Pilot Program (MPOID 18854) from FY 2023 to FY 2024 as it awaits federal approval. (Total Cost: \$7.0M)
- Delay the Houston-Galveston Area Council's STBG funded High-Capacity Transit Studies project (MPOID 18618) from FY 2023 to FY 2024 to allow for completion of the Advanced Funding Agreement. (Total Cost: \$1.3M)

- Delay the Houston-Galveston Area Council's STBG funded Safety Public Outreach project (MPOID 18818) from FY 2023 to FY 2024 to allow for completion of the Advanced Funding Agreement. (Total Cost: \$2.3M)
- Modify the scope of work for the Midtown Management District's Brazos Street Pedestrian-Transit Improvements project (MPO ID 17092) to include bicycle facilities and utilities improvements (Total Cost: \$5.1M)

Mr. Beckom gave a brief recap of August 2023, September 2023 and October 2023 amendments to the TIP and RTP put on hold as the region entered an Air Quality Conformity and now can be formally approved. Mr. Beckom requested approval by the TPC approval of Resolutions 2023-28, 2023-30, 2023-31,2023-32, 2023-34 and 2023-35. A discussion period occurred before the Council vote. A motion was made by Mayor Joe Zimmerman and seconded by Mayor Kevin Cole. The Council voted and approved TPC Resolutions 2023-28, 2023-30, 2023-31,2023-32, 2023-34 and 2023-35.

ITEM 12. CARRY OVER BALANCE POLICY DISCUSSION. MR, ADAM BECKOM, H-GAC

Mr. Adam Beckom, H-GAC made a presentation regarding the Carry Over Balance Policy and the updates that were requested to the document by the TPC, TAC and TIP Subcommittee. The changes consisted of the following:

- 1. Achieve and maintain up to a 200% cap on annually apportioned funds
- 2. Advance Projects for TPC funding
- 3. Project readiness assessments
- 4. Additional strategies where/when appropriate
- 5. Secondary goals of this policy include the following:
 - a. Expedite project implementation
 - b. Manage cost increase due to inflation
 - c. Encourage participation in the Regional Strategic Transportation Fund (RSTF)
 - d. Enhance the region's transportation infrastructure
- 6. Projects must advance the goals of the RTP and meet the project selection requirements

Mr. Beckom also briefly described the 6 strategies that staff would be bringing to the Council for consideration in a Carry Over/Spend Down situation and gave an overview on specific changes to two of the

strategies. Mr. Beckom requested TPC approval of the Carry Over Balance Policy. A lengthy discussion and comment period occurred after this presentation. A motion was made to table and seconded to table Item 12 with consideration for revising the language to include participation of the TPC, H-GAC Staff, and the MPO Director. The Council voted and approved to table Item 12.

ITEM 13. CARRYOVER/SPEND DOWN PROJECTS, MS. CALLIE BARNES, H-GAC

Ms. Callie Barns, H-GAC gave an update on the projects that can be let in a 0-2 year timeline that would spend down carryover balances. Ms. Barnes informed that Council that last month staff presented 91 projects from 26 sponsors that could be let in a 0-2 year timeframe. Ms. Barnes described specifics in refining the list. The projects have been pared down to 51 projects with 22 sponsors at a \$328M total cost, spend down target amounts at a total cost of \$330M, described a summary table of the projects, projects recommended by staff, and a funding eligibility summary table. Ms. Barnes informed the Council that staff will work with Local Sponsors and TxDOT prior to final selection of projects.

Mr. Lingala proceeded with his presentation with the Project Selection Process Update and described the next investment categories that staff will review and recommend for TPC Approval, next steps and available funding. ITEM 15.FUTURE AMENDMENTS TO THE 2023-2026 TRANSPORTATION IMPROVEMENT PLAN AND THE REGIONAL TRANSPORTATION PLAN, JIM DICKINSON, H-GAC

Mr. Jim Dickinson, H-GAC, presented the Future Amendments to the 2023-2026 Transportation Improvement Plan and the Regional Transportation Plan. A summary of the proposed revisions to the 2023-2026 TIP and 2045 RTP is included below for the Council's review.

Add \$3.9M of Statewide Right of Way funds to the TxDOT Houston District's SH 36 reconstruction
and widening project (MPO ID 263) reflect relocation, title, and court costs of all parcels in FY 2026
with \$15.1M of federal SW ROW funds matched with \$3.8M state funds.

- Delay TxDOT Houston District's SH 332 widening project (MPO ID 525) from FY 2025 to FY 2028 to allow for design and ROW acquisition.
- Delay TxDOT Houston District's SH 105 widening project (MPO ID 965) from FY 2025 to FY 2026 due to ROW and utility relocation issues.
- Add \$115.6M of Statewide Connectivity Corridors funding, \$91.6M of Statewide ROW, and Remove \$144.8M of Preventative Maintenance and Design Build funds to TxDOT Houston District's IH 69 S reconstruction, widening and reconstruction of interchange at SH 288 (MPOID 7428 -NHHIP Seg-3) projects.
- Advance TxDOT Houston District's US 90 grade separation project (MPO ID 10268) at Purple Sage Rd from FY 2026 of the 2045 Regional Transportation Plan to FY 2024 of the 2023-2026 TIP with \$35.1M of Statewide Connectivity Corridors funds.
- Delay Lake Houston Redevelopment Authority's NorthPark Drive's widening project (MPO ID 18033)
 from FY 2026 to FY 2028 to allow for ROW acquisition and utility relocation.
- Delay TxDOT Houston District's SH 6 grade separation construction project at Clay Road (MPO ID 18509) from FY 2025 to FY 2029 due to ROW acquisition and utility relocation issues, as well as coordinating with other corridor construction projects.
- Clarify limits on TxDOT Houston District's IH 10 E reconstruction and widening project (MPO ID 18707).
- Program TxDOT Houston District's \$10M of Statewide ROW funds to advance ROW acquisition project (MPO ID 19009) in FY 2023-2026 TIP in FY 2024 for IH 45 S Parkway Connectors into downtown (NHHIP SEG-3D).
- Program TxDOT Houston District's \$800M of Statewide ROW funds to advance ROW acquisition project (MPO ID 19010) in FY 2023-2026 TIP in FY 2024 for IH 45 S RECONSTRUCT IH45/IH69 INTERCHANGE & REALIGN/WIDEN IH 45 project (NHHIP SEG-3D).
