#### CALL TO ORDER

The Honorable Sallie Alcorn, Houston Council Member and Chair of the Board called the meeting to order at 10:00 a.m. on Tuesday, March 19, 2024, at 3555 Timmons Lane.

#### 1. INVOCATION

The Honorable KP George, Fort Bend County Judge, gave the invocation.

#### 2. PLEDGE OF ALLEGIANCE

The Honorable KP George, Fort Bend County Judge, led the Pledge of Allegiance and the Pledge to the Texas Flag.

#### **ROLL CALL**

Chair Alcorn asked Rick Guerrero to conduct the Board of Directors roll call. Mr. Guerrero conducted the roll call and announced that a quorum was present. Mr. Guerrero introduced special guests in the audience: Jay Guerrero (Office of State Senator John Cornyn), Melissa Washington and Regina Recinos (General Land Office), Freddy Guerra, Aylin Rodriguez, and Talya Morris (Office of Lesley Briones), Katie Shelton (Office of Sallie Alcorn), William King (Former Chair).

#### 3. PUBLIC COMMENT

Chair Alcorn invited comments from any members of the public who wished to participate during the meeting and asked Mr. Guerrero if any requests for public comments had been received. Mr. Guerrero stated that there were no public comments. There being no public comments Chair Alcorn proceeded to the next item on the agenda.

#### c. Executive Directors Report

#### AIRPORT TRAFFIC DEMAND MODEL

#### **Background**

The Houston-Galveston Area Council and the City of Houston Airport System are engaged in the collaborative effort "Commercial Airports Ground Access Survey" to collect travel data to and from the region's two international airports, George Bush Intercontinental and William P. Hobby.

Both airports play a crucial role in regional travel trip production patterns. Significant shifts in regional travel demand, the socioeconomic environment, and regional transportation networks have necessitated an update to H-GAC's regional models, as well as the development of a new Airport Sub-Component.

The primary objective of the survey is to gather valuable information and insights about the characteristics and travel patterns of airport users, as well as the modes of their ground access. The collected data will be integrated into H-GAC's regional travel model and used to develop airport sub-models.

#### **Current Situation**

On April 8th, 2023, the Board authorized H-GAC staff to negotiate a contract with ETC Institute to execute the scope of work of the airport survey for an amount not to exceed \$750,000. ETC was initially contracted to conduct the data collection portions of the survey (Task #1 through Task #5) for a contract sum of \$577,174. As of today, Tasks 1 through 4 have been completed, Task 5 (final documentation) is 80% complete.

H-GAC now seeks to implement Task #6 (Airport Sub-Model Development) of the same scope of work. Approval is requested to authorize a contract amendment of \$216,314.00 for the development of the airport sub-model and the extension by a 12-month period until May 31, 2025. The additional requested funds would exceed the originally approved amount of \$750,000 by \$43,488.

#### TEXAS TRANSPORTATION INSTITUTE INTERLOCAL AGREEMENT

#### **Background**

In response to the changes in travel behavior post-pandemic, the Houston-Galveston Area Council is actively gathering diverse traffic data throughout the Metropolitan Planning Area. H-GAC staff continues to work towards the update of the regional traditional travel demand and forecasting model while simultaneously developing new travel forecasting tools. These enhancements require a profound and complete understanding of the existing regional models and the travel survey data used for its testing and development.

The Texas A&M Transportation Institute is currently providing on-call support to H-GAC staff, assisting with travel demand model development, updates, as well as validation of the modeling system to newer survey data. In 2022, H-GAC entered an Interlocal Agreement with The Texas A&M Transportation Institute for \$100,000 over a period of two years, expiring on Nov. 30, 2024. Texas A&M Transportation Institute has proven to be a reliable and valued consultant with superior qualifications regarding the understanding of H-GAC's models.

#### **Current Situation**

To continue sustained support for the model update and development efforts, H-GAC is requesting an additional \$100,000 to be added to the current Interlocal Agreement with Texas A&M Transportation Institute and extend the contract period for six months to May 31, 2025. These additional funds will also assist in continual support for studies and tasks in the current Unified Planning Work Program.

#### REGIONAL HOMELAND SECURITY PLANNING INITIATIVE - FISCAL YEAR 2024

#### **Background**

The Emergency Preparedness Program assists local jurisdictions with a variety of planning and coordination services as part of an ongoing relationship with the Office of the Governor's Public Safety Office. Through this Regional Homeland Security Planning Initiative, H-GAC facilitates a Regional Homeland Security Coordinating Council; manages an Emergency Preparedness program to increase regional resilience to natural and manmade disasters; and provides direct support to member governments and regional coalitions on a range of security and resilience planning activities. The intent of this program is to increase the ability of the region to prevent, respond, and recover from all hazards, including acts of terrorism.

#### **Current Situation**

This grant project will allow H-GAC to continue these homeland security planning activities for the 13-county region. H-GAC staff will coordinate the development of the Regional Homeland Security Implementation Plan; work with the Houston Urban Area Security Initiative; coordinate the Regional Homeland Security Coordinating Council; represent the region as part of statewide homeland security/emergency management work groups; and conduct regional and local homeland security and emergency management catastrophic planning. In addition, H-GAC staff will assist jurisdictions with adopting/revising the Gulf Coast State Planning Regional Mutual Aid Agreement. Lastly, the grant project will provide H-GAC staff the training and associated travel required to perform these activities in accordance with best practices.

#### FISCAL YEAR 2024-2025 LAW ENFORCEMENT TRAINING

#### **Background**

H-GAC has sponsored a regional law enforcement training program for over thirty years. The program supports the Texas Commission on Law Enforcement Officers approved training for officers throughout the region by contracting with local law enforcement training academies that meet state standards.

#### **Current Situation**

H-GAC has requested proposals from qualified law enforcement training academies for Fiscal Year 2024–2025 in-service, basic and advanced training. When preparing recommendations, staff will use the results of the annual Training Needs Survey, cost per contact hour, geographic accessibility, and the number of officers to be served. Staff recommends a combination of basic, intermediate, advanced, and specialized training. Staff recommends awarding contracts to the following academies and contracted training provider in the amounts shown below:

Brazoria County Sheriff's Office	\$74,097
Fort Bend County Sheriff's Office	\$110,865
Harris County Sheriff's Office	\$208,893

#### FISCAL YEAR 2025 REGIONAL JUVENILE MENTAL HEALTH SERVICES

#### **Background**

There is an increasing need for counties to address mental health issues of youth referred to their Juvenile Probation Departments. This topic is listed as a need in county Community Plans and is a priority in the Commissioner's Courts of our region. Of particular concern are juveniles in need of diagnosis and therapy. Because this is a region-wide need, the H-GAC Criminal Justice Program is applying for funds that would enable counties to increase the availability of diagnostic and counseling services for these individuals.

#### **Current Situation**

The Fiscal Year 2025 project is providing counseling and mental health services for juveniles in the nine counties currently contracting with the Houston-Galveston Area Council. Surveys are being conducted to determine exact needs in the juvenile counseling/mental health area among the thirteen Juvenile Probation Departments in the region. Once identified, \$115,903 in pass-through funds will be made available to the juvenile probation departments to provide diagnostic services and/or professional therapy if needed.

# FISCAL YEAR 2025 VICTIMS OF CRIME ACT APPLICATION - ELDER JUSTICE PROGRAM

#### **Background**

Elder abuse is one of the nation's fastest-growing crimes. As the Baby Boomer generation ages, the number of elder abuse cases in the United States is predicted to at least double by 2030. This rising tide of elder abuse has major implications for the H-GAC region given that Texas is home to the nation's third-largest senior population.

H-GAC's Elder Justice Program directly assists senior citizens and disabled individuals who have fallen victim to crime in obtaining protection and, where possible, restitution and recovery. H-GAC concentrates on filling the #1 unmet victim need—for assistance navigating the criminal justice system and accessing legal protections—through the work of three H-GAC staff attorneys. The Elder Justice Program also provides training and technical assistance in handling elder abuse cases to law enforcement, prosecutors, Adult Protective Services caseworkers and investigators, and other criminal-justice system stakeholders.

#### **Current Situation**

H-GAC's Elder Justice Program seeks authorization to apply for renewal of its Victims of Crime Act grant. Victims of Crime Act funds underwrite three H-GAC staff attorneys who provide elderly and disabled victims of crime with legal advocacy, and access to basic legal tools such as protective orders and powers of attorney. At present, the Elder Justice Program serves victims in Chambers, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Waller and Wharton counties. If renewed, this Victims of Crime Act grant will cover program operating expenses from October 1, 2024 through September 30, 2025.

# TEXAS SOUTHERN UNIVERSITY AUTONOMOUS VEHICLE SHUTTLE PLANNING PROJECT

#### **Background**

The Texas Southern University Autonomous Vehicle Shuttle Project is a planning demonstration project conducted in partnership with the Metropolitan Transit Authority of Harris County. This project is designed to assess the physical and operational characteristics of an autonomous vehicle as well as assess public perception.

The first phase of the pilot project took place from summer 2019 to spring 2020 operating on the "Tiger Walk" on Texas Southern University's campus. In phase II, the route will operate off campus and is anticipated to connect Texas Southern University to Metropolitan Transit Authority's Eastwood Transit Center. The Metropolitan Transit Authority has provided funding for vehicle acquisition and operations. H-GAC was asked to support data collection and analysis by The Texas Southern University. This project was approved by the Transportation Policy Council for inclusion in the 2024 Unified Planning Work Program.

#### **Current Situation**

If approved by the board, H-GAC will provide up to \$170,000 to support The Texas Southern University's planning efforts over the course of two years for this Autonomous Vehicle Shuttle service. This budget covers costs associated with the analytical tasks of the demonstration project undertaken by The Texas Southern University students & staff. It does not include payment for any operational or capital costs. The analysis tasks are anticipated to include data collection and assessment of a variety of factors, such as:

Passenger Surveys, Field Data Collection, Ridership Recording, Physical and Operating Parameters, Maintenance and Storage Criteria, Vehicle Slow-downs and Stalls, Energy Utilization Analysis, Vehicle Characteristics, Schedule and Run Time, Ridership, Patrons with Disabilities, Weather and Safety, Rain and Humidity Report, and Incident Report.



The fees came in at a slower rate this month than last month - 186K in March compared to 511K in February. **EXPENDITURES** > Consultant expenses are under the projection level currently mainly in the Community & Environmental, Aging, & Transportation programs. > Equipment expenses increased nearly 250K during the month of March due to the issuance of final contractor payments related to the renovation. > Our lease of the 3rd floor ended on March 31st and this will reduce the monthly rent by 20K. # **Monthly Trends Chart**







#### 2023 CLEAN SCHOOL BUS APPLICATION - ALIEF ISD

#### **Background**

As part of the 2023 Clean School Bus Grant Program, the United States Environmental Protection Agency is awarding approximately \$400 million in grants to school districts and other eligible entities from across the nation to fund projects that achieve significant diesel emission reductions by replacing highly polluting buses and accelerating the transformation to low and zero emission alternatives. Specifically, this program addresses harmful emissions from pollutants that contribute to poor air quality and that negatively impact human health and the health of the children riding within these vehicles.

#### **Current Situation**

Alief Independent School District has applied to the Environmental Protection Agency's Clean School Bus Grant Program to replace twenty Class 7 diesel school buses with twenty Class ZE-Class 7+ electric school buses, as well as, five DC fast chargers to provide power to the project vehicles. Each of the Project's twenty school buses are estimated to cost \$385,000 each and the five associated DC fast chargers are estimated to cost \$100,000 per unit. Additional construction work and equipment upgrades as well as driver and technician training add approximately \$2,343,580, for a total project cost of \$10,543,580. The Environmental Protection Agency Clean School Bus grant will provide 75% of the total project costs and Alief ISD will provide the remaining 25% as project cost share.

The implementation of this project will confirm Alief ISD's commitment to providing students, staff, and community with cleaner air by reducing the pollutants released by diesel operated buses and will contribute to the district's goal to discontinue 10% of diesel-operated buses in the district fleet by 2028.

This project is consistent and is supportive of H-GAC's policies and efforts to improve regional air quality and meet the National Ambient Air Quality Standard for ozone and fine particulate matter.

#### CRIMINAL JUSTICE FUNDS FISCAL YEAR 2025

#### **Background**

The Criminal Justice Funding Program supports projects that address needs of crime victims and help prevent or reduce crime by enhancing criminal justice efforts in the region. This is accomplished by providing community planning support and technical assistance for applicants desiring to fund projects that meet one or more of these objectives.

#### **Current Situation**

The Criminal Justice Funding Program supports projects that address needs of crime victims and that help prevent or reduce crime by enhancing criminal justice efforts in the region. H-GAC staff support this grant program by providing community planning support, technical assistance for applicants, and facilitating the Criminal Justice Advisory Committee which develops priority rankings of projects.

The program areas funded under the Request for Applications include the Criminal Justice Program, the Juvenile Justice and Truancy Prevention program, the General Victim Assistance Grant Program, and the Violence Against Women Justice and Training Program.

The funding sources are then scored and ranked by a Criminal Justice Advisory Committee who are recommended by the H-GAC Board. This committee advises on criminal justice issues and recommends funding priorities for grants in the region.

Once approved by the H-GAC Board of Directors, these applications compete at the state level for available funds. Awards made by Criminal Justice Division may deviate from the H-GAC recommendations to achieve statewide priorities.

# TEXAS COMMUNITY DEVELOPMENT BLOCK GRANT REGIONAL PROJECT PRIORITIES

## **Background**

The Texas Department of Agriculture administers the U.S. Department of Housing and Urban Development's Community Development Block Grants for non-entitlement communities. Non-entitlement communities do not receive direct grant funding from Housing and Urban Development. The Community Development Fund is the largest fund category in the Texas Community Development Block Grant Program. This fund is available on a biennial basis for funding through a competition in each of the 24 state planning regions, including the H-GAC region. Eligible applicants are rural cities under 50,000 in population, and counties that have a non-metropolitan population under 200,000 and are not eligible for direct Community Development Block Grant Program funding from Housing and Urban Development.

## **Current Situation**

The Houston-Galveston Area Council, in conjunction with Texas Department of Agriculture, is beginning the planning process for the 2025-2026 Community Development application cycle. Texas Department of Agriculture has requested that the H-GAC establish regional project priorities for Community Development Block Grant program application scoring. The regional project priorities will be categorized by tier and assigned points per tier. Although historically most Community Development funds are used for Public Facilities (water/wastewater infrastructure, street and drainage improvements and housing activities), there are numerous other activities for which these funds may be used. Regional project priority points will account for 25% of the total points in scoring 2025-2026 Community Development applications.

As part of this process, H-GAC requested input on the establishment of regional project priorities via an online Regional Project Priority Survey. The public was invited to complete an online survey to help establish Regional Priority Projects by ranking a list of suggested priorities based on importance and providing comments. From March 11, 2024 to March 21, 2024, we received sixteen responses to the regional project priority survey. A public meeting was held on March 25, 2024, to review the survey results and recommended regional project priorities and to provide input. No comments were received.

Based on survey results and the public meeting discussion, H-GAC is recommending the following regional priorities:

## REGIONAL STRATEGIC TRANSPORTATION FUND

## **Background**

In November 2020, the Transportation Policy Council approved the update of the Transportation Development Credit policy. As part of the policy update, the Transportation Policy Council approved the creation of the Regional Strategic Transportation Fund which provides a mechanism to exchange transportation development credits for local funds. These local funds would then be used to support lower-cost, high impact transportation projects that can be implemented in the near term and improve funding flexibility.

## **Current Situation**

On December 15, 2023, the Transportation Policy Council approved the Carryover Spend Down projects to be implemented within the next two years. These projects would utilize approximately \$330M in surface transportation funds that have been carried over from previous fiscal years and are subject to expiration at the end of FY 2025. As part of the Transportation Policy Council action, project sponsors agreed to participate in the Regional Strategic Transportation Fund. The Transportation Policy Council will fully fund the projects from federal sources and provide transportation development credits as the match. The project sponsors would contribute 10% of the project cost into the Regional Strategic Transportation Fund. The project sponsor would also commit to spend 10% of the project cost on other transportation activities within the region.

Interlocal Agreements with the sponsors listed in the attached table are needed to receive a minimum of \$22,630,079 into the Regional Strategic Transportation Fund. The Transportation Policy Council can use the funds to support grant applications sponsored by H-GAC as well as projects that impact the following focus areas:

- Non-state routes in rural areas
- Maintenance and preservation of roadways in small-urban, rural, and economically disadvantaged areas
- Investment in local active transportation projects
- Localized safety improvements to address discrete pedestrian conflict points and intersections.

The Gulf Coast Workforce Board provides various services to improve the quality of early childhood education throughout the region. To continuously address the needs of childcare providers, we identified the need for an early education teacher recruitment and preparation program as a pathway for entry level child care teachers to gain the training and experience needed to provide quality learning for young children.

H-GAC issued a competitive, sealed solicitation to solicit qualified contractors for the goods or services requested under Project ID: HS-WKF-EEPP-10-23 on October 4, 2023 and which closed on November 16, 2023. Five responsive submissions were received and evaluated by a committee of representatives from H-GAC. Based on the committee's scoring and evaluation of the proposal responses, the recommendation and rankings are presented below:

## PARTNERS FOR REENTRY OPPORTUNITIES IN WORKFORCE DEVELOPMENT

## **Background**

The Department of Justice and the Department of Labor launched a grant initiative to provide targeted employment services to federally incarcerated individuals as they approach community reentry. The Partners for Reentry Opportunities in Workforce Development grant program seeks to better align job training and skills development services provided to program participants to the specific labor market needs of the communities where they will live.

### **Current Situation**

The Texas Workforce Commission reached out to Workforce Development Boards interested in joining this project, successfully securing \$4.6 million in partnership with eight Workforce Development Boards. Gulf Coast received an initial grant award of \$212,408 in February 2023 with an anticipated future allocation of \$200,000 later this year.

In our grant application we proposed partnering with Alvin Community College given their proven track record in this space. In 2021 Alvin Community College developed the New Beginnings Project to provide second-chance students classes leading to degree/certification in partnership with the Texas Department of Criminal Justice. The program matches regional employers with individuals possessing industry-required skillsets and connects second-chance individuals with support systems in local communities.

Through the Partners for Reentry Opportunities in Workforce Development grant we will serve individuals during their time with a reentry center or under home confinement and as they transition into the community after their full release. We plan to serve 105 people over a three-year period.
