Item 3 – Call for Project Development Update and Active Transportation Recommendations

Three topics were addressed under this item.

1. Project Prioritization & Policies Workgroup Meeting Summary

Adam Beckom recapped progress made under the new guidelines. Staff is developing a matrix to demonstrate adherence to the guidelines. Also considered were the differences between the Benefit\Cost Analysis for active transportation projects and the roadway projects; Progress on the planning factors; and how to account the Total Project Cost.

2. Updated Planning Factors Criteria

Vishu Lingala highlighted proposed changes to the planning factors based on the last set of comments received. The presentation noted the addition of certain planning factors as well as the reallocation of weights for existing factors for Roadway and Transit projects under the Major Investments, Expand, Manage, and Maintain Categories.

Air Quality Emission Benefits Calculation Template

Vishu Lingala presented three templates that would generate values to be used in the Air Quality Emissions Benefits calculations. The templates are (1) Crash reduction benefits, (2) Congestion Reduction benefits (Travel-Time\Delay benefits), and (3) Air Quality benefits. The values calculated through these templates will be used within the Benefits\Cost Analyses.
