- 1) Call to Order
  - Chairman Morad Kabiri calls the meeting to order at 1:32 p.m. and conducts roll call to ensure a quorum.

- 3) 2045 RTP Update (Mike Burns)
  - a. PH2 Outreach Summary
    - Mike B provided a brief summary of the attendance and outcomes for phase 2 of the inperson and virtual public outreach. Survey and polling results were provided with a summary of comments received on the strategies for safety, reliability, resiliency, equity, analytics, and livability.
    - Peter E asked for a clarification of the safety comment suggesting a limit on vehicles.
    - Mike B responded that the comment suggested that less vehicle use would reduce vehicle fatalities.
    - There was no action on this item.
  - b. Draft Vision Statement, Goals, Strategies, and Investment Categories
    - Mike B provided a summary of edits to the draft Vision Statement, Goals, and showed table demonstrating alignment between the draft investment strategies and the draft investment categories.
    - Taylor M asked if there was a definition for the high growth areas.
    - Mike B responded that high growth areas do not have a specific metric at this point and those areas are to be described in an application by the sponsor with the description taken into consideration by H-GAC staff.
  - c. PH3 Outreach Timeline
    - Mike B described the timeline for the RTP document review, public outreach, and Air Quality Conformity review. It was noted that the outreach for the RTP and Air Quality Conformity are intended to be done at the same time and approved by the TPC on April 28, 2023.

  - Mike B asked if rescheduling the next RTP meeting to January 18 would be acceptable.



• Preference for affordable living near work, shopping, and services







Investment Category	Description
Regional Goods Movement	Roadway projects that are located on highways classified as UCFC or RCFC or intermodal connectors; Projects proposed on roadways that provide connectivity to large warehouses, big box stores etc.; Projects located on facilities with high truck volumes
Operational Improvements & Congestion Management	Projects not adding roadway capacity that reduce congestion and reduce travel delay (Including HOV expansions and BRT projects)
High-Growth Area Needs	Development of facilities that will avoid future congestion in high growth areas; Projects that address safety, congestion, or multimodalism in high growth areas; Projects that promote coordinated planning in high growth areas and support continued economic development
Active Transportation	On and off-road bicycle & pedestrian projects that facilitate essential trip making including universal accessibility projects for transit
Transit	All transit projects (may include HOV expansions and BRT)
Major Projects	All projects with an estimated cost of $\frac{50}{50}$ \$100 million or more *,**
Resiliency & State of Good Repair	Projects focused on resiliency improvements and extending useful life of the facility (Details TBD pending full PROTECT guidance)
Safety **	Projects focused solely on safety improvements in high crash areas (details TBD pending recommendations of Safety Task Force)
