5B. APPROVAL OF 2024 TAC NOMINATING COMMITTEE RECOMMENDATIONS (VACANCIES)

BACKGROUND

The Bylaws for the Transportation Advisory Council (TAC) require the Chair to appoint a Nominating Committee prior to the first meeting of each calendar year for the purpose of bringing before the Committee a slate of officers and subcommittee members for consideration.
