### Purpose

The purpose of this workgroup is to update the regional bike network in GIS for both technical and public users that will eventually feed into mapping apps and form the foundation of the bicycle transportation network for a model that will allow accurate active transportation travel demand forecasting. It will also form the baseline for the Regional Active Transportation Plan update and capture upcoming active transportation projects/recommendations from studies.



### Goals

- Develop a standardized GIS attribute table and nomenclature
  - Will be developed in three implementation phases immediate, mid-term, and I term
  - Necessary for automation
- Develop a standardized qualitative/comfort level/functional use criteria to be attributed to infrastructure (e.g. bike paths, bike lanes, etc.)
  - Necessary for automation
- Develop a standardized schedule for regular updates to keep the data fr and current.
- Perform the same tasks for the sidewalk network

### Purpose

The purpose of this workgroup is to develop a new travel demand forecast model (or modify an existing model) that will allow for the accurate projections of active transportation travel. Since the regional model focused on the entirety of the region (e.g. macro scale) and considering bike infrastructure travel tends to be on a smaller sub-regional scale (within a community or between adjacent communities), the goal is to find a micro model that complements H-GAC's macro model.



### Goals

- Perform research as to what is done in other areas (e.g. best practices)
- Compile data that will eventually feed into the model
- Bike network update in GIS (see previous workgroup)
- Upcoming household surveys, O/D surveys, and similar travel demand modeling surveys
- Develop list of surveys needed with an active transportation focus

### Purpose

The purpose of this workgroup is to develop a standard methodology for evaluating and prioritizing active transportation projects. This workgroup has been placed on hold until after the upcoming TIP Call for Projects has been completed





The workgroup had completed the following:

- Revised Planning Factors (qualitative criteria) that were submitted to the TIP Subcommittee as recommendations to change the TIP Call for Projects selection criteria.
- Revised Benefits Cost Analysis (BCA) to better reflect quantitative criteria for active transportation projects. The recommendations were submitted to the TIP Subcommittee for consideration for the TIP Call for Projects selection criteria.
- Revised the Emissions Benefits template (feeds into the overall BCA) to make it reflect active transportation projects better and make it easier for applicants to complete on their own without heavy technical support. The revised template was submitted to the TIP Subcommittee for consideration for the TIP Call for Projects selection criteria.

- Revise and expand the Planning Factors to allow for a universal template for active transportation project prioritization/selection. The general categories (newly added, expanded, or altered) included but not limited to: Demand/Need, Connectivity, Safety, Equity, Barrier Elimination, and Innovation.
- Revise and expand the BCA to allow for a universal template covering active transportation projects. The general categories (newly added, expanded, or altered) included but not limited to: Demand/Need, Safety, Lives Being Saved, Health Savings, Emissions Reduction, Reduced Chauffeuring Burden, Delay Reduction, Mode share increase (including cost), and Vehicle Ownership Savings.

# **Ideas and Examples**

- Conduct an annual active transportation survey of local governments to gather information
  - Update Bike and Sidewalk GIS layers regarding infrastructure and quality/comfort
  - Create and refine performance measures for walkway and bikeway network connectivity.
  - Conduct pedestrian and bicycle safety audits at highfrequency crash locations and near schools
  - Develop outreach tools to notify residents of new and updated walkways and bikeways constructed in their communities as a way to encourage use and share safety tips
