# 6. APPROVAL TO FILL VACANCIES ON THE TRANSPORTATION ADVISORY COMMITTEE'S SUBCOMMITTEES

#### **Background**

The Transportation Advisory Committee (TAC) has six subcommittees: Transportation Systems Management and Operations, Pedestrian-Bicyclist Subcommittee, Regional Transportation Plan Subcommittee, Regional Transit Coordination Subcommittee, Transportation Air Quality Subcommittee and Transportation Improvement Program Subcommittee. The memberships of the 2021 TAC Subcommittees were approved at the TAC meeting in March 2021. Due to staffing changes in member agencies since the approval, the TAC Subcommittees have several vacant positions.

#### **Current Situation**
