- Transit agencies are required by Federal Transit Administration (FTA)
- Tier I (METRO and Island Transit)
- Tier 2 (all others)
- Staff coordinate with transit providers to analyze data and form draft recommendations for regional measures

#### **Category Definitions**

Fatality – confirmed death within 30 days of a reported event

Injuries – requiring medical attention for two or more individuals

Safety Events – collision, derailment, fire, hazardous material spill, or evacuation

MDBF – mean distance between failures (Revenue Vehicles)



#### Safety Assessment of Exclusive Busway Operations



70 buses (60 RE and 10 BRT)/hour/inbound > 40 recommended threshold



1,675 vehicle/hour/inbound; capacity ranges between 1,500 to 1,900 vehicle/hour/lane



Guideway expected to operate at LOS F with HOV in traffic stream



Stations located on the right instead of the center to minimize HOV traffic shifting lanes

#### Dedicated Transitway for BRT/Regional Express

- Maximizes safety throughout facility, with a focus on station locations
- Uses a smaller footprint
- Reduces risk of unsafe conditions
- Lower right-of-way requirements
- Lower construction costs




# Locally Preferred Alternative
