

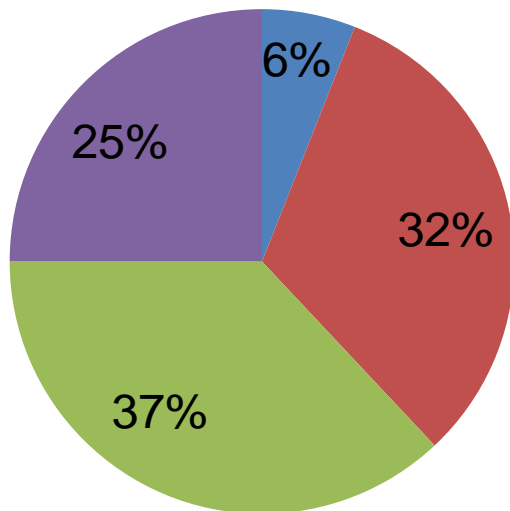

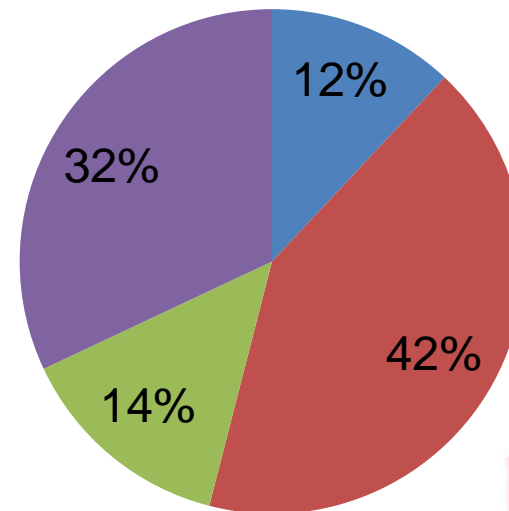
NOx Emissions in the HGB Eight-County Non-Attainment Region

2018 NOx Future Modeling Emissions



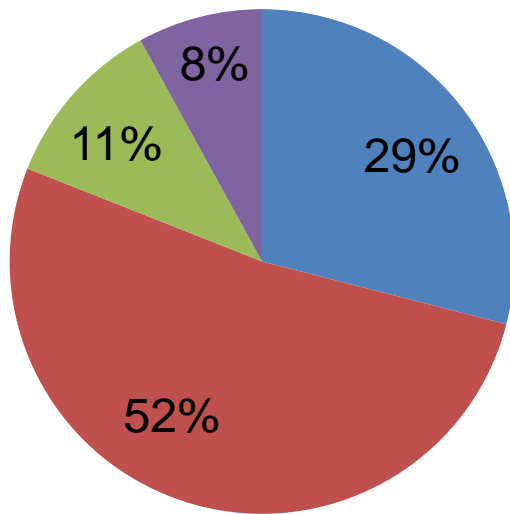
Total = 364 tons per day

2005 VOC Baseline Emissions

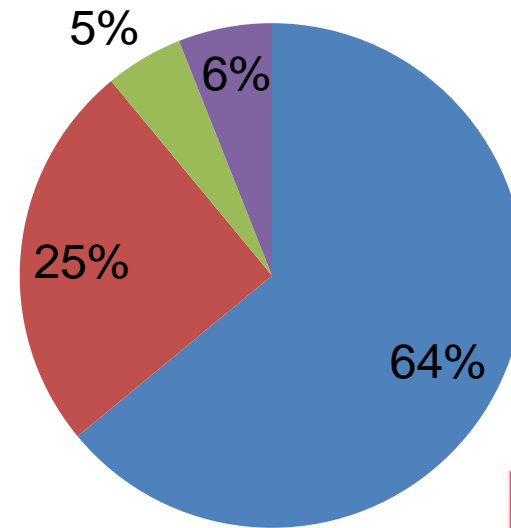
■ Point ■ Area

The Master List

Creation of Mobile Source Reduction Plan:

- Start with a wide range of strategy ideas
 - Public input
 - Additional measures used elsewhere
- Focus on NOx reduction strategies
- Qualitative evaluation of control strategies
- Create a cleaner list of most effective control strategies

Who are the Stakeholders?

Previous stakeholder meetings with:

- Local Governments: May 15, 2008
- Airports/Airlines: May 22 & October 1, 2008
- Construction Industry: June 3, 2008
- Rail Roads: June 12, 2008
- Ports/Marine Equipment 1: June 12, 2008
- Ports/Marine Equipment 2: June 19, 2008
- Small Local Governments: July 22, 2008
- Industrial Mobile Sources: August 13, 2008

Creation of the Short List Control Strategies

- Must meet EPA criteria for inclusion
- Short List criteria will focus on:
 - Highest emission reductions
 - Low implementation barriers
 - Highest cost effectiveness
 - Public acceptance
 - Local commitments

Local Commitments to Reduce Polluting Emissions

- EPA allows only 3% of total emission reductions to come from voluntary control strategies.
- Local governments and the private sector will need to commit to mobile related emission reductions in the State Implementation Plan.

GOAL: Achieve the NO_x and VOC emissions reductions needed in HGB in order to demonstrate compliance with the 1997 8-Hour Ozone Standard.

Local Control Strategies

- Voluntary Mobile Source Emission Reduction Program (VMEP)
 - Covers both on and off road mobile projects.
 - Identifies types of projects as opposed to specific projects.
 - Allows reduction credits for voluntary actions through incentives.
 - Mandates a bottom line reduction or commitment in the SIP.

Local Control Strategies

- **Transportation Control Measures (TCMs)**
 - Will reduce transportation-related emissions by reducing vehicle use, improving traffic flow and relieving congestion.
 - Currently collaborating with local governments and TxDOT to select local transportation projects as TCMs.

LIRAP Local Initiative Projects

- Funding from State LIRAP for participating counties.
- Fund local air quality emission reduction programs such as:
 - Implementing an enforcement program against fraudulent emission inspections
 - Intelligent transportation system (ITS) improvements to reduce traffic congestion
 - Replacing county fleets and buses with hybrids or other alternative-fueled transportation
 - Enhanced remote sensing of smoking vehicles.

Texas Emission Reduction Program (TERP)

- H-GAC has been approved to disperse TERP funds locally
- \$5 million in grants available to local governments within the 8-county non-attainment region
- Eligible vehicles
 - On-road heavy-duty vehicles
 - Non-road heavy-duty equipment
 - Marine vessels
