

**2008-2011 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)  
ADMINISTRATIVE AMENDMENTS SUMMARY – SEPTEMBER 2009**

**Background**

As per Transportation Policy Council (TPC) action, the Metropolitan Planning Organization (MPO) Director is authorized to approve the following revisions to the TIP administratively, with the concurrence of TxDOT:

- Project cost overruns not exceeding 25% of total project cost or less than \$500,000. Should cost overruns require delay of one or more projects to a latter implementation year, TPC review and approval will be required.
- Changes to project funding category.
- Changes in project priority within the four funding years of the TIP. Changes in priority to non-State sponsored projects must also have the concurrence of the project sponsor.
- Clarification of project scope. Minor changes to project limits, description or scope, which do not materially change the project's function, cost or environmental impacts, may be approved by the MPO Director.

On July 27, 2001 the TPC also approved a motion to permit the administrative approval of actions in one TIP that were already part of a previous action in another TIP. This action essentially allows for “clean-up” of the new TIP.

**Administrative Amendment Summary**

**Amendment #157: FM 359 widening in Fort Bend County**

Add SAFETEA-LU 2008 reallocation earmark funds to the MPO ARRA project.

**Amendment #158: Woodlands Pkwy widening in Montgomery County**

Reduce the limits to conform to the environmental document, delay the letting to FY 2011 and add local funding. The Woodlands Road Utility District #1 The Woodlands has already widened the segment from Grogans Mill Road to IH 45 from 4 to 6 lanes and has let a project to widen it from Gosling to East Panther Trail to 6 lanes. Those actions leave the portion from East Panther Trail to Grogans Mill Road for TxDOT letting.

**Amendment #161: SH 6 Access Management Improvements**

Split the Access Management Improvements project into two sections and two phases. Delay the Phase 2 section to FY 2011. Correct the County Name to ‘Fort Bend’.

**Amendment #163: Airline Improvements District Bicycle/Pedestrian Improvements**

Split the Airline Improvements District Bicycle/Pedestrian Improvements project from the H-GAC Special District Bike and Pedestrian Implementations placeholder project.

**Amendment #165: Houston-Galveston Transportation Management Area**

Show Preventative Maintenance and Rehabilitation Statewide Program (Appendix J) projects funded with Economic Stimulus funds.

**Amendment #167: SH 35**

Replace federal Category 2 Metropolitan Area Corridor (TMA) funds with Proposition 14 Category 2 100% state funds. Delay the lettings to FY 2010.
