SBA 504 Loan Fixed Assets (i.e. land, buildings, large equipment)	The LDC partners with a financial institution and works with the business applicant to develop financing packages that meet SBA 504 Loan Program guidelines and credit criteria. Most loan structures have a 50% (Bank)/ 40% (LDC)/ 10% (applicant) split. Loan amounts up to \$5 million or more.	Texas Businesses
Business & Government Loan Fund Working Capital (i.e. rent, salaries, utilities, marketing, etc.) Fixed Assets	The Business & Government Loan Fund helps finance new or expanding small businesses in the 13-county Gulf Coast region when traditional funding isn't available or isn't enough. Loan amounts up to \$350,000.	13-county Businesses
RRR Loan Program Working Capital Fixed Assets	The LDC operates a revolving loan program on behalf of Fort Bend County. Businesses may receive microloans up to \$50,000; tandem loans in partnership with banks up to \$1 million; and equity loans up to \$1 million to help with the down payment on a larger bank loan. The LDC hopes to expand this program throughout the region and will keep the Board updated.	Fort Bend Businesses
Relief & Recovery Working Capital	This program helps businesses that were impacted by COVID-19 and need financial assistance to help them recover. Loan amounts up to \$50,000.	13-county Businesses
