Two Stage Voting

- Invoked or a threshold
- Preserves regional voices
- Considers population
- Provides avenue for collaboration and compromise
- Adjusted each 10-year Census
- Simple process
 - 1st vote is standard composition
 - 2nd vote is weighted by population
 - Actions must pass both stages to advance
 - If not, reconsideration and discussion take place
