1. Call to Order/Certify Quorum and Introductions

Mr. Clint McManus, H-GAC, briefed the subcommittee on voting procedures by Primary and Alternate members on action items that require approval by the subcommittee.

Chair Louis Jullien called the meeting to order and confirmed quorum was met. The 2019 members of the Pedestrian-Bicyclist Subcommittee introduced themselves for the record.

2. Public Comments

No public comments were presented.

3. Approval of Minutes for January 24, 2019 (Chair Louis Jullien)

Chair Jullien made a motion for the approval of the minutes of the January 24, 2019 Pedestrian-Bicyclist Subcommittee. A motion was made and seconded. Minutes were approved as presented by the subcommittee.

4. Election of Officers (Chair and Vice Chair)

Chair Jullien requested nominations for the position of Chair of the Pedestrian-Bicyclist Subcommittee. Yuhayna Mahmud, METRO was nominated as Chair. A motion was made and seconded. Yuhayna Mahmud was approved as Chair by the subcommittee.

Chair Jullien requested nominations for the position of Vice-Chair of the Pedestrian-Bicyclist Subcommittee. Monique Johnson, City of Sugar Land was nominated as Vice-Chair. A motion was made and seconded. Monique Johnson was approved as Vice-Chair by the subcommittee.

Chair Jullien vacated his position as Chair of the Pedestrian-Bicyclist Subcommittee and Clint McManus, H-GAC, acknowledged his service and thanked him. Mr. Jullien was applauded by the subcommittee.

Yuhayna Mahmud, METRO, assumed the position as Chair of the Pedestrian-Bicyclist Subcommittee.

5. Approval of the 2045 Active Transportation Plan

Mr. Clint McManus, H-GAC, presented the draft of the 2045 Active Transportation plan to the subcommittee for approval by the Pedestrian-Bicyclist Subcommittee. Upon approval, the 2045 Active Transportation Plan will be presented to the Technical Advisory Committee for approval.

Mr. McManus proceeded to give an overview of the plan contents and let the committee know that the 2045 Active Transportation Plan was included in the Regional Transportation Plan Public Comment period which ends in two days. As of the date of this meeting, the Active Transportation Plan had not received any comments that would require any major edits of the 2045 Active Transportation Plan and if comments were received within the next two days, comments would be documented, and the subcommittee would be notified. Mr. McManus explained to the subcommittee how the data in the plan was collected. He continued to describe the Existing conditions portion of the plan and briefed the subcommittee by defining the Pedestrian and Bicycle Focus areas and the 2045 Vision Plan. He concluded his presentation with the 2045 Active Transportation Plan recommendations.

A lengthy discussion period, comments, questions and some revisions were suggested by subcommittee members during and after the presentation. Mr. McManus agreed to incorporate those revisions.

A motion was made and seconded. The 2045 Active Transportation Plan was approved by the subcommittee. Chair Mahmud acknowledged Mr. McManus as well as past and present subcommittees on their work in completing the 2045 Active Transportation Plan.

In all cases, subcommittee members recommended including input from the region's rural counties, particularly those not represented on the subcommittee itself. H-GAC staff agreed to hold a special meeting of the subcommittee to create a plan of action for the priorities mentioned.

1. Call to Order/Certify Quorum and Introductions

Chair Yuhayna Mahmud called the meeting of the Pedestrian-Bicyclist Subcommittee to order and the members of the subcommittee introduced themselves for the record. Quorum was not met.

2. Public Comments

No public comments were presented.

3. Approval of Minutes for May 8, 2019 (Chair Yuhayna Mahmud)

Chair Mahmud made a motion for the approval of the minutes of the May 8, 2019 Pedestrian-Bicyclist Subcommittee. There was not a quorum present. Approval was deferred to the next meeting.

DISCUSSION

4. Subcommittee Workgroup Creation (Clint McManus, H-GAC)

Chair Mahmud mentioned that a Policy Workgroup was created and will be informing the TIP process and Transportation Policy Council's (TPC) Project Development and Prioritization Workgroup on Bicycle-Pedestrian projects. This group met on July 16th. Chair Mahmud asked that Clint McManus give the subcommittee an update on the group.

Mr. McManus told the subcommittee there were four questions that the workgroup discussed included the following:

- a. Does the Transportation Improvement Program (TIP) reflect the priorities established in the Regional Transportation Plan (RTP) and the Active Transportation Plan?
- b. Do the existing criteria distribute funds fairly across urban, suburban and rural parts of region, as well as, environmental justice areas?
- c. Do the existing TIP criteria distribute funds appropriately to different project types?
- d. What policy recommendations can we make to improve the project pipeline?

Mr. McManus informed the subcommittee that meeting notes would go out to members when complete.

5. Overview of Current H-GAC Active Transportation Initiatives and Timeline

Mr. Clint McManus gave an update on Active Transportation initiatives and timeline. At the last meeting in May, the Active Transportation Plan was approved. The plan establishes the existing conditions of our walkways and bikeways in the region. It also analyzes the need for community and establishes a vision for what our community can look like in 2045 and also what investments will be needed in the future. To view the Active Transportation Plan Mr. McManus continued with an overview of special districts studies and how they are incorporated into the Active Transportation Plan. There are several studies beginning soon. Special District studies will be renamed Active Transportation studies. Mr. McManus also gave a recap on Livable Centers and Sidewalk Layer update. Mr. McManus informed the subcommittee about the Bicycle Safety Training that will happen in near future. Mr. McManus answered questions from the subcommittee throughout the presentation.

6. Sidewalk Layer Update (Kat Vo, H-GAC)

Ms. Kat Vo provided an update on the Sidewalk Layer. It identifies major intersections in

need of pedestrian infrastructure improvements in the 8-county transportation management area. Ms. Vo provided a description on what data the project will gather to identify specific needs to understand pedestrian connectivity gaps and existing infrastructure. A question and answer period followed the presentation.

7. Pedestrian Bicycle Safety Implementation Plan (Stephen Gage, H-GAC)

Ms. Stephen Gage, H-GAC, gave the subcommittee an overview on the Transportation Safety Committee and the Regional Safety Plan. This committee has identified five areas of concern; Bike-Ped safety, distracted driving, impaired driving, speeding and intersections. The goal of the Transportation Safety Committee is to collaborate with the Pedestrian-Bicycle subcommittee and discuss opportunities. A joint meeting of these two committees is also a possibility in the future. Mr. Gage continued with an update of the Regional Safety Plan and described it goals and focus areas. Mr. Gage presented a resolution on the collaboration of the Pedestrian-Bicyclist Subcommittee and the Transportation Safety Committee. There was no quorum present. Item deferred.

1. Call to Order/Certify Quorum and Introductions

Chair, Yuhayna Mahmud, called the meeting to order. The 2019 members of the Pedestrian-Bicyclist Subcommittee introduced themselves for the record.

2. Public Comments

No public comments were presented.

ACTIONS

3. Approval of Minutes for May 08, 2019 (Yuhayna Mahmud, Chair)

Chair, Yuhayna Mahmud, made a motion for the approval of the minutes for the May 08, 2019 Pedestrian-Bicyclist Subcommittee. At the time, we had not met quorum and the minutes were not approved.

After quorum was met, Mr. Clint McManus, noted the joint committee resolution name had been corrected to "Pedestrian Bicyclist" to meet the Subcommittee approval. The motion was passed, and the resolution was approved.

4. Safety Implementation Plan Collaboration with Transportation Safety Committee (Clint McManus, H-GAC)

Mr. McManus proceeded to give an overview to the Pedestrian-Bicyclist Subcommittee of the plans that the Transportation Safety Committee, which is the Subcommittee of the TPC, they have made it a priority to conduct safety implementation plans for the focus areas, one of them being bicycle pedestrian. They have asked to establish a formal collaboration, so we can work together.

Mr. McManus announced that Stepan Gage will give more details of the implementation plans. Stephan Gage, H-GAC, gave an update on the Safety Implementation plans collaboration with the Bicyclist Pedestrian Subcommittee. He noted, last year, TPC adopted the Regional Safety Plan, which includes Bike Pedestrian and Bicycle Safety. This opportunity will allow both committees to develop solutions, consensus of what the needs are, and strategies to determine what we want to implement as a region to address Bike Ped Safety issues. They would like to acknowledge the idea with a formal resolution that our two committees will formally collaborate in this project. Basically, to present results to TAC and TPC.

DISCUSSION

5. Pedestrian Bicycle Policy Workgroup Recommendations (Clint McManus, H-GAC)

Mr. McManus presented the draft recommendations for the Transportation Improvement Program developed for the Project Prioritization and Development workgroup. A lengthy discussion period, comments, questions and some revisions were suggested by subcommittee members. A recommendation was made that the language be made stronger. In addition, make language clearer in the justification section and remove the words set/aside and replace it with just "and". The Subcommittee members would like to see more emphasis on safety. Mr. McManus made note of the recommendations from the Subcommittee members.
