## LONG RANGE PLANNING

## 1. Sub-regional Planning Initiatives (SPI)

- Southeast Harris County Subregional Study has been completed. The study will be presented to TAC/TPC in July. For more information visit: <a href="https://www.engage.h-gac.com">www.engage.h-gac.com</a>
- The fifth Steering Committee meeting for the Liberty County Mobility Study occurred on Thursday, June 21, 2022 to review final recommendations and draft final deliverables. The consultant is currently preparing the draft final report for H-GAC staff to review.
- The final recommendations for Montgomery County Precinct 2 Mobility Plan will be presented at the second public meeting. It will be held on August 4, 2022, at the Magnolia Event Center, Magnolia, Texas.
- Staff developed Advanced Funding Agreements (AFA) for regional planning studies included in the 2021-2022 Unified Planning Work Program (UPWP). The AFA's have been submitted to TxDOT for approval.
- Staff developed draft project scopes of work for the regional planning studies included in the 2021-2022 Unified Planning Work Program (UPWP) and are coordinating with local partners.

# 2. Freight Planning

- The next Greater Houston Freight Committee meeting is scheduled for September 1, 2022.

## 3. Regional Incident Management, Safety, and Operations

- Reviewed the Intersection Safety Assessment (ISA) draft report for intersections in the City of Galveston.
- Reviewed the ISA draft report for intersections in Montgomery County.
- Reviewed the ISA draft report for intersections in Brazoria County.
- Kimberly Horn made a presentation to Waller County Commissioners Court on ISA conducted in Waller County.
- A TPC Transportation Safety Committee Meeting was held on June 28, 2022.
- A Tow and Go Operations Meeting with the City of Houston Police Department (HPD), the Harris County Sheriff Office (HCSO), AECOM, TxDOT, and the Tow and Go towing contractors was held on July 5, 2022.
- A Traffic Incident Management Meeting at Houston TranStar with TxDOT, Houston TranStar Staff, HCSO, HPD, AECOM and Tow and Go Contractors was held on July 14, 2022.

## 4. Environmental Planning

- Staff is developing a process and worksheet to assess and document the environmental justice issues associated with proposed transportation projects and planning decisions.
- Staff is updating the Eco-Logical tool to include links to existing environmental assessment and final environmental impact statements for roadway projects within the planning area. Staff will

- coordinate with TxDOT and consultants working on local Planning and Environmental Linkages studies to examine the application of Ecological tool on those studies.
- Staff is continuing work on an update to the regional Environmental Justice report.

## 5. Resiliency Planning

- Staff continues the development of a Low Impact Development tool to examine how to costeffectively integrate low impact development into transportation projects in the Metropolitan Planning Area.
- Staff completed work on the Resilience & Durability Pilot project as part of the FHWA program to develop transportation-specific resiliency best practices and strategies. The draft report has been finalized and accepted by FHWA. Staff has completed an update of the Foresight Panel on Environmental Effects report with outcomes from the Pilot project.

## 6. Regional Transportation Plan (RTP)

- Staff worked on the scope of work, outreach activities, and schedule for the development of the update of the 2045 Regional Transportation Plan.
- The RTP Subcommittee Meeting was conducted on July 13, 2022.
- The RTP Visioning Outreach occurred in May with meetings in all 8 Counties (Harris, Liberty, Chambers, Galveston, Brazoria, Fort Bend, Waller and Montgomery County). The RTP Visioning survey is open until the end of July. For more information on the public meetings visit: www.engage.h-gac.com

### 7. Other Planning Activities

- Staff continued to monitor regional travel impacts of COVID-19. Regional travel volumes were
  monitored through StreetLight data. Transit ridership numbers are now being reported on a
  quarterly basis from transit agencies within the region. Permanent pedestrian/bicyclist counters
  provide updates on counts along regional pedestrian/bicyclist facilities. Staff have developed
  an online COVID-19 Regional Traffic Impacts App which displays vehicular, active, and transit
  transportation patterns during the Pandemic.
- Staff has secured additional members for the Congestion Management Process Update Workgroup and is refining the scope of work for the update and responsibilities for the workgroup.

# SHORT RANGE PLANNING

#### 1. Project Programming

- Staff coordinated on the amendments to the 2021-2024 TIP document. Staff coordinated with TxDOT and local governments on the proposed amendments to the 2045 Regional Transportation Plan.
- Staff worked on the development of project selection criteria for the next Call for Projects and coordinated with various subcommittees.

Staff finalized the Annual Project Listing of Obligated Projects that provides project-level details on
the use of federal funds for highways, pedestrian and bicycle and public transportation projects.
H-GAC staff developed the annual report in cooperation with TxDOT and local public
transportation providers and is available on the H-GAC website.

# 2. Pedestrian and Bicyclist Planning

- Staff continues to maintain and monitor permanent pedestrian and bicycle counting equipment
  and data and has launched a new GIS based way to report the data for permanent counters and
  is now focused on doing the same for mobile counters.
- Staff continues to manage the Adult Bicycle Safety program and think of ways to build awareness and interest in Brazoria, Chambers, Fort Bend, Galveston, Liberty, Montgomery, and Waller counties. The AFA was recently extended through May 2023 and staff are working on extending the vendor contract through May 2023.
- Staff continues participation in meetings with the Houston Bicycle Advisory Committee.
- Staff are continuing work to revise the scope, budget, and timeline in anticipation of procuring a consultant to revise the 2045 Active Transportation Plan.
- Staff continue to advance Ped/Bike Subcommittee workgroups. One workgroup will revise the
  regional bike network GIS data and the other workgroup will develop an active transportation
  focused travel demand modeling solution. The bike network GIS data update workgroup will be
  making formal recommendations to the Ped/Bike Subcommittee in July 2022 regarding
  immediate short-term implementation.
- Staff hosted the League of American Bicyclists to present on their Bicycle Friendly America program during a special Ped/Bike Subcommittee meeting on July 15.
- Staff continued to hold monthly meetings with local sponsors for the Local Active Transportation Studies to refine scopes of work and project budgets.
- Staff is working to submit paperwork for the Advanced Funding Agreements for the Local Active Transportation Studies, and is also preparing consultant scopes of work and Interlocal Agreements for each of these studies.

# 3. Transit Planning

- The regular quarterly meeting of the Regional Transit Coordination Subcommittee was held on July 14, 2022. A new Chair and Vice Chair were elected.
- Staff continues to refine the scope of work for High-Capacity Transit feasibility studies and prepare
  paperwork for Advanced Funding Agreements for the bulk of these studies. The first study is
  funded through the Unified Planning Work Program and will focus on the US 90A corridor,
  conducted in partnership with the Gulf Coast Rail District (GCRD).
- A Technical Memorandum for the City of Pearland Transit Study with existing conditions and peer
  analysis is being refined internally. Due to additional revisions the Steering Committee and Public
  Meetings have been pushed back but are still anticipated to take place this summer.
- Staff continues to refine the City of Dayton transit study Request for Proposals.

- The Woodlands Energy Corridor commuter service is underway. Staff is coordinating with The Woodlands Township on invoicing, ridership and, through the Commute Solutions program, marketing.
- The action plan for the Regionally Coordinated Transportation Plan is complete, and work has begun on the scope for a transit information study recommendation coming out of the most recent plan update.
- Coordination continues between H-GAC, METRO and other regional transit agencies regarding
  the Regional Transit Connectivity Project, including the Seamless Fare System, regional trip
  planner, data management system, and related efforts. Initial assessments to determine agencies'
  needs and capacity are underway and are scheduled to be completed this summer. A meeting
  was held on July 12 with regional stakeholders participating as part of the Regional Transit
  Connectivity Workgroup of the Regional Transit Coordination Subcommittee.
- A new Paratransit/NEMT workgroup of the Regional Transit Coordination Subcommittee also held their first meeting in July. This workgroup will focus on closing the gaps with paratransit and nonemergency medical transportation services in the region and includes service providers and users of the services.

#### TRANSPORTATION PUBLIC OUTREACH

- Staff completed 8 public meetings in each of the eight counties within the MPO for the RTP 2045
  Update. Planning for a second phase of public outreach is in progress and slated to occur in

- Planning and implementation efforts are underway for the Montgomery County Pct. 2 Study public meeting. It will occur at 6 p.m. on August 4 at the Magnolia Event Center.
- The launch of media buys and advertising with local vendors for Hurricane Preparedness started June 1 and will continue through October of this year.

# **COMMUTE SOLUTIONS**

- Staff sponsored the NASA Johnson Space Center Commuter Series. This included two webinars held for NASA employees Commute Options Talk and Fuel-Efficient Driving Tips.
- Staff presented the Future of Work Survey to TAC and TPC.
- Staff also closed out Commuter Surveys with one company and one university.
- Staff continues development of an online survey for a company in Waller County. The survey will be held in three languages English, Spanish, and Vietnamese.
- Staff continued to make progress on telework policy development and implementation with employer partners. One partner launched their telework program evaluation to follow.
- Staff continues coordination with TXDOT's ConnectSmart project to develop TDM components of the application and discuss marketing and outreach. The project is scheduled for full launch in September 2022.
- Staff received an extension of their current Advanced Funding Agreement with TXDOT and is working on the scope for an emergency ride home request for information and a procurement for a bike engagement consultant.

### CLEAN VEHICLES PROGRAMS PLANNING ACTIVITIES

- During last month, staff continued to work with several ISD's in the Houston-Galveston region to replace older school buses. An application was received from Rice University for a new electric bus. Staff continued to coordinate with Cy Fair ISD for grant funding of electric buses.
   Additionally, two SEP-funded contracts are in the works Danbury and Lamar Consolidated ISD's.
- Staff continued to examine and develop the parameters needed to establish an electric charging infrastructure component to the Clean Vehicles Program. Staff worked on creating a new RFA and application specifically for electric vehicle chargers.
- Staff continued to monitor grant recipients' usage of vehicles to assure grant requirements for vehicle use and mileage are met.
- Staff participated in a variety of internal and external meetings and met with other local government agencies to discuss projects utilizing Congestion Management and Air Quality (CMAQ) funds. Staff met with TxDOT and discussed electric vehicles and charging stations as projects for CMAQ funding.
- Staff is meeting with electric charger manufacturers to verify Buy America compliance and program interest.

# GENERAL AIR QUALITY PLANNING ACTIVITIES

- H-GAC staff is working with EPA to develop a webinar focused on the new EPA Clean School Bus Program to occur on August 2<sup>nd</sup> at 10:00am. This webinar will include presentations from EPA with details about the funding opportunity, H-GAC staff to discuss the Clean Cities Program, Evolve Houston to discuss ongoing regional efforts to help advance school bus electrification, and Highland Electric to show one example of how to school districts can receive technical assistance to facilitate the electrification process.
- Air quality staff has been working with an intern, Fizza Hassan, through the Environmental Defense Fund. Fizza has been working with Air Quality and Project Delivery staff to help explore and develop strategies to help create a decision support framework to help Integrate environmental justice and health impacts into the TIP at a future date.
- Staff hosted a meeting of the Regional Air Quality Planning and Advisory Committee (RAQPAC) on June 30<sup>th</sup>. This meeting featured a presentation from Ken Adler of Environmental Defense Fund and Cyrus Cormier for Unlimited CUER Consulting to discuss an ongoing zero-emission drayage initiative currently underway within our region. Additionally, Lisa Lin, the Director of Sustainability for Harris County, joined RAQPAC to discuss her ongoing efforts at Harris County.
- Staff continued to work with air quality team from the North Central Texas Council of Governments to meet with stakeholders to develop Zero Emission Vehicle (ZEV) corridor plan for Interstate 45 between and within the two MPO's service areas. The final plan is currently being developed and it is anticipated that this report will be completed by the end of August.
- H-GAC continued to work on regional efforts to support the Department of Energy sponsored Houston-Galveston Clean Cities Coalition. Under this program, staff worked with regional fleets to foster economic, environmental, and energy security by working to advance affordable, domestic transportation fuels, energy efficient mobility systems, and other fuel-saving technologies

- and practices. The most recent month has focused on planning for future events to include: the school bus electrification event described above as well as potential follow-on electrification events, an upcoming stakeholder meeting, and assisting with an anticipated autumn event focusing on the transition to zero-emission vehicles.
- Staff is continuing to administer two separate Environmental Protection Agency-funded Diesel Emissions Reduction Act (DERA) grants from the 2018 and 2019 Calls for Projects to deploy allelectric yard tractors at local freight warehouses. Staff has been working with IKEA to replace two existing diesel yard tractors at their Baytown facility with all-electric models. IKEA is currently installing EV charging equipment to facilitate the vehicle purchases and it is anticipated that the entire project will be completed by the end of 2022. For the 2019 DERA project, staff is preparing a call for projects to find a new partner to complete the project.

### TRAVEL DEMAND MODELING & FORECASTING

- Staff continued to provide travel demand modeling support to support various sub-regional and
  corridor studies such as the City of Houston Thoroughfare Plan Amendment within the region to
  support H-GAC's planning processes (on-going) and assisting Transportation with presenting the
  draft staff recommendation targets for the Federal Performance Measures for Reliability,
  Congestion, and Air Quality.
- Staff presented Conformity Determination results to both the Transportation Advisory Committee (TAC) and the Transportation Policy Council (TPC) for recommendations and approvals. Updated various articles of the conformity documentations and coordinated with conformity partners.
- Staff continued to provide GIS technical support for the RTP, TIP, and in creating the New-Regional Bikeway Networks updates, and a web app for Active Transportation Viewers.
- Staff continued to enhance the capabilities of the website and dashboard to assist H-GAC's member agencies to view their various corridor and sub-area transportation planning and studies, and work with TxDOT to utilize Streetlight data, and serve in the steering committee in the TXDOT TP&P Household Survey planning and data design.
- Staff continued to run and enhance and fine-tune the H-GAC's Activity-Based Model (ABM). Staff continued to work with a Steering Committee and the Prime Contractor (ETC Consulting) for the Transit On-board Origin-Destination (O-D) Survey. The data collection for O-D Survey is complete and is currently in expansion phase. The Tour Cast part of the data collection is scheduled for the fall of 2022. Staff continues to work on procurement for the Airport Ground Access Survey; RFP is released, and the Pre-proposal conference is completed.
- Staff continued to process INRIX speed data in relation to the H-GAC traffic count project.
   Procurement process for the traffic data collection is completed, and Data collection is scheduled to commence in September 2022.
- Staff continues with the procurement process of acquiring a Contractor through a Sole Source to enhance the capabilities of H-GAC's current modeling framework call the Spatial Emission Estimator (SEE) used for estimating regional on-road emission inventories of criteria, toxic and GHG emission for each hour of a day with highly detailed spatial resolution.
- Staff continued to run the H-GAC VisionEval scenarios model to support transportation planning activities.
