DISCUSSION

A. 2045 RTP Amendment Update - Stephen Keen, H-GAC

Stephen reported on the progress of the 2045 RTP update, highlighting that staff has reached out to project sponsors for updated information on over a thousand projects. The amendment process aims to remove outdated projects and add new ones that align with regional interests. The finalized project list will be presented on March 19th, with ongoing updates until then.

B. Transportation Conformity Update - Maggie Isied, H-GAC

Maggie Isied provided insights into the transportation conformity process, highlighting its significance for air quality in non-attainment regions and the ongoing support for the Transportation Improvement Program (TIP). She also discussed regional partnerships, including those with Metro and TxDOT Houston, and addressed concerns raised by Bruce Race regarding the involvement of ports in air quality discussions. Dexter Handy prompted a conversation about the steps necessary to achieve attainment status, focusing on the state implementation process.

C. ZEV Plan Update - Vinny Polignano, H-GAC

Vinny Polignano updated attendees on the zero emissions vehicle infrastructure study, noting the shift in terminology to better reflect the project's scope and the increasing number of zero emission vehicles in the area. Bruce Race emphasized the need for equitable access to electric vehicle charging, particularly for low-income communities, while Amy Skicki announced upcoming events to engage the community. Vinny Polignano presented the latest updates on the zero emissions vehicle infrastructure study, noting a change in terminology from "plan" to "study." He reported that the Houston-Galveston area has approximately 90,000 plug-in hybrid and battery electric vehicles, representing a significant portion of Texas's total. Additionally, he mentioned the upcoming release of fact sheets to educate the public and policymakers about electric vehicles and charging infrastructure. Vinny Polignano shared insights on a study indicating that increased EV adoption in California led to measurable air quality improvements. He also mentioned the importance of user-friendly tools for analyzing EV data in Harris County.

D. Free Friday Promoting Healthy Air Quality Habits Through Mode Shift - Robyn Egbert, H-GAC

Robyn Egbert discussed the Free Fare Friday campaign, which encouraged commuters to shift to public transit by providing free rides. The campaign involved collaboration with several transit agencies and utilized data analytics to project ridership. Marketing efforts reached over 100,000 residents, and initial results showed a positive trend in ridership following the campaign.
