AMES

With its home in Liberty County, the city of Ames is located at the junction of FM 160 and U.S. Hwy. 90 with a population of 937.* With the median age of residents standing at 36, 28.6 percent of the population is 18 and younger. Ames is served by the Liberty County Independent School District.

MONTGOMERY

The city of Montgomery is located in Montgomery County and serves as the county seat. It is known as the birthplace of the Lone Star Flag. In 2020, the city had a population of 1,948* with a median age of 38.6. The majority of the population (27.5 percent) are aged 45 to 64, with the under-18 age range a close second at 26.7 percent. Montgomery is served by the Montgomery Independent School District.

PLEAK

Pleak is located in Fort Bend County on Hwy. 36, just 4.5 miles south of Rosenburg, with a population of 1,213* approximately equally distributed across all age ranges. The median age is 38 years. The Village of Pleak is part of the Lamar Consolidated Independent School District with a small portion in the Needville Independent School District.

ROMAN FOREST

Also located in Montgomery County, the city of Roman Forest has a population of 1,781* with a median age of 43.6. The largest portion of the residents are aged between 45 to 64 (32.5 percent) and the 18 and under population accounts for 23.3 percent. The New Caney Independent School District serves Roman Forest.

ANNIVERSARIES & RECOGNITION

1 YEAR LATER: Centralized Intelligence For Intelligent Decision-Making

April 2023 marked the first anniversary of the Data Analytics and Research Department. Born from organizational restructuring, the department has become a central information hub for all departments within the organization as well as local governments, planning agencies, research institutions, and the public seeking data-driven insights about the 13-county region.

The department has been instrumental in critical planning activities, providing invaluable data for economic forecasting, growth projections, identifying public service needs, transportation, housing, environmental planning, and air quality research. Its impact extends to strategic community outreach as well.

Accessible to all, many of the department's research projects and reports are available online and presented through interactive mapping applications and digital storyboards. In just one year, the Data Analytics and Research Department has evolved into an indispensable resource, contributing significantly to informed decision-making and planning across the region.

Reimagining Rail in the Region

Workforce Receives Convener Grant

The Gulf Coast Workforce Board received a Tri-Agency Convener grant from the Texas Education Agency to enhance collaboration among the workforce system, public education, higher education, community organizations, and employers. This grant supports the development of a comprehensive strategy for high-quality career and education pathways in targeted industries across the region, aligning with the Tri-Agency Workforce Initiative's goal of strengthening connections between education and industry for Texas's economic growth. Successful completion of the grant requirements will qualify the Gulf Coast Workforce Board for inclusion in the Texas Regional Planning Network.

Tow and Go Marks Five Years



Celebrating its fifth anniversary in May of 2023, the Tow and Go program has performed more than 160,000 tows, with an average response time of 16 minutes, helping drivers in the cities of Houston, Baytown, Bellaire, Deer Park, Humble, Jersey Village, La Porte, Pasadena, Webster, and Unincorporated Harris County.

H-GAC's Livable Centers **Receives Planning Award**

H-GAC and Livable Centers study sponsors, Harris County Precinct 2 and Consor Engineers, earned recognition as part of the 2023 American Planning Association Houston Planning Awards Program. Completed in 2023, the Cloverleaf Livable Centers Study was selected to receive a Silver Award in the Advancing Diversity and Social Change category. The study included an inclusive public engagement process resulting in community-driven placemaking recommendations.

Established in 2008, H-GAC's Livable Centers Program works with local communities to reimagine auto-focused infrastructure, policies, and programs to be more multi-modal friendly. Since the programs's inception, H-GAC has completed 43 Livable Center studies.

On January 13, 2023, H-GAC hosted its first board retreat. For one full day, the newly minted 2023 board of directors discussed and set H-GAC's "5 BIG" priority areas for the next three to five years. They include:

HEALTHCARE

Addressing capacity and access to healthcare, including mental healthcare and telemedicine, with particular emphasis on the rural areas of the region as well as the homeless population.



WATER RESOURCES

Improving water quality, addressing flooding, and improving water and wastewater capacity as the region's population continues to grow.

Ensuring access to starter homes, affordable housing, and the missing middle housing.



BROADBAND ACCESS

Providing equitable opportunity to combat challenges associated with lack of internet access, including learning loss and access to telemedicine. 5

The Area Agency on Aging provides high-quality services to older adults aged 60 and over. Through a community-based delivery system, AAA is focused on meeting the needs of seniors at the local level by engaging local community partners, organizations, and a network of volunteers to ensure older persons maintain their dignity and remain independent in their homes and communities.

Priority is given to seniors who:

- Are members of low-income and underrepresented groups
- Have limited communication and/or speaking abilities
- Reside in rural areas
- Are disabled
- Live with dementia, including Alzheimer's Disease
- Are informal caregivers

A Caring Alliance

In the heart of Chambers County, a partnership has been transformative for the healthcare of the rural population. Chambers Health, determined to secure grant funding, faced the daunting challenge of competing with bigger entities in Harris County and Houston, where success often hinges on population size.

Through their collaboration with H-GAC, Chambers Health leveraged new grant funds to lead impactful projects, from the hospital and wellness center to expanding their clinics in Anahuac, Dayton, and Mont Belvieu.

The partnership and funding proved crucial when it came to disaster planning. The county allocated funds to ensure individual healthcare sites could weather any storm by linking them to one another, enabling Chambers County to deliver essential care during critical moments.

Beyond healthcare, Chambers Health has taken on the nutrition and transportation programs in Chambers County as a team effort with H-GAC's Area Agency on Aging. This program has become a symbol of community service, reflecting the county's commitment to residents' well-being. Grants have also supported programs encouraging senior socialization—a powerful antidote to various health issues, including dementia.

Chambers County's story is one of resilience, collaboration, and a community thriving thanks to generous grant funds.

A Partnership Focused on Healing

UTMB-Galveston partners with the H-GAC's Area Agency on Aging to improve seniors' health.

Charlene, a woman in her 70s, faced mobility challenges due to a car accident in her teens that had a lasting impact on her ability to walk and perform everyday tasks. Her doctor referred her to Stay Active and Independent for Life (S.A.I.L.), an evidence-based strength, balance, and fitness program for older adults. Charlene had noticed her increasing difficulty getting up from a chair, leaving her feeling vulnerable and afraid of falling.

Charlene's doctor, who is part of UTMB's Network Physician Referral program, recognized the value of the program and referred her to it. UTMB had partnered with H-GAC's Area Agency on Aging to provide evidence-based classes for seniors to enhance their mobility and quality of life.

Charlene embraced the class led by Misty, a compassionate and knowledgeable instructor. She learned that strength, balance, and posture were key to functional fitness. With determination, Charlene attended each class and practiced exercises at home to enhance her leg strength, balance, and coordination. The supportive group environment and dedicated instructor motivated her to push herself further, resulting in a noticeable transformation.

The classes included fall prevention education and routines involving warm-up, aerobic activity, balance exercises, and stretching. Charlene appreciated the practical movements they learned, like taking high steps to get in and out of a tub, stepping over obstacles, and practicing carrying a tray and pivoting.

As Charlene's physical abilities improved, so did her confidence. She regained her independence, no longer needing assistance to stand or hesitating to engage in daily activities. Charlene's journey demonstrated that it's never too late to improve oneself, and sometimes, a seemingly simple class can make a profound difference.



FACTS ON FALLS

According to the Centers for Disease Control and Prevention, falls are the leading cause of injury-related death among adults aged 65 and older. In 2020, more than 1 million, or 30 percent, older residents in Texas reported falling.

Early this year, H-GAC's Area Agency on Aging and the University of Texas Medical Branch-Galveston's (UTMB-G) Osher Lifelong Learning Institute partnered to provide evidence-based fall prevention programming for adults aged 60 and older. Physicians refer patients to the Stay Active and Independent for Life (S.A.I.L.) fall prevention program led by a certified S.A.I.L. instructor from H-GAC's Area Agency on Aging.

37 Older adults have benefited through the AAA/UTMB-G partnership. Of those:

- 80% demonstrate overall improvement
- 20% remained the same
- No participants measured a further decline in fitness

H-GAC's Area Agency on Aging operates in 12 counties including Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Liberty, Matagorda, Walker, Waller, and Wharton counties. Harris County operates its own Area Agency on Aging.

Overcoming Barriers: Justice for Elder Abuse Victims

-GAC's Elder Justice Program began in mid-2018 to help families and communities address the rising tide of elder abuse. Three program attorneys provide seniors who have been victims of crime with crisis support, resource referrals, and help navigating the criminal and civil justice systems. Free legal representation is offered in civil matters to help stop the abuse and/or safeguard the victim's physical or financial health.



H-GAC Fights Against Elder Abuse

Sharon and her husband had worked diligently throughout their lives, but tragedy struck when they lost their adult children and their grandsons drifted away. Following her husband's passing in 2020, one of her estranged grandsons offered assistance with her finances. When Sharon fell seriously ill with COVID-19 and spent weeks in the hospital, her grandson placed her into assisted living without her consent, claiming it was temporary.

Sharon's grandson initially appeared devoted but was actually emptying her savings, checking, and retirement accounts. His deception first came to light when a payment to her assisted living facility bounced.

Seeking answers, Sharon enlisted a cousin to drive her to her house, only to discover the interior gutted and all of her belongings missing. Going next to her bank, Sharon learned that her checking and savings accounts were overdrawn, and her retirement investments were nearly depleted, squandered on frivolous purchases. Calls to her grandson went unanswered.

H-GAC's Elder Justice Program helped Sharon regain control of her accounts and safeguard \$300,000. Staff assisted her in selling her home and truck to regain financial stability while also helping her report unauthorized expenditures to reclaim some of her misappropriated savings from credit card issuers and retailers.

Throughout the tumultuous two-year journey, Sharon's physical and emotional well-being deteriorated, leading to profound isolation and a suicide attempt. Our team provided unwavering support during this challenging time. Initially hesitant to press criminal charges, Sharon changed her mind as the extent of the theft became clear. After a year of investigation by the Brazoria Sheriff's Department, the case is currently under review by prosecutors.

Sharon now strives to rebuild her life with the continued support of H-GAC's Elder Justice Program.

Emergency Response and Access to Care

The Arrival of NextGen 9-1-1 in the H-GAC Region

H-GAC, home to the Gulf Coast Regional 9-1-1 Emergency Communications District (District), made a giant leap this year as it prepares to rollout NextGen 9-1-1 services to its eight participating counties in 2024.

The District focuses on boosting public safety and optimizing efficiency by maintaining 9-1-1 answering point equipment, working with county and city partners as well as wireless carriers ensuring accurate caller location and telephone number data, and providing technical support for mapped automatic location data and 9-1-1 mapping in rural areas.

With a goal of NextGen readiness in 2023, the District standardized data to National Emergency Number Association Standards, offered ongoing GIS software training, conducted field tests for Wireless Network Performance, and acquired NextGen technology.

NextGen 9-1-1 revolutionizes emergency response by seamlessly integrating cutting-edge technology, real-time data, and precise location accuracy. Dispatchers gain comprehensive information for faster responses. Live video feeds and exact coordinates enhance emergency understanding, creating a swift and accurate connection between technology and response, saving lives, and providing reassurance during critical moments.

The eight participating counties in the program's region include Brazoria, Chambers, Colorado, Liberty, Matagorda, Walker, Waller, and Wharton counties.

In 2023, H-GAC financially supported the construction of the Tri-County Communications Tower to serve and connect Austin, Colorado, and Wharton counties ensuring a seamless connection between mutual aid systems in times of emergency. H-GAC's Public Safety program works with local governments to enhance community resilience, emergency preparedness, and law enforcement capacity through a variety of funding opportunities and technical services.

ACCESSING RURAL CARE

In 2023, H-GAC's Data Analytics and Research Department contributed to the agency's healthcare work by devising the Regional Health Accessibility Analysis. The project examined and visualized driving distances to evaluate people's access to rural hospitals and behavioral health centers throughout the 13-county region.

The resulting Healthcare Accessibility
Tool encompasses key demographics,
including the population in poverty,
non-Hispanic and non-white minorities,
Hispanic minorities, limited English
proficiency, disabled families, elderly,
carless households, and single mothers
with children. This tool is now widely
available online for healthcare
professionals to gain insights into
healthcare accessibility gaps and
potential avenues for enhancement.

WATER RESOURCES



The Community and Environmental Planning Department at H-GAC is focused on devising and implementing strategies to promote sustainable and resilient communities, such as urban and regional planning, public safety, environmental protection, community development, and elder justice.

In addition, the organization is pivotal in managing water issues in the Houston-Galveston region by collaborating with stakeholders on strategies for water quality, watershed management, and flood mitigation. As a common concern voiced in many of H-GAC's pop-up meetings with local governments, in 2024, H-GAC and its Water Resources Committee will focus on a broader discussion of water supply challenges to ensure a resilient and sustainable water future for the region.

Regional Strategy to Flood Mitigation

H-GAC promotes a regional approach to planning and response for flooding and natural disasters through collaboration, technical services, and funding development. Through direct staff support and facilitation of its Regional Flood Management and Water Resources Committees, H-GAC identifies best practices for regional flood resilience, prioritizes projects for potential funding opportunities, supports local communities in developing Hazard Mitigation Plans, leads regional emergency preparedness programs, and ensures federal and state funding for flood risk mitigation is prioritized throughout the 13-county H-GAC region.

Improving Our Region's Water Quality

Since 1991, H-GAC has coordinated the Clean Rivers Program in the region. Coordinating with seven local partners, H-GAC manages water quality data collection at 408 sites in four river basins. Accredited labs analyze samples under a regional plan, ensuring high-quality, comparable data.

In 2023, H-GAC collaborated to identify and reduce bacterial sources in local water bodies, exemplifying effective environmental stewardship. Using the water quality data collected, H-GAC offers a variety of watershed planning activities and assistance to local communities in support of their efforts to reduce threats to the public.



In 2023, H-GAC helped local governments apply for \$62 million in disaster mitigation project funding from an allocation by the Texas General Land Office's Regional Mitigation Program. H-GAC and its local partners pursued five regional priority projects to enhance our region's storm resilience, which include a wastewater treatment plant relocation, wastewater line rehabilitation, Brazos River erosion mitigation, a wetland mitigation bank, and a flood warning system for the Colorado and San Bernard rivers.

HOUSING

n 2023, the Community and Environmental Planning Department began an initiative to expand its role in housing beyond past efforts related to disaster recovery and fair housing policy. Adequate housing across all economic situations is a fundamental need to ensure the continued prosperity of our region. As one of our priority areas, our work began with an update to the Regional Housing Plan, which will be released in 2024. In addition, H-GAC will continue to foster conversations and efforts to increase housing capacity in the region and support efforts to enhance the community context that affects it, in its Livable Centers, Bringing Back Main Street, and Regional Conservation Initiative programs.

Strategies for Addressing Displacement

The workshop, "Paving the Path to an Equitable Future: Strategies for Addressing Displacement," took place in late 2023 and explored equitable development methods, featuring expert speakers and real-world solutions for creating inclusive communities without displacement. The event engaged urban planners, community leaders, policymakers, and developers in addressing this critical issue.



H-GAC is one of many partners in a multi jurisdictional team, which includes local governments, nonprofit partners, and community organizations, and is led by the Texas A&M Forest Service. Tree plantings occur in local communities with a focus on tree equity, heat island impacts, water quality, and flood mitigation benefits.

H-GAC Supports Resiliency and Quality of Life Through Conservation

H-GAC's Regional Conservation Initiative actively supports the conservation and enhancement of natural areas in local communities by identifying funding, performing technical analyses, facilitating partnerships, and providing educational opportunities. When considering the community context with access to transit and career centers and services, the natural infrastructure of a community can go a long way to ensure housing initiatives are successful. Natural infrastructure is also key to improving public health, environmental conditions, and disaster resiliency as well as creating a sense of place for those who live, work, and raise their families in the community.

In 2023, H-GAC hosted several workshops, led community tree-planting events in Kashmere Gardens and the Cypress Creek watersheds, conducted several urban forest analyses for local cities, led a successful rails-to-trails project, and helped partners identify and pursue funding for a large number of projects designed to provide functional benefits and natural beauty in the places where we live.

Conservation Initiative

H-GAC Hosts Livable Centers Workshop

The workshop featured insights into implementing Livable Centers projects across the region, emphasizing elements beyond aesthetics, such as safety, economic development, and environmental impact. Local sponsors, including representatives from H-GAC, Angleton, East End District, Near Northwest Management District, East Aldine District, and UltraBarrio shared their experiences and efforts in the realm of placemaking. The

event was notable for its accreditation, offering three certification management credits from the American Planning Association, and drew 72 in-person attendees. These sessions provided a valuable platform for knowledge exchange and inspiration for sustainable community development.





The Infrastructure Investment and Jobs Act, signed into law on November 15, 2021, allocated \$42 billion to broadband infrastructure. Texas is slated to receive \$3.3 billion of this total in 2024 through the Broadband Equity, Access, and Deployment program. Regional leaders understand that broadband is a critical service for businesses, organizations, and residents. Its void was made more pronounced during the height of the COVID-19 pandemic when people needed it for work, telemedicine, and schooling for their children.



Bridging the Digital Divide

Broadband technology is rapidly evolving into a fundamental utility, playing a crucial role in enhancing individuals' quality of life and economic opportunities, spanning healthcare, education, employment, services, news, and entertainment.

Recognizing this, the federal government and the state of Texas have made historic investments in broadband infrastructure and access programs. H-GAC, home to the Gulf Coast Economic Development District, has emerged as a regional leader, ensuring communities within our region are equipped with updates, data, and support to position themselves for funding and active participation in the rapidly changing digital economy.

2023 Key Achievements and Initiatives

\$400,000 GRANT FUNDS

Awarded by the U.S. Economic Development Administration to conduct deep research and analysis into the region's broadband needs, focusing on rural and disadvantaged communities, and to develop an action plan addressing those needs.

CONVENING THE EXPERTS

The first Regional Broadband Summit included featured speakers from the National Telecommunication and Information Administration, the Federal Communications Commission, the Texas Broadband Development Office, technology companies, internet service providers, and the Gulf Coast Workforce Board.

BROADBAND MAPPING

H-GAC's Data Analytics and Research Department has supported the project by developing a tool to help better visualize the region's broadband needs.

COALITION BUILDING

The Dallas Federal Reserve and other regional partners objectively address broadband needs and challenges, leveraging expertise in understanding needs, identifying opportunities, and building best practices.

COLLABORATING REGIONALLY

The Texas Association of Regional Councils and other government councils across Texas are fostering a united voice and a collaborative approach to working with the Texas Broadband Development Office and communities within their respective regions.

H-GAC is leading the conversation for more statewide collaboration and planning through a mega-broadband summit in 2024, for the four major Texas regions: Houston, Dallas, Austin, and San Antonio. This summit aims to explore cross-regional partnerships, cost efficiencies, economies of scale, and extended infrastructure and access across multiple jurisdictions.

Cities and counties throughout the region are tackling the challenge of managing growth, which is hindered by infrastructure costs, inflation, and limited federal funding. In addition, recent major flooding events have spurred these communities to search for additional resources to acquire necessary flood prevention equipment and assess the cost-effectiveness of flood mitigation efforts.



Team H-GAC celebrated a day of thanks and giving at the Houston Food Bank on November 6, 2023. H-GAC staff sorted, sanitized and packed six pallets of food for the Houston Food Bank, providing close to 3,000 meals for families in the Houston-Galveston region.











LEGISLATIVE OUTCOMES FOR SERVICES AND PEOPLE SERVED

During the 88th Texas Legislative Season, the legislature passed a number of bills that will enhance the services H-GAC already provides to the people of our region. At the federal level, with the passage of the American Inflation Reduction Act, seniors and other vulnerable populations on Medicare are expected to benefit in multiple ways.

Public Safety

TX Senate Bill 1852 mandates 16 bi-annual ALERRT training hours for certified peace officers, with a two-year compliance deadline. In response, H-GAC, a supporter of this training since 2013, purchased and distributed extra ALERRT kits at no cost to local law enforcement agencies.

Jobs & Education

TX House Bill (HB) 8 overhauls the state's method of financing community colleges, shifting toward an outcomes-focused, industry-aligned model. It offers new scholarships to support high-demand industries and provides funding to increase student support.

TX HB 1755 provides funds to educational institutions and nonprofits for performance-based workforce training programs. Supported providers must coordinate with the Texas Workforce Commission and employers to ensure programs align with the state's workforce needs.

TX HB 1615 amends Texas Government Code §2308.256, mandating workforce boards to include a childcare workforce representative. The bill also instructs the Texas Workforce Commission to collaborate with the Texas Education Agency to enhance pre-K program availability and offers professional development scholarships for childcare workers pursuing degrees in relevant fields or apprenticeship programs.



Medicare & Pharmaceuticals

TX HB 25 creates the "Wholesale Prescription Drug Importation Program." The state's Health and Human Services Commission is able to contract with Canadian drug wholesalers and suppliers to bring safe, eligible prescription drugs to Texas consumers at prices far less than U.S. wholesalers.

The American Inflation Reduction Act allows Medicare to negotiate the price of certain prescription drugs, bringing down the price beneficiaries pay for their medications. Medicare recipients will have an annual out-of-pocket prescription drug cost cap starting in 2025.

The act also extends Affordable Care Act Subsidies through 2025, instead of expiring at the end of this year. According to the U.S. Department of Health and Human Services, nearly three million Americans could lose their health insurance if these subsidies were not extended.

Social Security and Supplemental Security Income payments will increase by 3.2 percent for 71 million older Americans. On average, Social Security retirement benefits will increase by more than \$50 per month beginning in January 2024.

SUPPORTING THE LOCAL ECONOMY

Comprehensive Strategy for Regional Growth

A first opportunity for the public to help define a vision that could bring grant dollars to our region.

H-GAC and the Gulf Coast Economic Development District have achieved a milestone by seeking public input for the first time in developing a Regional Comprehensive Economic Development Strategy (CEDS). CEDS provides a shared vision of the Houston-Galveston region for the next five years.

During the summer and into late 2023, CEDS workshops were held throughout the region to encourage active, diverse participation. This effort marks a significant step toward creating an informed and responsive economic development strategy for the entire 13-county Houston-Galveston region. The community's shared vision strategically aligns with the needs and aspirations of stakeholders, fostering a more comprehensive understanding of the regional economy and growth vision.

Based on the identified needs, H-GAC aims to secure federal funding to support small businesses, education institutions, and communities, fostering collaboration and alignment with the envisioned goals.

New H-GAC Energy Members Experience Cost-Savings

Specializing in electricity procurement for government entities in Texas' ERCOT (De-Regulated) regions, the H-GAC Energy Program employs a network of providers to offer a range of quotes, ensuring access to the most advantageous options, including a commitment extended to providing exceptional member support and services throughout a contract. H-GAC Energy Program finalized electricity contracts with several new members, including the city of South Houston and the city of Bunker Hill Village. Totaling more than 200 members, H-GAC Energy Program members are able to bypass resource-intensive events such as pre-proposal conferences and proposal openings, capitalizing on a real-time, competitive procurement process to select their retail electricity provider. Substantial overcharges were also detected, amounting to tens of thousands of dollars for a large water processing plant. H-GAC Energy Program acted promptly to champion the situation, resulting in necessary restitution.

HGACBuy Set to Surpass \$1.5 Billion in Sales in 2024

Helping Governments Across the Country Buy (HGACBuy) extended its services in 2023 by adding more than 400 new members to its roster, totaling 9,800 members. In 2024, the program expects to process over 3,100 orders to surpass \$1.5 billion in sales through its government-to-government procurement service. HGACBuy serves its members by streamlining the acquisition of diverse products and services through competitive solicitations, allowing member governments the flexibility to make purchases using interlocal agreements.

TRANSPORTATION SYSTEM What is a Metropolitan Planning **Organization?**

A Metropolitan Planning Organization (MPO) is a federally mandated and federally funded transportation policymaking organization. Introduced by the Federal-Aid Highway Act of 1962, MPOs are comprised of local elected officials and transportation authorities to ensure regional cooperation in transportation planning. Our local MPO consists of Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, and Waller counties.





H-GAC Contributes to Houston Rail **Transformation**

The Gulf Coast Rail District Board of Directors approved the Houston Area Rail Transformation (HART) stakeholder group as one of its official committees on January 17, 2023.

Comprised of representatives from Class 1 railroads, Gulf Coast Rail District, city of Houston, Port Houston, Harris County, the Metropolitan Transit Authority of Harris County, H-GAC, and the Texas Department of Transportation, this committee of partners is working together to increase the efficiency of Houston's unique rail network.

H-GAC's contributions to HART during 2023 include:

- Developed H-GAC regional priority rail crossings list
- Contributed 10 locations to Phase 2 of the Texas Department of Transportation - Houston Rail Study Project

2045 Regional Transportation Plan Update Reaches Millions

In early 2023, the MPO, a program of H-GAC, engaged the community and sought feedback on an update to the 2045 Regional Transportation Plan (RTP).

The current 2045 RTP Update recommends transportation investments totaling approximately \$109 billion and includes more than 750 unique projects sponsored by 63 local planning entities. The 2045 RTP Update was approved and adopted by H-GAC's Transportation Policy Council on April 28, 2023.

H-GAC Commute Solutions Charts a Better Route to Work

Commute Solutions, a program of H-GAC, provides alternative transportation resources in the Houston-Galveston region for commuters and employers. The initiative aims to reduce peak period commuter trips and vehicle miles traveled, improve traffic mobility, and improve regional air quality by reducing ozone-forming vehicle emissions.

Commute Solutions wrapped up a flexible work pilot program with several employers this year to help them and their workers find better ways to get to work. Some of these employers include public service organizations, such as the city of Houston, and private companies like Oncology Consultants.

Intersection Safety Work Continues into 2024

In the summer of 2021, H-GAC contracted with Kimley-Horn to perform intersection safety audits, which took place from late 2021 to early 2022 at 58 intersections in the region. Remaining funds in the grant led to contract amendments for additional work, including analyzing the Crash Record Information System for the top five dangerous intersections in each county, developing an intersection safety audit course, and auditing additional intersections along Crosstimbers from Yale to Hirsch in Houston. The intersection/road safety audit pilot training occurred in August 2023, and a scheduled intersection/road safety audit training is set for February 2024.



WORKFORCE PUTS THE REGION TO WORK

The Gulf Coast Workforce Board and its operating affiliate, Workforce Solutions-Gulf Coast, a program of H-GAC, is the public workforce system for the 13-county region. The board sets the strategic direction and focus for the public workforce system in our region and serves to elevate the economic and human potential of the Gulf Coast region by fulfilling the diverse needs of businesses and individuals. The board has identified objectives to achieve and performance measures to judge progress toward those results. This enables the board to effectively engage employers, help workers find jobs, and maximize funding. The board uses its funds to ensure our region has competitive employers, an educated workforce, more and better jobs, and higher incomes.

Operating at 30 locations throughout the Houston-Galveston region, Workforce Solutions works in tandem with the Texas Workforce Commission and the statewide Workforce Solutions network to maintain the state's largest job-match database: WorkInTexas.com.

The Summer Earn and Learn Program, a collaboration between the Gulf Coast Workforce Board/Workforce Solutions and Texas Vocational Rehabilitation Services, successfully placed 611 young adults with disabilities, aged 14 to 22, into paid work experience opportunities. Four participants even secured full-time employment at the start of their work experience (two at CVS Pharmacy, one at Gimme a Bark, and one at Taco Cabana).

This year, CVS hosted 100 worksites for 209 students, and Goodwill provided 34 worksites for 101 students. Taco Cabana, Houston Zoo, West Houston Alliance Ministries, Houston Independent School District (I.S.D.), Aldine I.S.D., Klein I.S.D., and Walgreens each hosted 10 or more students.

- 611 Young adults aged 14 to 22 were placed in paid work experience for the summer.
- 550 Youth with disabilities completed at least five weeks of paid work experience.
- 256 Worksites participated in the Summer Earn and Learn Program.



H-GAC will launch a redesigned website in January 2024. Crafted with the user experience in mind, the new website is accessible, engaging, and visually appealing as it educates, informs, and connects visitors to the programs and services available at H-GAC.



Improved Calling Customer Experience

H-GAC has embraced Ring Central, integrated with Microsoft Teams, as its telecommunications platform. Ring Central, a cloud-based service, enhances phone accessibility in our hybrid and mobile work environment, offers customization for future projects, and provides robust metrics for improved program performance visibility. As of November 6, 2023, approximately 450 phone numbers and 25 calling groups have seamlessly migrated to Ring Central, ensuring a smooth transition.

Streamlined for Efficient Performance

In 2023, Data Services championed the implementation of Asana for advanced project management and collaboration, centralizing tasks and plans. Originally designed for 100 users, the project has surpassed expectations with more than 313 active staff using the platform and 53 external members for 1,175 projects and 72,901 tasks. Leveraging Asana's features has streamlined operations, improved internal collaboration, and enhanced customer experience initiatives, leading to improved external customer interactions.



Beyond Our Walls: Expanding Communication and Outreach Services

Representing a pivotal step towards enhancing our capabilities and fostering meaningful collaborations, H-GAC's outreach and government affairs team worked with the Texas Association of Regional Councils to produce a video commemorating its 50th anniversary featuring interviews with members from various councils of government. This project holds particular importance as it marks the team's inaugural external request for work. H-GAC is working to expand its resources and extend services to member governments.
