




AACOG Housing Activities

AACOG serves the Alamo Area State Planning Region 18, which is comprised of Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson counties

The AACOG 13-County region covers 12,585 square miles and with a population of approximately 2.7 million

Alamo Area Housing

- Population 2,726,631
- Housing Units 1,089,626
- Owner Occupied 632,821 or 58%
- Renter Occupied 359,770 or 33%
- Vacant (vacation or seasonal) 97,035 or 9%
- San Antonio Population 1,495,295 or 55%
- Housing Units 592,430 (71% of Bexar County; 54% of the Alamo Area)
- Owner Occupied 219,415 or 37%; 20% of area
- Renter Occupied 373,015 or 63%; 34% of area

 - Oak Creek in New Braunfels, Comal County
 - Walnut Sprints in Seguin, Guadalupe County

Housing Choice Voucher Program

Mission Statement

The mission of the Brazos Valley Council of Governments (BVCOG) Housing Choice Voucher Program (HCVP) is to promote:

- Adequate and affordable housing
- Economic opportunity

A suitable living environment free from discrimination for lowincome families

What is the Housing Choice Voucher (HCV) Program?

The HCV program is a federally funded rental assistance program for low-income families

- We pay a portion of the family's rent, which is based upon the household's income
- The program currently serves 1,742 families
- On average, BVCOG pays \$1.2 Million in Housing assistance for families on the program each month in the BVCOG Seven County Jurisdiction
- Families must meet certain guidelines regarding income, family size, and household structure to be eligible for assistance

*Have their own Housing authority

How does a person apply?

They can apply on the waiting list which is located on our web site at <u>www.bvcog.org</u> under the Housing Choice Voucher Program. (Currently closed)

There are currently 2,806 families on the waiting list.

As we determine need to meet Funding needs or Voucher usage, Families are scheduled for an appointment for Eligibility determination.

Housing Choice Voucher (Allotted-1943)
*Have Income at or below HUD Specified income limits

- Qualify on the basis of Citizenship or the eligible immigrant status of family members
- Meet Net Asset and Property Ownership restrictions Requirements

- Veteran Affairs Supportive Housing (Allotted-25)
 Eligible participants are homeless veterans and their families who agree to participate in Case Management from the Veteran Affairs Medical Centers (VAMC)
 - All referrals must come from the VAMC to BVCOG
 BVCOG determines Income Eligibility and verifies they are not a lifetime registered sex offender by background check.

Mainstream Voucher Program (Allotted-75)
 Must apply on the waitlist and meet the following criteria when selected:

- Be between the ages of 18-61 and meet the statutory definition in accordance with Chapter 42 US Code Section 423 for a disability.
- Have Income at or below HUD Specified income limits
- Qualify on the basis of Citizenship or the eligible immigrant status of family members

Foster Youth Initiative Voucher Allotted-17 Referred by the TX Department of Family Services (DFPS) meeting the following criteria > At least 18 years of age but no more than 24 at the time of certification by DFPS > Are homeless or risk of becoming homeless BVCOG Determines if they meet Income and eligibility requirements

- Emergency Housing Voucher (Expired 9-30-23)
 This Voucher was provided to Participants who were homeless or at Risk of being homeless.
 - Referrals were received by Continuum of Care partner Twin City Missions and BVCAP.
 - The vouchers sunsetted on 9-30-2023 and as families End Participation, the voucher is not reusable.
 - We currently have 38 families being served.

Family Self-Sufficiency

Voluntary five-year program for housing clients to help them

- Obtain and maintain employment with a livable wage
- Prepare for and achieve a life FREE FROM government assistance

Family Self-Sufficiency Benefits of the program

Through partnerships with other agencies

- Participants gain access to community resources through a streamlined referral process
- Participants are able to obtain support services to assist with basic needs, i.e. child care assistance, tuition assistance, transportation, medical needs, while they are working to achieve their goals

Family Self-Sufficiency Benefits of the program

Escrow payments

- As the participant's income increases due to an increased in earned income, their portion of the rent also increases and the housing program's portion of the rent decreases.
- BVCOG will deposit a portion of the rent assistance not used for the participant into an escrow account.
- At the end of the FSS program participation, the participant will receive the remaining balance in the escrow account from the deposits and interest earned



GOLDEN CRESCENT AGING DISABILITY RESOURCE CENTER

Direct Support

- Housing navigation for older adults & individuals with disabilities
- Assistance with rental applications, utility support, home modifications
- Connections to emergency shelters and transitional housing
