No written public comments were received prior to the meeting and no one in attendance expressed an interest in making a verbal comment.

## 3. ACTION

## Approval of meeting summary for April 17, 2024 meeting

Lisa Graif (HPB) will lead the subcommittee through the approval process.

Eileen Egan motioned for approval & Patricia Kievlan seconded the motion. The item was approved unanimously.

### INFORMATION

#### 1. Safety Briefing – Open Discussion

Marcus Tucker (H-GAC) lead the safety briefing discussion with the announcement of new HAWK signal installations on S. Mason, Fry, and anticipated on Westheimer. The project was introduced by Commissioner Vincent Morales with Fort Bend Precinct 1. There was a discussion about the effectiveness and the limitations of HAWK improvements on pedestrian and bicyclist safety.

#### 2. *Transportation Alternative Set-Aside (TASA) Call for Projects Update*

Vishu Lingala (H-GAC) provided an overview of the upcoming TASA project selection process. Vishu briefed committee members on the status of regional goods movement and indicated staff is still in the process of selecting projects for the next 5 categories including major investment projects, high growth area needs, operational improvements, congestion management, resiliency, transit, and the next category active transportation. Vishu explained the types of projects that could be submitted for active transportation including, bike and pedestrian projects, new sidewalks, shared use paths in new areas and fill gaps within existing networks. Additionally, reconstruction or reconfigure travel lane projects would be eligible too. Staff is currently working on the criteria for evaluation and we anticipate publishing by the end of December. Questionnaires would be accepted in January with forty-five (45) days to complete online questionnaires. Active Transportation Benefit Cost Analysis (BCA) may have a lower or a less than 1.0 ratio for active transportation projects. Staff anticipates to include another validation for the BCA. Project selections should be completed by August 2025. There was a discussion about timeline and process. This discussion started with Sherry Weesner asking about if all the benefits of active transportation are being scored & captured correctly & accurately with the current process. Vishu responded that a tool has been discussed but that he hoped that by the next meeting there would be an improved scoring system available. Sherry also made a comment about the upcoming Highway Safety Improvement Program (HSIP) call for projects. Specifically, she noted that TxDOT had included several new countermeasures available in this call that weren't available previously. She also noted that these projects can appeal to rural areas not just urban or suburban areas citing a comment at a previous TPC meeting about a former member whose son was killed on a rural FM road in Chambers County.

#### 3. *Biketober Bike the Gulf Update*

Chelsea Alventosa (Commute Solutions) provided an update on the Bike the Gulf Challenge. Chelsea explained the Love to Ride app and the Bike the Gulf challenge during the month of October. Love to Ride works across seven (7) countries and hundreds of cities with ¼ million riders on the platforms. Love to Ride aims to make biking fun and engaging while encouraging and educating riders. The Love to Ride website has tips and tricks as well as more information on campaigns and challenges. Chelsea explained that the app works like a Fitbit and can automatically track when someone is riding a bike if they enabled that setting. The app allows riders to rate the route and indicate where they felt comfortable and where improvements may be needed. During the month of October, the campaign in Bike the Gulf and riders can compete and win prizes. Several committee members indicated their appreciation for the program.

#### 4. *Buffalo Bayou East Design Concept*

Marcus Tucker (H-GAC) will provided an update on the Buffalo Bayou East Design Concept. Marcus indicated this was a fourteen(14) month project to improve the mobility of bicycle and pedestrian access and mobility through the two (2) part project. Marcus explained the first part includes looking at several trail segments while the second part will study a Transit Oriented Design (TOD) area within a ½ mile radius around the Lyons Transit Center. The plan will produce an existing conditions assessment with a robust public engagement effort to inform scenario building and recommendations. Stephan Gage (TxDOT) requested to be engaged in the process to ensure projects they are working on can align. Yuhayna Mahmud (METRO) requested the transit center be referred to as 5th Ward, Denver Harbor Transit Center for consistency with the community.

#### 5. *Memorial Drive Bicycle and Pedestrian Study*

Marcus Tucker (H-GAC) will provided an update on the Memorial Drive Bicycle and Pedestrian Study. Marcus explained this was a twelve (12) month project in within the Energy Corridor. The study will identify opportunities for improving the multi-modal travel along Memorial Drive from State Highway 6 to North Eldridge Parkway.

#### 6. *City of Friendswood Master Trails Plan*

Marcus Tucker (H-GAC) provided an update on the City of Friendswood Master Trails Plan. Marcus explained this was a

twelve (12) month project in within the City of Friendswood limits. The study will identify opportunities for improving the bike and pedestrian infrastructure in the City. Donna Kacmar asked about the connector from Memorial Park to Buffalo Bayou. Jessica Cohen answered that the project was part of last year's call for progress & is in progress with the project currently in design & an interlocal agreement for Commissioner's Court is expected soon.

#### **7. Bay Area Ped/Bike Safety Study Update**

Susan Jaworski (H-GAC) will provide an update on the Bay Area Ped/Bike Safety Study and walked the committee through some of the components of the study.

#### **8. Ped/Bike Subcommittee Workgroups Update**

Marcus Tucker (H-GAC) indicated there was no update for workgroup activity.

#### **9. Planned Ped/Bike Activities in the Region**

Eileen Egan (Near Northwest Management District) provided an update to the W. Tidwell project and announced they have started construction and are a little bit more than halfway through sidewalk construction. Eileen stated the Management District will be starting the Park Gateway work in December/January 2025. Eileen announced they are moving forward early next year on design efforts using carry over funding on W. Little York Safe Routes to School project.

Dexter Handy (Greater Houston Coalition for Complete Streets) announced the East End District is planning to conduct a walk audit on 10/26/2024 on the East End and are looking for more volunteers.

Lisa Graiff (Houston Parks Board) announced they are nearing the end of construction on a connector trail project in Spring Branch and another in Sharpstown which should be complete by early next year. Lisa announced the Parks Board has accepted bids to complete the Brays Bayou Greenway project.



# The Lisa Torry Smith Act

- June 18, 2021, Texas Governor Greg Abbott Signed The Lisa Torry Smith Act, Making It A
  - **Criminal Offense For Drivers Who, Through An Act Of Criminal Negligence,**
  - **Cause Bodily Injury Or Serious Bodily Injury To**
    - Pedestrians,
    - A Person Operating A Bicycle,
    - Motor-assisted Scooter,
    - Electronic Personal Assistive Mobility Device,
    - Neighborhood Electric Vehicle,
    - Or Golf Cart
  - **In The Area Of A Crosswalk.**
- Beginning September 1, 2021, A Driver May Be Charged With:
  - **Class A Misdemeanor If A Driver Causes Bodily Injury To A Pedestrian And**
  - **State Jail Felony**
    - **If The Driver Causes Serious Bodily Injury To A Pedestrian**



# The Background

- In October 2017, Lisa Torry Smith Was Walking Her Son To School
- A Vehicle Struck Lisa And Her Son While They Were In A Crosswalk
  - Lisa Torry Smith Died - Her Son Suffered Serious Bodily Injury But Survived
- A Criminal Investigation Grand Jury No-billed The Driver
  - Grand Jury's Decision Was Due To A Gap In The Law
- Senator Joan Huffman & Representative Ron Lewis Worked Legislation To Close That Gap, & Successfully Passed The Lisa Torry Smith Act This Year.
- The Lisa Torry Smith Act Applies State-wide, And Drivers Who Fail To Keep A Proper Lookout, Or **Commit Criminal Negligence** In The Area Of A Crosswalk, May Face Criminal Prosecution If Their Actions Cause Bodily Injury Or Serious Bodily Injury.”

# How Can You Positively Enhance The Lisa Torry Smith Act?

- **DRIVERS:** Be Courteous And Share The Road With Pedestrians
  - Be Cautious When Entering Intersections
  - Look Both Ways And Check Crosswalks For Pedestrians And Cyclists
  - Your Actions May Save A Life And Prevent Your Prosecution.”
- **Pedestrians & Bicyclists:** Make Certain Vehicles Operators Are Paying Attention To You As You Prepare To Enter A Crosswalk
  - If Possible, Make Eye Contact With The Driver – Don't Become A Victim Of Their Smart Phone Distractions



According To The Texas Department Of Transportation Website, “Pedestrian Deaths Continue To Rise In Texas And Account For One In Five Of All Traffic Fatalities.

- **In 2020, 172 Pedestrians And 34 Bicyclists Were Killed On Houston Streets**

- *In 2019, There Were 205,179 People Involved In 77,556 Crashes In The City Of Houston. 1,469 People Were Seriously Injured In Crashes, And 267 People Were Killed In Traffic Crashes.*
  - **90 People Were Killed While Pedestrians And 16 People Were Killed Riding Bicycles.**

# Houston street conditions contribute to fatalities as well as health problems among children, study finds

- **Twenty-one children in Houston died while using active transportation modes such as walking and cycling between 2018-23,**
  - Study by Rice University's Baker Institute for Public Policy.
  - The study authors noted that hazardous road conditions for children likely are contributing to a national trend in which kids have become considerably less active.
- **At least 160 pedestrians were killed in Harris County in 2023, including 17 who were at traffic intersections**, Axios Houston reported in December. In order to increase effectiveness of the law, additional awareness by general public is needed.










New Riders by gender




Occasional Riders by gender



Regular Riders by gender




## Barriers to riding more

## Barriers to riding to work




This question was only answered by users who ride once a week or more.







# How Participants Get To Work by Rider Classification





## Selection of Key projects

Sidewalk Program	Short, medium, long-term solutions to reduce gaps in existing network. Short (unincorporated): \$21M, complete in 2024 (35 locations: 8wk). Medium: planned for 2025 (6wk), Long term (3-4mth) involves ROW acquisition, additional engineering, drainage etc.
Call for Projects 2023	Annual Call for projects – deadline June every calendar year.
Call for Projects 2024	Focus: multi-modal projects that are shovel ready + partner share
Tollways to Trails	Joint initiative between HCTRA, Pct 4 and consultants. Goal: developing and improving trails, with a focus on accessibility and community engagement.


