

10A. ADMINISTRATIVE AMENDMENTS TO THE 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM AND THE 2045 REGIONAL TRANSPORTATION PLAN

BACKGROUND

The 2025-2028 Transportation Improvement Program (TIP) is a four-year capital improvements program for transportation projects. Under federal rules, all federally assisted projects must be included in the TIP to be eligible for funding. In addition, federal rules require that regionally significant local projects must also be included in the TIP.

The 2045 Regional Transportation Plan (RTP) is a long-range plan that prioritizes spending on regional transportation projects including short and long-range strategies to ensure the transportation network is safe and efficient. Updated every four years, the RTP outlines a fiscally constrained transportation investment program that is based on the unique needs and characteristics of the MPO region. Amendments to the TIP and RTP are brought to the Transportation Policy Council for consideration monthly and amended in accordance with the H-GAC Public Participation Plan.

CURRENT SITUATION

In accordance with the H-GAC Public Participation Plan (PPP) administrative amendment requirements, these amendments are being processed within the stipulated limits. A summary of the modifications to the 2025-2028 TIP is included for information below.

- Add engineering as an authorized phase of work to four Montgomery County FY 2026 projects: two projects grouped in the TxDOT Statewide Rehabilitation and Maintenance Program (MPO IDs 19203, 19209) and two Intelligent Management System implementation TIP projects (MPO IDs 19236, 19237) at the sponsor's request. Delay the Montgomery County ITS implementation (MPO ID 19236) to FY 2026. No additional funding is requested.
- Delay two Gulf Coast Transit District Category-10 funded maintenance projects (MPO IDs 19029, 19032) from FY 2025 to FY 2026 in anticipation of available funding.
- Cancel the North Houston District's Imperial Valley Walking and Biking Connection's project (MPO ID 19034) from the TxDOT Statewide Bicycle and Pedestrian Program at the sponsor's request due to a change in priorities.
- Modify the locations of the Harris County Precinct-4's Traffic Signals Project (MPO ID 19206) at the sponsor's request.

The Harris County Office of the County Engineer (OCE) received funding for the construction of replacement of existing traffic signals with new upgraded signals at 12 intersection locations within Harris County Precinct 4 for a total amount of \$11,081,765 including \$11,081,765 of federal funds and 2,216,353 Transportation Development Credits (TDCs) for local government's 20% contribution.

The OCE, as the current Project Sponsor of the Harris County Precinct 4 Traffic Signals project (CSJ 0912-72-822), would like to request an amendment to the Transportation Improvement Program (TIP) to do the following:


