2020 Harris County Election Updates and Safety Tips: JoAnne Ray with the Harris County Clerk's Office updated the GDW on the results of the July primary runoff elections in Harris County and provided a breakdown of voting patterns for the March and July primary elections by vote type and ethnicity.
