1. Call to Order/Certify Quorum and Introductions

Chair Louis Jullien called the meeting to order and confirmed that Quorum was met. The members of the Pedestrian-Bicyclist Subcommittee introduced themselves for the record.

2. Public Comments

A public comment was made by Mr. Michael Huffmaster, Complete Streets Coalition.

On behalf of The Complete Streets Coalition, Mr. Huffmaster expressed interest in working with the H-GAC's Pedestrian-Bicyclist subcommittee in developing the criteria for the prioritization of sidewalk development and buildouts in the City of Houston. The Complete Streets Coalition looks at the proximity to major thoroughfares, public facilities, schools, and corridors as well as areas that need walkable sidewalks. The coalition would like to join the efforts in sidewalk surveys that are now being conducted by the subcommittee and the city planning department in developing a broad plan for the prioritization of sidewalks.

3. Approval of Minutes for April 19, 2018 (Chair Louis Jullien)

The minutes of the April 19, 2018 meeting of the Pedestrian-Bicyclist Subcommittee were approved as presented.

DISCUSSION

4. Analysis of Pedestrian and Bicycle Crashes in Houston (Ms. Oni Blair and Mr. Jonathan Brooks, LINK Houston)

Ms. Oni Blair briefed the subcommittee on the LINK Houston's bicycle crash analysis study and online map. Ms. Blair explained to the committee that this analysis was at the request of the Mayor of Houston to identify the ten most dangerous intersections in Houston for pedestrians and bicyclists. LINK Houston has collaborated with different organizations such as Bike Houston to facilitate this research. Ms. Blair also mentioned that this analysis would pinpoint what intersections and corridors impacted pedestrians and bicyclists the most and to also look to facilitate methods to increase pedestrian and bicyclist safety in the Houston area.

Mr. Jonathan Brooks briefed the subcommittee on the methodology used to complete this research as well as reviewed the most dangerous intersections, statistics, and various details that make these intersections dangerous. Mr. Brooks also reviewed the next steps and the agencies that will work toward investigating reasons behind pedestrian and bicyclist crashes and implementing methods to decrease their occurrence.

A brief question, answer, and comments by members followed this presentation.

5. Health Impact Assessment – 1-45 (Ms. Adele Houghton, Air Alliance Houston)

Ms. Houghton briefed the subcommittee on the health impact assessment Air Alliance will conduct on the I-45 expansion project. This assessment will include the highway expansion for I-45 from Beltway 8 to Midtown with funding received from the Urban Institute, Robert

Wood Johnson Foundation. Ms. Houghton explained this presentation would focus on pedestrian-bicycle impact concerns as well as concerns regarding air quality, mobility, low-income communities, economic development, parks and green space, noise, and views.

Ms. Houghton also explained there are school campuses that are located close to I-45 today and the distance between the schools and I-45 will decrease after expansion. She also mentioned after preliminary analysis, there were numerous pedestrian related and bicycle related traffic crashes near the schools that are located next to the I-45 corridor. Ms. Houghton said vulnerable school age children are the focus of this assessment. The study would research how these children might be impacted by the expansion and if there are ways to mitigate the impact. Ms. Houghton mentioned Air Alliance is in the process of developing the methodology to facilitate the assessment and will begin in the late summer or early fall of 2018. The report will be issued in February 2019.

A brief question and answer period as well as comments by members followed this presentation

6. Call for Projects (Mr. Vishu Lingala, H-GAC)

Mr. Vishu Lingala, H-GAC, updated the subcommittee on 2018 Call for Projects. Mr. Lingala mentioned the Technical Advisory Committee of July 18, 2018 has pushed back the start of the Call for Projects for 30 days due to some issues that need to be resolved. Mr. Lingala informed the subcommittee regarding changes in the investment category. Initially the minimum Federal participation amount was \$500,000 for all transportation projects. The revised requirement allows for a minimum participation amount for roadways of \$500,000 and \$150,000 for Transit and Active transportation. Mr. Lingala also briefed the committee on how projects would be categorized. The Major Investments category would include projects of over \$100 million and Other Investments would include projects under \$100 million. Active Transportation would be included in this category. Mr. Lingala also briefed the committee on other scoring factors and readiness criteria and available funding for the 2018 Call for Project as well for the next 10 years as well as future Call for Projects. Mr. Lingala also reviewed the application process for the committee. Committee members made comments. Mr. Lingala answered questions from the subcommittee during and after his presentation.

7. NEPA and Bike Lane Projects (Ms. Callie Barnes, TxDOT)

Ms. Callie Barnes, TxDOT, updated the committee on recent changes to the NEPA process for bike lane projects. Ms. Barnes briefed the subcommittee on the environmental classification for Bike and Pedestrian projects and recent changes in the environmental clearance process. Ms. Barnes also let the subcommittee know that Bike and Pedestrian projects are classified as CE C (3) and can be approved at the district level and do not need additional approval at the state level. Ms. Barnes also informed the subcommittee on changes to the Public hearing requirements for Bike and Pedestrian projects. This change

requires projects that receive Federal funding and involve a substantial change to a highway must hold a public meeting. Ms. Barnes also briefed the subcommittee on project scope development tools.

A lengthy question and answer period followed Ms. Barnes presentation.

8. TxDOT Statewide Ped-Bike Database (Mr. Robert Benz, TTI)

Mr. Robert Benz, TTI, provided information on the TxDOT Ped-Bike Database project. Mr. Benz gave the subcommittee an overview of the database and said the database was created for TxDOT and other agencies to gather information to make informed decisions and answer questions such as:

- What type of facilities do people use most?
- What attributes are around those facilities?
- Land use?

Mr. Benz also described the many types of data that can be collected and entered into this database. Mr. Benz also requested the assistance from all agencies in collecting information and asked them to enter their information into this database so that others can use this information for their pedestrian and bicycle planning efforts. Mr. Benz also mentioned this database would be standardized to accept data from all types of vendor collection formats. During the presentation, Mr. Benz demonstrated on how data would be entered into the database and how to manipulate the information. This database would allow a statewide monitoring process for pedestrian and bicyclists.

A short questions and answer period followed this presentation.

Chair Jullien invited subcommittee members to briefly discuss current and future walking and biking efforts in their communities. Subcommittee members and others provided updates.

10. Chair Jullien informed the subcommittee members that Ms. Diane Dohm, H-GAC Bicycle-Pedestrian planner, would be leaving H-GAC and accepting a position with the Oahu MPO in Hawaii and this would be her last meeting at H-GAC. Chair Jullien requested a round of applause for her efforts on behalf of the subcommittee and wished her well in her new position. A question regarding a pending workshop was discussed and resolved.

1. Call to Order/Certify Quorum and Introductions

Chair Louis Jullien called the meeting to order and confirmed that Quorum was not met. The members of the Pedestrian-Bicyclist Subcommittee introduced themselves for the record.

2. Public Comments

There were no public comments.

3. Approval of Minutes for July 19, 2018 (Chair Louis Jullien)

The minutes of the July 19, 2018 meeting of the Pedestrian-Bicyclist Subcommittee were presented for approval and were deferred to the next meeting of the committee due to quorum not being met.

Mr. Clint McManus introduced himself to the committee as the new Senior Bike planner at H-GAC effective in September. Mr. McManus mentioned to the committee that he was very excited to work with everyone. Also, Mr. McManus said he knew most of the members and was very familiar with the great work the committee members had done to make the region safer and more accessible. Mr. McManus invited the members to introduce themselves if they had not formally met.

DISCUSSION

- 4. Update on the 2045 Active Transportation Plan (Mr. Clint McManus, H-GAC)
- Mr. McManus explained to the committee the role of the active transportation plan is to establish a long-range regional vision for active transportation in the Houston-Galveston area. Mr. McManus also said the Active Transportation Plan also lays out the goals and the vision for the region and this includes the broad strategy for active transportation investments in both walkways and bikeways but it also includes an understanding of our region's conditions and needs and lists the strategies to help us achieve those needs. Mr. McManus also mentioned that some members were in the process of completing or had completed their applications for the Call for Projects and both projects support the broader 2045 Regional Transportation Plan. Mr. McManus said the 2045 Regional Transportation Plan is a federal requirement, and the Active Transportation Plan is not. Mr. McManus further elaborated on the process to facilitate the plan and said an advisory workgroup initiated at the end of 2017 as well as different types of data such as comments from public meetings, bicycle and walking surveys were used to complete the plan. Mr. McManus also informed the committee that he would bring the Active Transportation plan back to Pedestrian-Bicycle Subcommittee to January 2019 meeting for review and present it to the Technical Advisory Committee for review in February 2019 and its approval in March 2019.
- 5. Regional Safety Campaign (Mr. Stephan Gage and Ms. Lauren Preston, H-GAC)
 Mr. Gage briefed the subcommittee on the regional safety campaign that will support the update to the Regional Safety Plan. Mr. Gage elaborated on the importance of this safety plan and how it will be used to identify the more frequent types of vehicular crashes and then find ways to develop an action plan to address those problems. Also, the Regional Transportation Plan will mirror the safety plan at the state level. Mr. Gage mentioned that our region represents about 25% of the crashes in Texas and that Bicycle-Pedestrian crashes are over a quarter of those crashes and most are always fatal. Mr. Gage also said the plan continues the expansion of some of the current strategies such as "Teens in the Driver's Seat" and "Regional DWI Taskforce." Mr. Gage also mentioned another strategy which included

using data analysis to build a profile of the person or persons involved in the crashes to facilitate a more comprehensive outreach campaign. Mr. Gage ended his presentation by introducing Ms. Lauren Preston, H-GAC.

Ms. Lauren Preston, H-GAC, briefed the subcommittee on the upcoming Regional Safety Campaign and the various areas of concern that will be the focus of her public outreach efforts as well as the various forms of media that will be used to promote the Regional Safety Plan with a budget of \$1.3 million. A portion of this budget will be allotted to Bicycle-Pedestrian efforts. Ms. Preston also let the subcommittee know this campaign was tentatively set to begin in February 2019.

6. FHWA Multimodal Performance Measures Project (Mr. Clint McManus, H-GAC) Mr. McManus presented information to the subcommittee on the new grant received by H-GAC to study performance measures for measuring multi-modal network connectivity. Mr. McManus mentioned that Federal Highways requested applications for this grant in July 2018. H-GAC was awarded one of 8 grants distributed nationwide. Mr. McManus also said that H-GAC will partner with the City of Sugarland and METRO and the area being studied will consist of a half-mile radius around METRO's Hillcroft Transit Center. Mr. McManus also told the subcommittee that FHWA was interested in this study to comply with the FAST Act which was passed by Congress in 2015 which mandated state and local agencies to set measurable community goals which they call performance measures that are tied to transportation investments. Some of the measures are related to safety and some are related to congestion. H-GAC has already adopted some performance measures related to active transportation and currently use them in planning and operations. Mr. McManus presented the subcommittee with some statistics that supported his briefing and mentioned FHWA would like H-GAC to include other goals such as connectivity which is a challenge to measure and asked grantees to study and facilitate new connectivity methodologies and find what would enable it to be measured in active transportation. H-GAC will develop methodologies with this grant in three components.

- Network Completeness
- Active to destination
- Network Quality

Mr. McManus informed the subcommittee on the timeline for this study and is tentatively set for completion in Summer or Early Fall of 2019.

A short question and answer period followed the presentation.

1. Call to Order/Certify Quorum and Introductions

Chair Louis Jullien called the meeting to order and confirmed that Quorum was not met. The members of the Pedestrian-Bicyclist Subcommittee introduced themselves for the record.

2. Public Comments

Chair Jullien asked if there were any public comments and none were presented. Chair Jullien mentioned the passing of Mr. Pat Walsh, Director of Planning and Development with the City of Houston. Chair Jullien acknowledged Mr. Walsh's previous position with City of Sugar Land and his accomplishments. Chair Jullien requested a moment of silence by the subcommittee in memory of Mr. Walsh.

3. Approval of Minutes for July 19, 2018 (Chair Louis Jullien)

The minutes of the July 19, 2018 and October 18, 2018 meeting of the Pedestrian-Bicyclist Subcommittee were presented for approval. Both summaries were deferred to the next meeting of the committee on January 24, 2019 due to quorum not being met.

DISCUSSION

4. Update on the 2045 Active Transportation Plan (Mr. Clint McManus, H-GAC)

Mr. Clint McManus, H-GAC briefed the subcommittee on the status of the 2045 Active Transportation Plan. Mr. McManus mentioned the addition of new components added to the plan and briefed the committee on the plan timeline and what had been accomplished as of this meeting which included writing content, establishing goals and strategies, analysis of focus areas and then finalizing goals and strategies. Currently, the focus is on quality control and analysis on the Bikeway Layer and receiving feedback from subcommittee members and work toward finalizing the plan and prepare it for publishing. Mr. McManus proceeded to brief the subcommittee on the plan's six regional focus area criteria which include:

- Activity Population Density
- Intersection Density
- School Proximity
- Transit Proximity
- Crash Locations
- Environmental Justice

Mr. McManus also gave an overview of a map that described what the focus areas represented and the included criteria. The presentation concluded with a briefing on what the next steps are in completing the 2045 Active Transportation Plan. Mr. McManus informed the subcommittee that a draft plan would be sent to the subcommittee the week of January 7th and would be presented to Ped/Bike Subcommittee for approval on January 24, 2019. A period of questions, answers and comments from subcommittee members and other interested parties occurred during this presentation.

5. Regional Sidewalk Layer Presentation and Update (Mr. Clint McManus, H-GAC)

Mr. McManus provided an update to the subcommittee on data collected with the new regional sidewalk layer and provided a demonstration on how this tool would work and used to view the presence of sidewalks in the 8-County transportation management area. Subcommittee members and other interested parties participated in a lengthy discussion during this presentation. Several subcommittee members requested several additions to the criteria included in Regional Sidewalk Layer tool.
