H-GAC Staff updated members on the following items from the previous meeting:

1.*Regional Safety Campaign* -The committee was informed consultant is narrowing ideas and close to finalizing the campaign. The production work has been completed. The videos have been finalized and TSC received the radio commercial voice overs for review. No date has been set on when the campaign will launch. More details will be given at the next upcoming meeting.

2. *TXDOT Grant Application*- H-GAC is partnering with TXDOT instead of Ford on H-GAC grant funding opportunity. If approved, this grant will help to further develop a safety analysis tool with TTI. Funding determination will be known by April and communicated at the next meeting.

3. *Other Safety Data Analysis Efforts*-The state has hired TTI to do safety analysis. TXDOT Austin applied as well to get federal funding to assist with developing TTI tools. An update will be given on where the project stands.

Robert Benz presented the Bicycle Pedestrian implementation action plan.
