



## Goals and Metrics - For Review



#### Goals (metrics) - 1 of 2:

- <u>Mobility</u> Expand and accommodate all roadway users by incorporating Complete Streets principles, as contextappropriate (connectivity, gaps, cross section)
- Mobility Increase operational efficiency and reliability of major intersections and roadways (v/c, LOS, travel time)
- <u>Safety</u> Improve safety on the high-injury network (predicted changes to crash rates, number of conflict points)
- <u>Economic</u> Provide mobility options for residents and visitors (connectivity, cross section, economic impact, broadband)
- <u>Economic</u> Increase truck travel time reliability on the regional freight network (travel time, delay, stops)

#### Goals and Metrics - For Review



#### Goals (metrics) - 2 of 2:

- <u>Maintenance</u> Achieve a state of good repair for transportation assets (pavement section & condition, funding, policy)
- <u>Maintenance</u> Improve transportation asset resiliency and stormwater capacity (pavement section, cross section, truck routes, best practices)
- Natural/Cultural Resources Reduce transportation emissions (emissions, delay, stops)
- <u>Natural/Cultural Resources</u> Minimize impacts requiring mitigation (ROW required, access)

## **Network Screening - Overview**




Network screening defines focus areas (intersections and corridors) for further evaluation based on an evaluation of key indicators

- Corridor Mobility Identify 25 high-congestion corridors
- Intersection Mobility Identify 100 high-congestion intersections
- Segment Safety Identify 25 miles of high-crash segments
- Intersection Safety Identify 50 high-crash intersections








#### Network Screening - Intersection Mobility








# Network Screening - Segment Safety


