LONG RANGE PLANNING

Sub-regional Planning Initiatives (SPI)

- Pearland FM 518 Corridor Study: City Council accepted the study on June 30. H-GAC staff are working with the consultant to finalize the report.
- Pearland Mobility Plan: A public hearing was held on July 7 with the Planning & Zoning Commission
 for recommended updates to the Thoroughfare Plan. At that meeting the Commission recommended
 the City Council adopt updates to the Thoroughfare Plan. A public hearing and first reading of the
 ordinance with the City Council is scheduled for July 28, 2025. A second reading of the ordinance
 and adoption of the Thoroughfare Plan is anticipated for August 11, 2025.
- Chambers County Thoroughfare Plan: The Commissioner's Court adopted the Chambers County
 Thoroughfare Plan on April 22, 2025. H-GAC staff anticipates receiving the final report by the end of
 July.
- Washington Ave Corridor Study: A third public meeting was held on June 23 at the St. Theresa's
 Catholic Church's Fellowship Hall. A public survey on the short-term recommendations is currently
 available on the project website at Washington Avenue Corridor Study (WACS) | Engage HGAC until
 July 28. A direct link to the survey is available here https://hzplanning.typeform.com/WACS-Short. HGAC staff will present a project update at the Camp Logan Civic Club quarterly meeting on July 29 at 7:00pm.
- Cemetery Road Corridor Study: H-GAC staff received the final report and are collecting final deliverables for closeout.
- Friendswood Parkway (Friendswood Lake) Corridor Study: The draft alternatives and technical report are pending review by City of Friendswood staff. The alternatives will be presented during the next Focus Group and Public meetings, anticipated for the end of summer 2025.
- Friendswood Active Transportation Plan: The first Steering Committee Meeting was held on June 25.
 The project team introduced the project, presented the existing conditions assessment, provided an overview of the public engagement process, and gathered input from the steering committee members on community needs.
- Buffalo Bayou East Design Concept: The second Steering Committee meeting was held on June 26 to
 present preliminary recommendations for improvements to key corridor connections and transitoriented development surrounding the 5th Ward/Denver Harbor Transit Center.
- North Houston Communities Transportation Priorities Plan (NHCTPP): H-GAC staff completed proposal evaluations and will be seeking Board approval for a consultant contract on August 19, 2025.
- Montgomery County Mobility Plan: The Request for Proposals was released on July 2 and closes on August 14.

Regional Transportation Plan (RTP)

- Active Transportation staff attended the 2025 Texas Pedestrian Safety Forum in San Antonio.
- Staff began internal synchronization with Project Development and Project Delivery teams for input on the TASA Call for Projects program framework and integration into H-GAC's existing project selection process.
- Staff is inventorying existing Safe Routes to School (SRTS) programming in the region and is preparing to engage local stakeholders to begin a needs analysis.

AIR QUALITY

Air Quality Planning

- The TCEQs Rider 7 project provides funding to near nonattainment areas to support projects that may assist with the development of the State Implementation Plan (SIP). This month, staff worked with TCEQ to finalize the scope of work. The deadline for the completion of this project is December 2025. Staff have initiated regional conformity activities to support the 2025-2028 TIP and the updated 2045 RTP project listing by conducting a conformity kick-off meeting with conformity consultation partners. Staff finalized the Pre-Analysis Consensus Plan (PACP) and are currently working on the conformity report and subsequent appendices.
- Staff have begun to develop an air quality data hub, which will compile different air quality resources and efforts across the region.
- Staff is currently reviewing the final draft of the Regional Zero-Emission Vehicle Study. It will be published in the coming weeks.
- Staff is drafting a scope of work for a Regional Zero-Emission Vehicle Plan which will build on the
 results of the above study of current conditions. A competitive procurement process to select a
 consultant capable of executing the plan will follow.
- Preparations for the September 24, 2025 Regional Air Quality Summit at Baylor College of Medicine
 are well underway. The agenda has been finalized, speakers have been confirmed, and catering plans
 are in progress. Staff is also working to ensure the event includes meaningful takeaways for attendees.
 The event website and registration are now live, and marketing and social media notifications are
 currently being distributed.
- Staff is actively working with partners to develop an Engagement Plan that supports ongoing regional
 climate initiatives. Reduction Strategy Opportunity menus for local climate action plans have been
 drafted, and six regional stakeholder meetings across the 13-county area are scheduled to start in
 August. Branding and outreach materials for the CPRG campaign are also in development.

Clean Vehicles Grant Programs:

- Staff is working to prepare standard operating procedures for every phase of the Clean Vehicle Program participation. These include: the Application Phase, Contract Generation, Implementation Phase, Reporting Phase, and Close Out Phase.
- Staff are in the process of contracting a new GPS Provider to assist with monitoring vehicle usage for participants of H-GAC's Clean Vehicle Program.
- Staff continue to monitor post-delivery projects that have not yet met the contractually required emission reductions based upon subrecipient performance. This monitoring effort ensures that grant recipients' usage of vehicles remains within grant requirements and that vehicle use and mileage commitments are met. Staff are currently monitoring nearly 100 project vehicles.
- Conduct quarterly at the Area Emissions Reduction Committee Meeting (AERCO) to provide updates and reports for School Districts that receive Supplemental Environmental Project (SEP) funds through the Clean Vehicle Program. The last meeting was on May 14, 2025.

• Staff are updating a "Certificate of Buy America" to support new vehicle replacement efforts through the Clean Vehicles Program.

Clean Cities Coalition:

- Staff collaborated with subcommittees to gather input and develop the agenda and structure for the next Stakeholder Meeting, scheduled for July 22, 2025.
- Coalition staff secured a guest speaker who will present on autonomous trucking at the upcoming Stakeholder Meeting.
- Staff partnered with other Texas Clean Cities Coalitions to organize and develop a statewide webinar on electric vehicle charging solutions during emergencies.
- Coalition staff continues to engage with both new and existing stakeholders and partners to effectively
 disseminate Clean Cities program information and resources.
- Coalition representatives met with the Clean Cities and Communities Regional Manager, along with
 colleagues from other coalitions in the South-Central region, to share best practices and gain insight
 on the future of the national partnership.

MPO PROGRAMS

Incident Management/Tow and Go

- H-GAC held the regularly scheduled Tow and Go Ops meeting at Houston TranStar.
- H-GAC extended the current contracts for the continuation of the Freeway Incident Management Programs with the City of Houston and Harris County to expire January 31, 2026.
- H-GAC staff met with TxDOT to plan additional TIMS/SHRP 2 trainings. The next training will be held August 21, 2025, at Houston TranStar.

Transit Planning

- The Dayton Transit Study conducted two public meetings one onsite in Dayton on Jume 24 and the other online on Jume 26. Alternatives and recommendations for the study were discussed at the meeting. Recommendations for expanded services, marketing, and capital investments in transit infrastructure in Dayton were positively received. The consultant is working on the Financial Plan and Implementation Plan. Drafts of the Financial and Implementation Plan are expected in August. A meeting of study Steering Committee is scheduled for August 26.
- The Regional Transit Information Study Tasks 1–4 have been completed. Following the acceptance of the Federal Transit Administration/TXDOT grant at the July 15 H-GAC Board of Directors meeting, the consultants will proceed with Task 5: public engagement.
- The Regional Public Transportation Coordination Plan with the acceptance of the Federal Transit Administration /TxDOT grant on July 15 H-GAC Board of Directors meeting; the next steps will be developing a scope of work for the consultants.
- CMAQ: Sugar Land On-Demand service has seen rapid growth in ridership with 5,100 rides in four months, a 4.9/5 average ride rating, and a 36% zone expansion.
- TSU AV Research: H-GAC staff received invoice packets from Texas Southern University (TSU) for the months of January 2025 to June 2025. TSU also submitted an updated form 60 with these items.

Safety Outreach

- Teen Drivers Education: Outreach Strategists, LLC was awarded. The contract has been uploaded to Agiloft pending approval.
- Youth Traffic Safety: H-GAC staff issued a sealed solicitation to seek qualified contractors. Five submissions were received and evaluated by a committee of representatives from H-GAC and the Texas Department of Transportation. Evaluations were closed on June 2, 2025. The Board of Directors is set for July 15, 2025.
- Regional Safety Campaign: Staff is seeking approval from TxDOT for the influencer campaign and Ride, Don't Drive Campaign.
- Staff continues to attend Transporation Improvement Program Subcommittee, Rail Mobility Group, Road and Rail Safety Workshop, Regional Transporation Plan Subcommittee, Transporation Advisory Committee, MPO Programs Weekly Meeting and the Houston Traffic Safety Coalition.

Hurricane Evacuation

- Staff participated in television interviews regarding hurricane preparations with Fox News Weather and KHOU Great Day Houston.
- Staff provided Hurricane Guides to multiple external stakeholders including non-profits and churches.
- The Houston-Galveston Area Council was awarded the best internal campaign for our internal hurricane season campaign at the PRSA Houston Excalibur Awards.

Intelligent Transportation Systems and TSMO Planning

• TSMO Subcommittee received a survey regarding the future of the subcommittee. Feedback will be taken into consideration for the goals and improvements of the subcommittee.

Title VI/Language Access

- Staff continue to look for opportunities for implementing the Title VI Program and Language Access
 Plan through community outreach efforts and will participate in community engagement related to the
 development of RTP 2050.
- Staff training on Title VI Non-discrimination requirements for the MPO is scheduled for July 30, 2025.

Congestion Managment Process

The interim Congestion Process Management Plan udpate is under management review. The more comprehensive 2026 Congestion Management Plan update is moving towards release for competitive procurement. It is now under review in Procurement.

The development of an online form for the Congestion Management Analysis for Congestion Management waivers was well received by TxDOT staff. Release of the online form is scheduled for August.

A Congestions Management Proces dashboard is under development. The dashboard is intended to provide online information on the Congestion Management Process and provide interactive feedback from site users.

Travel Demand Management (Commute Solutions)

- Staff attended and hosted several outreach events, including presentations to the Transportation Advisory Council and the Transportation Policy Council. The Commute Solutions team continues to
- row their presence among the 8-county MPO and actively seek opportunities to increase education about program and expand number or partners.
- Commute Solutions saw over 7K new users visit yourcommutesolution.org, with over 9.1K page views. This trend is similar to previous months and demonstrates that the current campaign is helping the program reach residents and increase program awareness.
- Commute Solutions promoted our regional travel demand resource, Houston Connect Smart, through H-GAC's social media channels. Through this highlight, over 1k impressions were attained and promoted this tool to our residents.
- The paid digital campaign received over 5.8 million ad impressions for the month of June, with over 1 million of them delivered in Spanish.
- AECOM provided the Commute Solutions team witha draft of the Sales and Outreach Guide, as well
 as previewed a TDM strategy tool that would help staff identify the best TDM strategy for specific
 employers, based on their location. This tool remains in review.
- Commute Solutions and H-GAC Procurement hosted a preproposal conference for Bike Encouragement software with 5 interested organizations. The RFP is set to close on 6/26 and an evaluation period is scheduled for 7/1 7/10.
- Commute Solutions is preparing a request for a software that will further advance TDM services and
 programs for the region. The app and web-based TDM platform will be the backbone of current and
 future TDM services provided to employers and commuters. The platform will have the capability to
- manage relationships with employer partners, where Commute Solutions staff can help administer TDM programs that are unique to their organization.

TRAVEL DEMAND MODELING & FORECASTING

TRAVEL DEMAND MODELING & FORECASTING

- 1. Staff continues to provide travel demand and forecasting modeling to support the Regional Transportation Plan (RTP), Transportation Improvement Programs (TIP), and other traffic and travel
- 2. related data developments within the H-GAC MPO region that supports sub-regional and corridor studies. These include modeling support for TxDOT and non-TxDOT projects such as:
 - I-10 Inner Katy Corridor Traffic Projection (TxDOT): No-build and U-turn scenarios for 2040 and 2045 no-build, build, and U-turn scenarios, waiting on the projected 2059 and 2069 demographic data from the TxDOT consultant for additional model runs.
 - US 90A Transit Study and Fort Bend County Growth (Fort Bend County): Review of data and conducting model runs with improved accessibility along the corridor.
 - 110 Proposed Ramp Study (TxDOT): Model re-run for 2030 no-build and build scenarios using the updated network. The 2045 model run is forthcoming.
 - FM149 Extension Study (TxDOT): Working with TxDOT consultant to prepare the 2040 model inputs.
 - Metro I-69 LOS Analysis (METRO): Entered traffic data into HCS2024 and generated the Level of Service (LOS) report for I-69.
 - Employment Forecast near NW Transit Center (METRO): Provided 2023 and 2030 updated demographic data (TAZ layer) for METRO's job forecast in the transit center area.

- Houston Area SIP Inventories (TTI/H-GAC Transportation Department): This is a request from TTI (on-behalf of H-GAC Transportation Department to support the development of emission inventories for MOVES5-AD.
- H-GAC Safety Action Plan (SAP) Project: This is a project from the Transportation Department. We
 provided a large set of data, including TDM model outputs, RTP viewer layer and land use-related
 data, to H-GAC Consultant, Kimley-Horn.
- World Cup Scenario Planning (H-GAC MPO Region): Collected and post-processed time-of-day factors specific to weekend travel patterns across various trip purposes. Updating weekend headways for local transit routes.
- RTP Data and Map Request (H-GAC Transportation Department): Created the 2023 and 2050 (no-build) regional roadway congestion maps. Will assist with the Fort Bend County public meeting in August

3. Conformity:

- QA/QC current 2045 update project listing for TPC approval; working with in-house TIP staff and TxDOT for consistency with the project listing and Travel Demand Modeling network.
- Travel Demand Model Updates for next conformity Continue to update the 4-step Regional
 Travel Demand Model that supports the Regional Transportation Plan (RTP), Transportation
 Improvement Programs (TIP), and other traffic and travel related data developments within the HGAC MPO region that supports sub-regional and corridor studies
- World Cup 2026 FIFA Scenario Planning Services Continue to adjust the current H-GAC Regional Travel Demand Model for the various transportation scenarios modeling for the forthcoming FIFA 2026 World Cup games in the Houston area.
- Request from METRO: I-69 Eastex Freeway Level-of-Service (LOS) analysis
- AADT Review: I worked in Brazoria County and reviewed the listed cases; when I found any issues,
 I added comments explaining the problems.
- Lane number comparison: I did a comparison between DTA link, Actual Lanes and TDM Link.
- Metro Weekend Transit Review: Continue to conduct QA/QC on METRO existing data that goes
 into the H-GAC Regional Models for forecasting. These include Metro bus routes on METRO map
 and GIS map, both weekday and weekend schedules, and the time intervals between bus arrivals
 and departures.
- Ozone Calculation: This is a request from the Transportation Department. With MOVES output for NOx and VOC; exploring whether Ozone (O₃) levels can be estimated.
- Conformity Model Run (H-GAC Transportation Department): Performed travel demand model runs for all five analysis years, QA/QC on roadway networks. Ran TransVMT with T ravel Demand Model output and we sent the results to TTI to develop MOVES input files for the air quality model.

4. Travel Demand Modeling Updates:

- Staff continues to coordinate with Cambridge Systematics and team of sub-contractors in the Travel Demand Model Update and Maintenance tasks that includes:
- Model validation/calibration exploring the Travel Demand Model outputs and comparison with count data for validation/calibration purposes.
