

## ADMINISTRATIVE MODIFICATIONS OF THE 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM AND THE 2045 REGIONAL TRANSPORTATION PLAN

### BACKGROUND

---

The 2025-2028 Transportation Improvement Program (TIP) is a four-year capital improvements program for transportation projects. Under federal rules, all federally assisted projects must be included in the TIP to be eligible for funding. In addition, federal rules require that regionally significant local projects must also be included in the TIP.

The 2045 Regional Transportation Plan (RTP) is a long-range plan that prioritizes spending on regional transportation projects including short and long-range strategies to ensure the transportation network is safe and efficient. Updated every four years, the RTP outlines a fiscally constrained transportation investment program that is based on the unique needs and characteristics of the Metropolitan Planning Area.

Amendments to the TIP and RTP are brought to the Transportation Policy Council for consideration monthly and amended in accordance with the Metropolitan Planning Organization's Public Participation Plan.

### CURRENT SITUATION

---

A summary of the proposed revisions to the 2025-2028 Transportation Improvement Program is included below.

- Delay five METRO Federal Transit Administration (FTA) formula funded projects (MPO IDs 11268, 15243, 18002, 18009, 18857) to fiscal year 2026 to finalize the FTA grant obligation process.
- Delay two Woodlands Township FTA formula funded trolley replacement projects (MPO IDs 19170, 19171) to fiscal year 2026 at the Township's request.
- Clarify the Facility name and scope of work of The Woodlands Township's Congestion Mitigation/Air Quality Program funded Sterling Ride Park and Ride development project (MPO ID 19192) at the Federal Highway Administration's request.
- Clarify the scope of work of The Woodlands Township's FTA Section 5307 funded capital expenditures project (MPO ID 19456) and delay it to FY 2026 at the Federal Transit Administration's request.
- Clarify the scope of work of the City of Conroe's FTA Section 5339 funded bus replacement project (MPO ID 19239) and delay it to FY 2026 at the Federal Transit Administration's request.
- Update the FTA Section 5339 funding of the City of Galveston's vehicle purchase project (MPO ID 19181) based on the latest vender quote.

- Update the descriptions of three TxDOT Houston District roadway construction projects (MPO IDs 210, 282 19026) to maintain consistency with the recent Regional Transportation Plan amendments.
