

## 2025-2028 TIP Amendments

- Remove two Fort Bend County non-regionally significant, widenings on Harlem Road & Beechnut Street (MPO IDs 12622 & 13754) from TIP/STIP at the County's request.
- Add \$1.6M Congressional CPF award to City of Pearland's FY 2028 Mykawa Road widening (MPO ID 17082) matched with \$400K local funding.
- Add \$850K CPF award to Westchase Management District's Meadowglen West sidewalk reconstruction (MPO ID 18098) matched with \$213K local funding.

## 2025-2028 TIP Amendments

- Add engineering phase to TxDOT Beaumont District's FY 2025 US 90 widening (MPO ID 16347) with additional Cat-4, Cat-12 and Cat-12CL funding.
- Split Montgomery County's FY 2025 CPF funded Ford Road widening (MPO ID 18120) into two sections creating a locally funded section from IH 69 to Needham Road in FY 2026 (MPO ID 19413). Delay to FY 2026 with reduced local funding.
- Delay two Port Houston Port Road grade separation phases (MPO IDs 19012 & 19013) to FY 2027 & FY 2028 to coordinate with Bayport Southern Access Road construction.

## 2025-2028 TIP Amendments

- Adjust FTA Section 5307 Urban Area formula funding of City of Galveston's transit planning and operating project (MPO ID 19088) replacing state and local matching funds with TDCs.
- Program METRO's Police Department Headquarters building purchase and rehab with \$50M of local funding in FY 2026.
- ➤ Program METRO's Eastwood Transit Center rehabilitation with \$29M of local funding in FY 2027.


## Let's "Breathe Easy" in September!



- September is Commute Solutions 31st Anniversary
- Historically, September is one of the worst months for ozone levels in the Gulf Coast region.
- Goal of the program to:
  - Reduce peak period congestion & improve traffic mobility
  - Improve regional air quality by reducing ozone-forming emissions
- Commute Solutions launched a pilot ozone action campaign – Breathe Easy September



## Partnership Pilot w/ Transit Agencies



- Commute Solutions partnered with 4 transit agencies, and will continue to do so this September
  - The Woodlands Express
  - Conroe Connection
  - Harris County Transit
  - Fort Bend Transit
- Each Friday in September, riders can ride for free on all routes
  - Saw an increase of 15% in ridership among participating transit agencies!
  - Ridership on non-free fare days was higher overall, and continued into the following month

**DBE Program Guidance** 



- 1. Recipients of DOT funds must develop and implement a DBE program that conforms to DOT standards set forth in <u>49 CFR Part</u> <u>23</u> (for airport concessionaires) and <u>49 CFR Part 26</u>.
- 2. The FHWA requires local governments and other entities that receive federal funds through the Texas Department of Transportation (TxDOT) to sign a Memorandum of Understanding adopting TxDOT's federally approved DBE Program.
- 3. Each recipient is expected to set their own DBE goals based on their individual circumstances. The triennial goal is established to ensure that DBE firms have reasonable opportunity to participate in DOT-assisted contracts.



# FY2026-2028 DBE Goal Update Determining the Base Figure



#### STEP 1

- Bidders List and the TUCP (follows requirements of 49 CFR § 26.11)
- Looks at successful and non-successful bidders for past three years
- Looks at all ready, willing, and able DBEs
- Looks at all ready, willing and able Firms
- All DBEs are vetted by TUCP and MPO to determine certification and that they are ready, willing, and able to do the contract tasks.







- 2025 → 2029: 1 project, \$5M



### **Establishment Travel Surveys**

#### Why these Surveys (Objectives) -

> To update H-GAC Regional Model Inputs to post COVID-19 conditions.

#### **Establishment Surveys** -

- Commercial Vehicles At the 8-county level
- > Special Generator 4 campuses in Galveston county only

#### **Common Characteristics -**

- Usually create unique travel patterns.
- ➤ As a workplace, they often have a fleet of Commercial Vehicles which travel around each day performing duties for that business.

#### There are a total of 4 Special Generators in this survey:

- University of Texas Medical Branch
- Texas A&M University at Galveston
- > 2 Galveston College campuses at the Main and ATC Campuses.



## **Establishment Travel Surveys and Data inputs for Modeling**

Model Inputs needed to be updated to post COVID-19 conditions.

- a) Trip Attraction Rates
- b) Trip Length Distribution
- c) Travel Mode Usage
- d) Travel Estimates of Commercial Vehicles



### **Commercial Vehicle (CV) Survey – Recruitment and Retrieval**

Step 1: **Recruitment** Phase - Randomly contact businesses via a phone call for Recruitment of <u>2350 CVs</u> based on stratified targets.

Step 2: **Retrieval** Phase – businesses are assigned a travel date for their site, upon which the vendor leaves a smartphone to be placed into each vehicle to record their trips for the day.





## Future 2025-2028 TIP Amendments

- Program two Fort Bend County SH 99 NB frontage road construction projects (MPO IDs 19494, 19495) in FY 2026 with \$30M of federal STBG & Cat-10 with state match as H-GAC Project Select Process awards.
- Add \$6.7M of Texas Senate Bill 1 Cat-10 funds to three Fort Bend County SH 99 SB frontage road construction projects (MPO IDs 19198, 19200, 19201) in FY 2026 with state match & update the authorized phases of work.



## Future 2025-2028 TIP Amendments

- Remove \$70.4M of CMAQ funds from three METRO construction projects (MPO IDs 15265, 18761, 18762) per the Transportation Policy Council directive in March 2025. Delay from FY 2025 to FY 2026.
- Change the sponsor of the City of Conroe's FY 2029 Old Conroe Road four-lane extension project (MPO ID 17101) to Montgomery County per the agreement between the agencies.
