# ITEM 4. Approval of Minutes for September 08, 2020

Meeting minutes were approved.

# ITEM 5. Issue Updates (Stephan Gage)

H-GAC Staff updated members on the following items from the previous meeting:

- 1. Vision Zero Policy Resolution The committee was informed TPC did adopt Vision Zero Policy Resolution.
- 2. *Regional Safety Campaign* The consultants have completed their work. H-GAC communication department is working to further develop the safety campaign materials. The campaign will launch in the Spring 2021.
- 3. *Intersection Safety Audits*-Staff informed the committee that a request for qualifications has been solicited. Staff hopes to have a consultant under contract by March or April 2021.

#### ITEM 6. Subcommittee Reports

- 1. Policy and Regulation Subcommittee-The committee discussed the development of the secondary safety performance measures benchmarks.
- 2. *Impaired Action Plan Subcommittee*-The committee is still formulating ideas for the implementation plan. Discussion continued regarding ways to report additional data sets such as arrests and convictions to see how they compare.

# **ITEM 7. Regional Safety Performance Measures** (Stephan Gage)

The committee was briefed on the proposed benchmarks for the secondary safety performance measures. Discussion ensued regarding how the benchmarks were developed and how they should be utilized. A motion was made and approved to adopt benchmarks and the methodology for calculating the benchmarks.

## ITEM 8. Congestion Management Process Update (Stephan Gage)

Staff informed the committee that the regional congestion management process was being reviewed and updated. Staff further informed the committee that the previous adopted definitions for "Safety Issue" and "Bottleneck" would need to be revised. A motion was made and approved to endorse the update of the congestion management process.

# ITEM 9. Federal Safety Performance Measures Methodology & Targets

Staff informed the committee this year the state changed their methodology for setting they safety performance measure targets. Staff reminded the committee that safety performance measure targets must be submitted annually, and that TPC agreed by resolution to support the state's efforts to achieve its targets. Because of this, regional targets have been set based on 5-year rolling averages to be aligned with the state. A motion was made and approved to adopt the new methodology for calculating safety performance measure targets.

ITEM 10. Other Matters/ Member Updates (Stephan Gage)

- TxDOT informed the committee that it will continue and expand its agreement with Lyft to provide ride vouchers during the holidays. Additional information is posted on the Lyft website.
