

11A. FUTURE AMENDMENTS TO THE 2025-2028 TRANSPORTATION IMPROVEMENT PROGRAM
AND THE 2045 REGIONAL TRANSPORTATION PLAN

BACKGROUND

The 2025-2028 Transportation Improvement Program (TIP) is a four-year capital improvements program for transportation projects. Under federal rules, all federally assisted projects must be included in the TIP to be eligible for funding. In addition, federal rules require that regionally significant local projects must also be included in the TIP.

The 2045 Regional Transportation Plan (RTP) is a long-range plan that prioritizes spending on regional transportation projects including short and long-range strategies to ensure the transportation network is safe and efficient. Updated every four years, the RTP outlines a fiscally constrained transportation investment program that is based on the unique needs and characteristics of the Metropolitan Planning Area.

Amendments to the TIP and RTP are brought to the Transportation Policy Council for consideration monthly and amended in accordance with the Metropolitan Planning Organization's Public Participation Plan.

CURRENT SITUATION

A summary of the proposed revisions to the 2025-2028 Transportation Improvement Program is included below.

- Delay ten TxDOT Houston District construction projects on various roadways (MPO IDs 209, 282, 290, 13864, 17221, 17233, 18048, 18156, 18516, 18721) to FYs 2029-2033 of the Ten-Year Plan to match the FY 2026 TxDOT Unified Transportation Program (UTP) which was approved by the Texas Transportation Commission on August 21, 2025.
- Delay eight TxDOT Houston District construction projects on various roadways (MPO IDs 965, 7564, 14249, 17224, 18402, 18514, 19023, 19024) to FY 2028 of the TIP and FYs 2029-2030 of the Ten-Year Plan due to statewide level letting.
- Delay the City of Pearland's Mykawa Road widening (MPO ID 17082) to FY 2029 the Ten-Year Plan due to TxDOT's statewide level letting.
- Delay METRO's Inner Katy Corridor bus rapid transit construction (MPO ID 18405) to FY 2033 of the Ten-Year Plan due to TxDOT's statewide level letting.
- Delay Lake Houston Redevelopment Authority's Northpark Drive construction (MPO ID 18033) to FY 2029 of the Ten-Year Plan due to TxDOT's statewide level letting.
- Delay the City of League City's Landing Boulevard widening and reconstruction (MPO ID 17080) to FY 2029 in the Ten-Year Plan due to TxDOT's statewide level letting. Add \$2.3M of federal/local Surface Transportation Block Grant (STBG) funds, split 80/20, to cover the unforeseeable requirement to relocate a utility tower.

- Delay eighteen TxDOT Houston District Right-of-Way acquisition projects on various roadways (MPO IDs 18977, 18978, 18979, 18980, 18981, 18982, 18983, 18984, 18985, 18986, 18988, 18989, 18994, 18995, 18996, 18997, 18998, 18999) to FY 2028 of the TIP and FYs 2029-2035 of the Ten-Year Plan due to Right-of-Way Program budget constraints.
- Add engineering as an authorized phase of work to TxDOT Beaumont District's FM 565 widening project (MPO ID 17113) with an additional \$4.3M of federal/state Category 2 Metropolitan Mobility funding and delay it to FY 2027 at the District's request.
- Add \$1.3M of federal/state Congestion Mitigation/Air Quality (CMAQ) funding to TxDOT Beaumont District's FY 2023 SH 105 widening project and turn bay project (MPO ID 18031) to cover increased construction engineering costs caused by site conditions.
- Add \$3.5M of federal/state CMAQ funding to TxDOT Beaumont District's FY 2025 US 90 grade separation construction at the UP railroad (MPO ID 18036) to cover increased construction engineering costs caused by site conditions.
- Add \$2.5M of federal Surface Transportation Block Grant (STBG) funding to Chambers County's CR 486 reconstruction project (MPO ID 19078) to cover increased cost estimates caused by the inflation of labor and materials. Add 550K Transportation Development Credits (TDCs) in lieu of matching funds.
- Delay the City of Tomball's FM 2920 reconstruction (MPO ID 17085) to FY 2029 the Ten-Year Plan per the agreement between the City and TxDOT Houston District and update the description of work.
- Delay four of METRO's capital construction and system implementation projects (MPO IDs 18260, 18761, 18762, 18846), from FY 2025 to FY 2026 at METRO's request.
- Program four City of Galveston/Island Transit FFY 2024 and 2025 apportionments of Federal Transit Administration Section 5337, State of Good Repair Program, in FYs 2026-2028 with local matching funds (MPO IDs 19546, 19547, 19548, 19549).
- Program the City of Mont Belvieu's Eagle Drive reconstruction and widening engineering phase (MPO ID 18061) with \$4.5M of federal/local STBG funding in FY 2027 in preparation for the construction phase (MPO ID 19410) in FY 2030.

Mr. Papsdorf:

The City of League City is currently in the Final Engineering phase for the federally funded Extension of Landing Blvd from FM 518 to NASA 1 Bypass. Current federal funding is for the construction phase. The project reached the 100% design milestone in December 2022. Since that time, City has been busy with the acquisition of 18 parcels and associated relocations and utility and pipeline relocations. As of now the City has spent approximately \$27.73 million on design, ROW acquisitions, relocation of tenants and businesses at the U-Haul taking, and relocation of 3 pipelines, none of which are federally funded. The City had to reprioritize CIP and bond projects to be able to accomplish this. This has been a major expenditure of City funds.

One of the utility relocations which has not been completed involves a CenterPoint Energy – Electric (CNP) transmission tower located south of the Clear Creek (see attached map). Throughout the Final Engineering phase, the City coordinated with CNP at the 30%, 60% and 90% milestones to identify any potential utility conflicts with proposed improvements. The proposed roadway design provides approximately 11.5-foot clearance from the face of a MSE wall at the proposed bridge over the Clear Creek to the base of an existing CNP transmission tower. The initial assessment of CNP dating back to July 22, 2021, was that “there won’t be a clearance issue to the bridge.” However, during the final phase of utility coordination to receive Letter of No Objections after completion of plans, CNP informed the City in April 2024, that a minimum 25-foot clearance is required around the transmission tower. Attempts to receive a Variance were not accepted due to CNP’s standard clearance requirement on major transmission towers. With the alignment set and right-of-way acquisition nearly complete, the only option to resolve the conflict was the relocation of the transmission tower.

In June 2024, the City entered into a \$250,000 reimbursement agreement with CNP for an Engineering Feasibility Study, which would determine the cost of this relocation, identify additional property CNP needs, construction timeframe, and other matters. A draft engineering plan submitted in early 2025 put the cost at over \$8M based on relocation of 3 towers. However, this engineering plan and cost was further scrutinized and studied which brought the relocation down to only 1 transmission tower at an estimated cost of \$2,266,458. CNP subsequently provided a Utility Relocation Agreement which has a schedule of early 2027 to start construction and completion of mid 2027. In order not to cause further delay, City staff is planning to take this Agreement before Council on August 12, 2025, for consideration of approval.

Currently, the estimated construction cost of the project is around \$65M which will increase since TxDOT is not planning to Let the project until this relocation is resolved. The current federal funding is \$42.8M. City is working with HGAC on a Regional Strategic Transportation Fund Agreement to help with the \$21M local share of this project. With what is stated above, the actual estimated local share currently stands at nearly \$51M.

This unexpected utility relocation cost on top of what the City has already spent to get to this point has caused a major financial strain on the City. The City is seeking additional financial support that HGAC may have toward this specific utility relocation cost or the overall ROW acquisition & utility relocation cost.
