## Call to Order/Welcome/Introductions

Mr. Steven Johnston of H-GAC welcomed all in attendance. Mr. Johnston provided instructions for features of the virtual meeting platform, Zoom. Mr. Johnston then proceeded to review the agenda with members of the BIG. Mr. Johnston asked if there were any changes or additions by BIG members. Hearing no requests for changes and no call for discussion, the meeting proceeded.

## **Certification of Quorum**

Mr. Johnston called roll. Based on the number of BIG members and alternates in attendance, a quorum was certified.

All changes to member and alternate nominees were approved unanimously by the members present.

# Approval of the May 25, 2021, Meeting Summary

BIG members unanimously approved the May 25, 2021 meeting summary without corrections.

## **Public Comment**

No public comments were made.

# **Item One: I-Plan Revision Update**

Mr. Johnston, H-GAC, provided an update on revising the BIG Implementation Plan. The topic included a review of actions and activities taken so far to revise the I-plan. This included presenting changes to individual action areas contained in the plan.

Mr. Johnston stated that the updated maps and data tables that would be included in the revision would focus on 2013 thru 2020 period. When and where possible, data comparisons will be made between the beginning implementation year, 2013, with that of 2020. The data and analysis will also look at AU and Segment level. The goal is to get the programmatic data analysis down to the AU level where the environmental analysis is generated. This will allow a more granular look at the data.

Mr. Johnston reviewed the upcoming timeline which focuses delivering a draft copy to the BIG for review in November. The group will then review the document, providing comments via email through January 2022. The Coordination and Policy work group would then be convened to review any comments and substantial changes. Following agreement should the document be ready to approve, the BIG would be invited via video conference to review the final version for approval.

## Item Two: 2021 Annual Report Update

Mr. Johnston provided an update on the draft 2021 Annual Report. Current Success Stories include:

City of Houston Green Stormwater Program,

- Watershed Protection Plans,
- Targeted Monitoring Projects, and
- Exploration Green.

Mr. Johnston reviewed the timeline with the BIG. He said it would follow a similar timeline with that of Item 1. Mr. Johnston reviewed the upcoming timeline which focuses delivering a draft copy to the BIG for review in November. The group will then review the document, providing comments via email through January 2022. The Coordination and Policy work group would then be convened to review any comments and substantial changes. Following agreement should the document be ready to approve, the BIG would be invited via video conference to review the final version for approval.

## **Item Three: TMDL Program Updates**

Mr. Johnston with H-GAC provided the TMDL updates to the BIG. Mr. Johnston noted that the Texas Institute for Applied Environmental Research at Tarleton State University completed the Technical Support Document for Caney Creek (AU1010\_3). The document was submitted to the TCEQ and is under peer review. Once approved, the TMDL addendum will be place in a future Water Quality Management Plan which is submitted to the US EPA for approval. A new project will be undertaken in FY22 for White Oak Creek (AU1004J\_01). A presentation will likely be given by the University in May.

Mr. Johnston then run down the status of five TMDLs that are situated outside of the BIG project area: Cotton Bayou, Caney Creek, Big Creek, Oyster Creek, and Chocolate Bayou. While work on the TMDLs were under way in each watershed, it was noted that the TMDL for Caney Creek was adopted by the TCEQ.

## Item Four: Implementation Project Presentations (PDF versions available via H-GAC.com)

Ms. Rachel Windham and Justin Bower, planners for H-GAC, presented on the status of watershed protection plans (WPPs) in the BIG Project Area. The BIG project area is unique in its size and the WPPs present an opportunity to establish planning groups within smaller portions of the area. Mr. Bower stated that the West Fork WPP was completed and is in the implementation stage. H-GAC is looking for funding to implement the plan. Many of H-GACs ongoing programs like the OSSF SEP assist with this effort. Mr. Bower noted that the Cypress Creek WPP was recently approved and will be shifting into the implementation phase. The Spring Creek WPP is in development, according to Ms. Windham. She noted that data analysis and modeling has been completed. Stakeholders in the watershed are meeting to determine the management measures for the watershed, a key component of the final plan. They wrapped up there presentation stating that the Clear Creek WPP is just getting underway as the Quality Assurance Project Plan is being reviewed by TCEQ. Finally it was noted that there will be a new WPP effort for the East Fork of the San Jacinto River as H-GAC just received funding for that project.

## **Item Five: Other Business/Roundtable**

H-GAC provided a slide on upcoming meetings and workshops. Mr. Johnston encouraged attendees to add to the list of upcoming events.
