ITEM 7. PROJECT SELECTION PROCESS, ADAM BECKOM, H-GAC

Mr. Adam Beckom, H-GAC, updated the Council on the Project Selection Process. Mr. Beckom told the Council that sponsors submitted additional scoring information for the Regional Goods Movement evaluation. Online questionnaire closed on May 15, 2023. 15 sponsors submitted 88 projects with cost of \$11.8B. 64 projects with cost of \$2.35B will be scored for Regional Goods Movement Criteria. 24 projects with cost greater than \$100M will be scored for major investment criteria. Staff will start asking for Benefit -Cost and project readiness information in June/July. Mr. Beckom described funding instruction alternatives, investments categories, and next steps. Comments, questions and discussion occurred among members of the Council and H-GAC staff after the presentation.
