We need street arrows painted at Walnut Bend and Westheimer. (North and South sides of Westheimer). When going North towards Westhiemer, drivers don't know if they're supposed to be in the right or left lane to turn left (West) on Westhiemer. There is always a hestitant "dance" between drivers to see where the others are going. It's dangerous. Now that so much construction is happening in our area, Blue Willow has a TON of traffic. They speed through the neighborhood. The problem does not just occur from cars, but from HUGE delivery trucks, construction vehicles, etc. I have never understood why Walnut Bend Lane has speed bumps and Blue Willow does not. WE ARE THE STREET THAT EVERYONE USES TO CUT THROUGH TO THE WESTCHASE DISTRICT! Please, please budget for us to get those rubberized speed bumps installed at Blue Willow! (You do know that when the city topcoated our streets they didn't touch the existing speed bumps in the area. No asphalt/no paint. They were left as they were found). I think the city wasted some valuable money doing these streets. They looked just fine when the old, cracked asphalt was removed. In fact, the drains worked better. Out neighborhood is prone to flooding, and it gained us at least 2" of rain without the asphalt. Oh well - water under the bridge (or in my gargage) at this point. Walnut Bend/Westheimer = Street arrows Blue Willow Lande = rubberized speed bumps.
