Dear General Weber:

We have reviewed the documentation supporting the transportation conformity determination for the Houston-Galveston Area Council's (H-GAC) 2040 Regional Transportation Plan (RTP), adopted by the H-GAC's Transportation Policy Council on January 23, 2015. Based upon our review and consultation with the U.S. Environmental Protection Agency (EPA), the Texas Commission on Environmental Quality (TCEQ), and the Texas Department of Transportation (TxDOT), we hereby find the 2040 RTP to meet all the requirements for making a joint conformity determination under the Clean Air Act Amendments of 1990, subject to the enclosed comments.

In accordance with 23 Code of Federal Regulations (CFR) 450.322 (a), this conformity determination establishes the effective date of H-GAC's 2040 RTP and addresses the requirement in 23 CFR 450.322 (c) that the metropolitan transportation plan (MTP) be updated at least every four-years. This action also relieves the Houston-Galveston-Brazoria non-attainment area of the transportation conformity lapse grace period initiated on January 25, 2015. Additionally, this action restarts the four-year update cycle associated with the update of H-GAC's 2040 RTP. As such, a MTP update and corresponding conformity determination must be completed by September 11, 2019.

The interagency consultative partners have indicated that they have no unresolved issues concerning this conformity determination in their letters dated September 9, 2015 for EPA, September 11, 2015 for TxDOT, and September 10, 2015 for TCEQ. The conformity determination and procedures used to make this determination are in accordance with the provisions of the transportation conformity rule (40 CFR Parts 51 and 93), dated August 15, 1997, as amended.

The Federal Highway Administration (FHWA) acts as executive agent for the Federal Transit Administration (FTA) on MTP and TIP air quality conformity determinations. Accordingly, this letter will serve as the joint FHWA/FTA conformity determination. Should you have any questions concerning this action, please contact Jose M. Campos at (512) 536-5932 or Barbara C.
