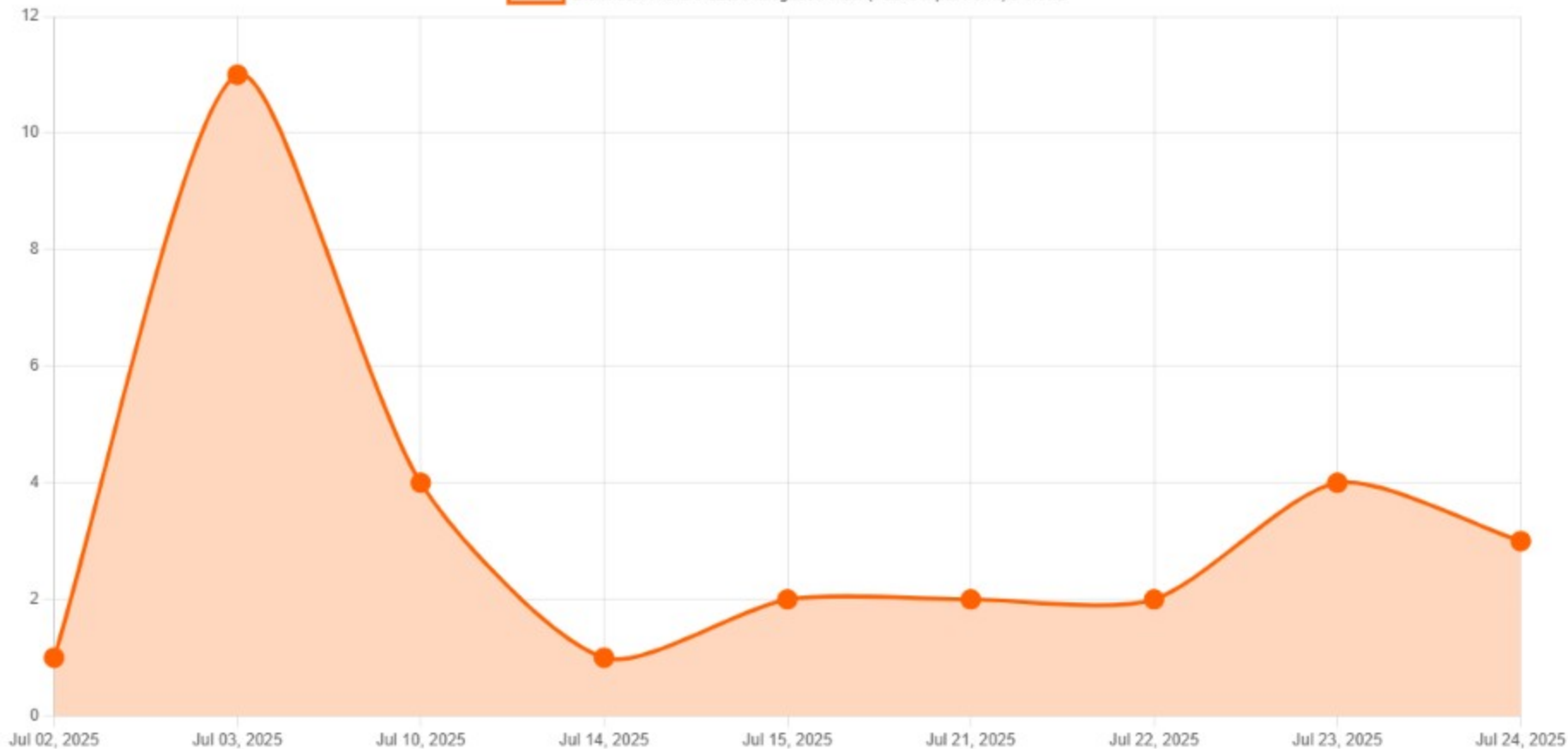
Next Steps
