## **GDW Meeting Summary for June 3, 2020**

2020 Infogroup Data Cost-Share Wrap-Up: H-GAC wrapped-up this cost-share project by making the 2020 Infogroup Business and Residential datasets available for download starting on May 22<sup>nd</sup> to those cost-share participants with a paid invoice. To date 6 of the 14 participants have received and encrypted email with download instructions for the new data. The 2020 data consists of one residential dataset totaling over 6 million records and four business datasets totaling over 1.4 million records. Both the business and residential data come in SAS, DBF, FGDB feature class, and Shapefile formats. 2020 Aerial Imagery Cost-Share Update: H-GAC kicked off the user QC and inspection phase of the 2020 Aerial Imagery Cost-Share project on May 12<sup>th</sup> using the vendor provided QC tool known as SurCheck. To date, the 6 Inch inspection area is 45% complete and the 1 Foot inspection area is 59% complete. The original deadline set for completion of both inspection areas was Friday, June 12<sup>th</sup> but with just over a week left until then, that deadline will likely be pushed back by at least one additional week; details pending. After both inspection areas have been completed, H-GAC will send out invoices to all cost-share participants and look to receive the final, QC revised data from vendor Surdex in mid to late July for final disbursement shortly thereafter.
