## **RAILROAD COMMISSION OF TEXAS APPLICATION FOR MULTIPURPOSE GRANTS**

### **Background**

H-GAC staff regularly reviews grant applications and project proposals for conformance with regional planning goals and objectives, including those defined in the current H-GAC Board-accepted Water Quality Management Plan. H-GAC recently performed an intergovernmental review of a Multipurpose Grant to States and Tribes application submitted to the U.S. Environmental Protection Agency by the Texas Railroad Commission. The proposed project is entitled “Digitize Railroad Commission Permits Related to Underground Injection Control Activities.”

### **Current Situation**

The Railroad Commission is seeking funding to continue the development of a complete digital record series for the Class II Underground Injection Control program in order to improve the efficiency and effectiveness of the program. The proposed project includes the digitization (both historic and day-forward) for the following records:

- Brine mining permits
- Storage caverns permits
- Mechanical Integrity Test reports
- Sonar reports

The digitization of the Railroad Commission’s injection well permit applications will allow for greater access to the information than is presently available without an electronic database of these records. The maintenance of these records in a digital format allows for greater access to the data by affected stakeholders and the general public. Due to H-GAC’s role in developing watershed-based plans such as Watershed Protection Plans and Total Maximum Daily Loads, the agency would benefit from having this data in a readily available and accessible format. This project is in conformance with H-GAC’s Regional Water Quality Management Plan goals and objectives, including the acquisition, analyses, and dissemination of regional water quality data that are used throughout the agency’s planning activities.
