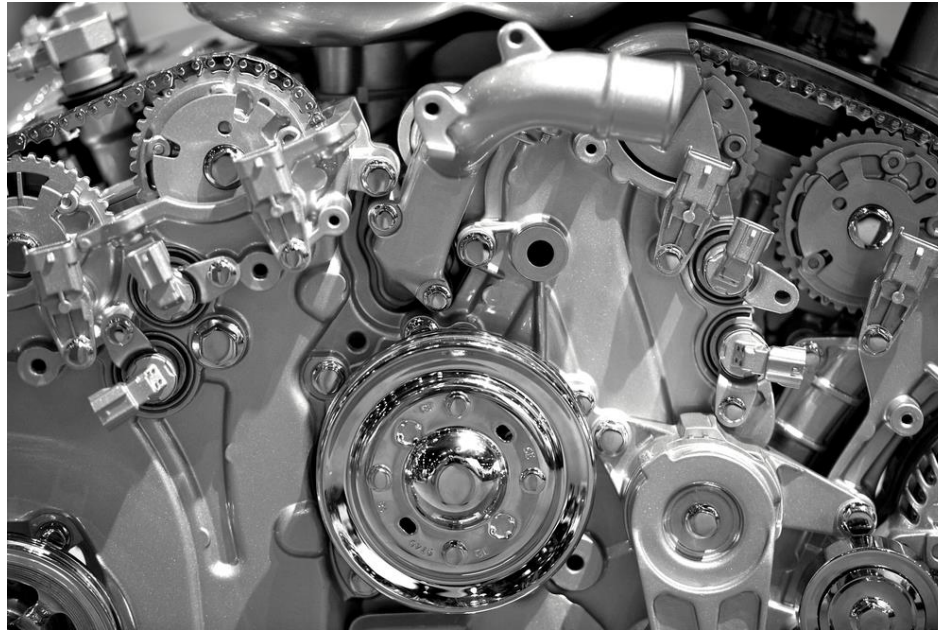




Downtown Revitalization-Economic Engine

2015 Downtown “Inventory” of Lots & Buildings

25 Vacant Lots and/or Buildings comprising 16.856 acres.

734,225 square feet of commercial property just within
a 1-mile stretch of Friendswood Drive.

This inventory was generating just \$21,403.53 in
property tax revenue for the City of Friendswood.

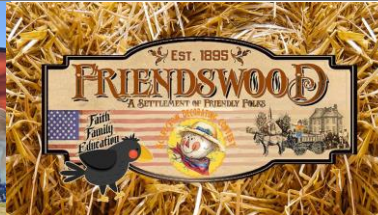
New Construction since 2015

As of 2019, over \$ 7.5 million has been added in taxable value, with another \$32 Million on-line by 2021; adding over \$215,000 in revenue to the City.
