Thank you for the opportunity to review the conformity determination and associated transportation plans for the Houston-Galveston-Brazoria (HGB) nonattainment area. We are satisfied all requirements have been met, as discussed below.

The HGB area is designated nonattainment for ozone. In order for the area to demonstrate transportation conformity, the area must show that regional emissions produced by the 2006-2008 Transportation Improvement Program and the 2025 Regional Transportation Plan meet the transportation conformity requirements in the federal rule, Title 40 Code of Federal Regulations Part 93, as revised July 1, 2004.

The Texas Commission on Environmental Quality (TCEQ) air quality planning and technical staff reviewed the documents and identified issues needing clarification and revision. In addition, issues were identified by other reviewers.
