### 2025-2028 TIP Amendments

- Remove all Categories 2 and 4 funding from TxDOT HOU's IH 69 S reconstruction and widening (MPO ID 155), add \$234M of state Category 12 'Clear Lanes' funds, and delay it to FY 2028 to match the FY 2026 UTP.
- Remove all Categories 2 and 4 funding from TxDOT HOU's SH 35 frontage road construction (MPO ID 210) and add \$50M of federal/state Category 12 'Strategic Priority' funds to match the FY 2026 UTP.
- Delay TxDOT HOU's FM 523 reconstruction and widening (MPO ID 512) to FY 2030 due to the District's 'Budget Leveling' process.



### 2025-2028 TIP Amendments

- Remove all Category 2 funding from TxDOT HOU's SH 332 widening (MPO ID 525) and delay it from FY 2028 to FY 2037 to match the FY 2026 UTP.
- Remove all Category-4 funding and adjust the amounts of Category-2 and Category-12 'Strategic Priority' funds of TxDOT HOU's IH 10 W reconstruction and widening (MPO ID 10334) to match the FY 2026 UTP.
- Add \$30M of federal/state Category-4 funding to TxDOT HOU's IH 10 reconstruction (MPO ID 19025) to match the FY 2026 UTP.




### 2025-2028 TIP Amendments

- Add \$23.2M of federal/state Category 4 funding to TxDOT HOU's IH 10 realignment and reconstruction (MPO ID 19026) to match the FY 2026 UTP.
- Program the NCTCOG's construction and operation of a hydrogen refueling station for heavy duty trucks in FY 2027 (MPO ID 19555) on IH-10 W in Brookshire, Texas with \$13.0M of federal Category-10 (USDOT Discretionary Grant) and matching funds from Pilot Travel Centers, LLC.





- State requirement (not federally mandated)






## 10-Year Plan

  - Locally funded projects
- All funding commitments to Project Selection Process projects are included in the 10-Year Plan.



### **TASA Call for Projects**



- H-GAC begins initial steps to Transportation Alternatives
   Set-Aside (TASA) Call for Projects
- Accepting Statements of Project Interest through mid-December
- Questionnaire with Active Transportation scoring criteria to open in January
- Estimated TAC/TPC vote to approve ranked project list in August 2026




### **Project Selection Process**



- Approved by TPC in January 2023
- Active Transportation is one of eight investment categories
  - 2023: Regional Goods Movement
  - 2024: Major Projects, High Growth Area Needs, Operations Improvements, Resiliency, Transit
  - TBD: Safety
- Sponsor submission requirements
  - Statement of Project Interest (emailed to H-GAC staff)
  - Questionnaire based on investment category criteria (online portal; TASA falls under Active Transportation investment category)
  - Benefit-Cost information
  - Readiness survey



### **TASA Eligibility**



Projects must be within H-GAC's 8-county MPO planning area: Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, Waller counties





# **Project Monitoring**



### **Quarterly Monitoring**

 Over the past three years, H-GAC has held quarterly meetings with local sponsors to monitor key project development milestones.

### **Observed Challenges**

- Recurring project delays and missed milestones.
- High carryover balances in federal funding categories (CMAQ & STBG).
- Many projects rolled into future years without advancement.



# **Policy Direction & Response**

### **TPC Direction (February 2025)**

The Transportation Policy Council (TPC) directed H-GAC, through the TIP Subcommittee and Transportation Advisory Committee (TAC), to develop policy solutions to strengthen accountability and improve delivery forecasting.

### **Policy Response**

- The Project Development Milestone Policy Workgroup was established to:
  - Create a framework for timely project delivery.
  - Ensure efficient use of federal funds.
  - Enable consistent milestone tracking for all TIP and 10-Year Plan projects.



# Policy Objectives/Outcomes



- Establish clear milestones and expectations for all TIP and 10-Year Plan projects, improving accountability and delivery
- Improve coordination and communication between H-GAC, TxDOT, and project sponsors.
- Enhance project monitoring and reporting through consistent data and performance tracking.
- Identify delivery risks early and provide guidance to prevent project delays.
- Support efficient programming and reduce unspent federal carryover balances.





# Workgroup Status - Consensus to Draft

Guiding principles for the Project Development Milestone Policy:

- Accountability: Sponsors must ensure projects progress toward implementation consistent with programmed funding timelines.
- Project Variability: Recognize that projects differ in complexity, scope, and external constraints.
- Common Framework: Establish a standardized approach to evaluate project development/delivery progress and assess overall TIP program health.
- Policy Alignment: Build upon existing policies (e.g., Cost Overrun Policy) and best practices to form a strong policy foundation.

#### **Current Status:**

- A draft Project Development Milestone Policy has been developed and reviewed by both the Workgroup and the TIP Subcommittee.
- A draft Risk Register has also been created and is expected to be finalized in November.



# Policy Framework



- Assessment of Existing Projects:
  - 1. Baseline Schedule aligned with programmed funding
  - Risk register identifies uncertainty requiring proper management
- Quarterly meetings to confirm progress, identify potential issues ("Caution List")
- Timely action recommendation to adjust program where issues unresolved ("Action List")
- Establish "readiness thresholds" for programming construction funding

Project Development and Delivery Milestone Policy

#### 1. Purpose and Objective

Federal regulations require Regional Transportation Plans (RTPs), Transportation Improvement Programs (TIPs), and Statewide Transportation Improvement Programs (STIPs) to be fiscally constrained, meaning they must demonstrate that projects can be implemented with committed or reasonably available funding. Since passage of the Intermodal Surface Transportation Efficiency Act (ISTEA) in 1991, fiscal constraint has been central to transportation planning and is met through financial plans prepared under FTA/FHWA regulations (23 CFR 450). Each Metropolitan Planning Organization (MPO), in cooperation with the state and transit providers, must develop a fiscally constrained TIP covering at least four years that includes all federally funded and regionally significant projects, as well as applicable non-federally funded projects, ensuring alignment with the RTP.

The Project Development and Delivery Milestone Policy's purpose is to ensure efficient utilization of the MPO's fiscally constraint funding to achieve federal, state, and local transportation priorities by establishing a transparent and accountable process for programming of funds by phase of work. The establishment of key milestone decision points for project programming by phase will help to ensure on-time project development and delivery.

This policy provides a framework for identifying, monitoring, and addressing project schedule and other risk-related issues in the delivery of programmed projects, with the goals of:

- Ensuring programmed projects in the fiscally constrained Transportation Improvement Program (TIP) and 10-year plan are reviewed periodically to confirm timely delivery.
- Identifying project risks early to avoid high carryover balances.
- · Mitigate risk to keep projects moving forward and on schedule.






## **Baseline Schedules**



- The original, approved project timeline that defines planned start and finish dates for all activities, milestones, and deliverables.
- Serves as a fixed reference point to measure progress and performance throughout the project lifecycle.
- Ensures accountability and visibility into schedule adherence and delays





# Risk Management



Deliver TPC-approved project portfolio on time and within available resources




Align project programming with funding readiness



Identify and mitigate risks early to make informed decisions. Because risks evolve over time, risks need to be evaluated/adjusted during project lifecycle



## Risk Assessment Categories



### **Key Risk Categories:**

- Project <u>Scope</u>:
   Clarity of project scope, progress in planning and design maturity, and potential scope changes.
- <u>Process</u> Certainty:
   Readiness of environmental reviews, permits, right-of-way (ROW), utilities, and programming (TIP/STIP, conformity).
- <u>Resource</u> Availability:
   Adequacy of funding, staffing levels, and procurement readiness.



# **Overall Summary**



The Project Development Milestone Policy establishes a structured, transparent framework to guide project sponsors and staff through key development stages.

- Enhances project readiness and delivery timelines.
- Promotes consistent milestone tracking and risk management.
- Builds trust in TIP programming through improved accountability and performance.



## TAC Recommendation Highlights

- Committee name change: "Transportation Advisory Committee" to "Technical Advisory Committee"
- Membership categories revised to define appointing entities where possible (indefinite terms); at-large positions approved by TPC (2year terms)
- Officer positions remain the same; officer vacancies are filled by remaining officers
- Meeting requirements clarified to provide notice and agenda 7 days prior and meeting packet 3 days prior to meeting date.



## TAC Recommendation Highlights

- Ethics section added to mirror Transportation Policy Council Ethics Policy
- Standing, ad hoc, or workgroup subcommittees may be established by TAC or MPO Director; chair/vice chair must be TAC member; membership recommended by TAC Nominating Committee/approved by TAC.
- Clarified that amendments to TAC Bylaws may be made independently by the Transportation Policy Council with a twothirds majority vote.



## Changes Since September

- Smaller Cities: number of positions reduced from 8 to 3
- Montgomery County Toll Road Authority and Fort Bend County Toll Road Authority positions removed; Regional Toll Road Authority position added
- Active Transportation position removed

#### Future 2025-2028 TIP Amendments

- Program installation of four TxDOT HOU electric vehicle direct current charging ports (MPOs ID 19551, 19552, 19553, 19554) along the Electric Alternatives Fuel Corridor (IH 10, IH 45) in Baytown, Houston, Spring and League City in FY 2026. \$3.0M of federal National Electric Vehicle Infrastructure Formula Program funds (Category-10) with state matching funds. Includes five years of operation and maintenance.
- Update description of METRO's Fannin South Transit Center reconstruction (MPO ID 18372), add \$17.7M of local funding, and delay from FY 2026 to FY 2027 at METRO's request.




#### Future 2025-2028 TIP Amendments

• Add ~2,600 TDCs to two Gulf Coast Transit District FTA Section 5307 (Urban Area formula) planning and operating projects (MPO IDs 19144, 19146) to account for the different matching requirements between the two project types.
