




Texas Clean Rivers Program

- H-GAC is one of 12 regional authorities that partner with TCEQ to administer the CRP
- 4 river basins and coastal waters
- 15 counties
- 6 regional partner organizations
- Program Objectives:
 - Provide data for decision-making
 - Identify and evaluate water quality issues
 - Promote cooperative watershed planning
 - Recommend management strategies
 - Inform and engage stakeholders
 - Maintain efficient use of public funds



H-GAC's Water Resources Information Map (WRIM)



- H-GAC and partners monitor
 319 sites for CRP.
 - Monthly to Quarterly
 - Quality Assured Data
 - Routine Monitoring
 - Data to SWQMIS and WRIM





Background

- Central Texas Floods July 2025
- Upper Guadalupe River Authority reached out for recommendations
- State-wide CRP authority meeting to discuss post-flood water quality monitoring plans
- H-GAC region is unique



Post-Flood Water Quality Monitoring Discussion

- Objectives:
 - Public Health: Evaluate risks to public health from contact with floodwaters.
 - Environmental Impact: Assess short-term and long-term impacts of floods on aquatic ecosystems.
 - Regulatory Compliance: Monitor water quality against established standards and respond to point-sources of concern.
- Is there a need/interest?

Active calls and public input opportunities

Flood Priority Research ideas: The Texas Water Development Board (TWDB) is soliciting ideas for research on topics of priority regarding flooding in Texas. The intent of this solicitation is to provide stakeholders with the opportunity to suggest potential project ideas. Proposed research ideas may be for new projects that support flood planning or flood science, or they may be ideas that build upon previous flood research projects conducted by the TWDB. Funding Updates

- The Texas General Land Office announced a last call for applications to its Local Hazard Mitigation Plans Program (grants \$20,000–\$100,000) and Resilient Communities Program (up to \$300,000), both funded by HUD CDBG-MIT. Applications are first-come, first-served and must be submitted by 11:59 p.m. CST on Dec 31, 2025; eligibility requires being in HUD CDBG-MIT designated areas, meeting FEMA's local government definition, and (for RCP) having authority to enforce building codes.
- H-GAC Funding Development Program Launched: A new initiative designed to provide direct grant technical assistance to help member governments successfully identify, plan, write, and apply for competitive funding opportunities. In addition to one-on-one assistance, the program offers specialized expertise, training, education, and resources to strengthen local grant capacity. The Funding Development Program partners closely with communities to maximize funding opportunities that advance regional priorities. The first application round is open now and will close on Friday, November 21, 2025, at 7:00 p.m. For more information: https://www.h-gac.com/funding-development

Legislative updates

 Nov. 2025 statewide ballot – Proposition 4 (Texas Water Fund): Would dedicate up to \$1B/year (no new taxes) for 20 years to water infrastructure, including flood control and mitigation.
