1. CALL TO ORDER

Acting Chairman, Commissioner Adams, called the meeting of the Board of Managers to order at 11:08 a.m. on Tuesday, January 17, 2023. The meeting was held Hybrid on Zoom and in person at 3555 Timmons Lane, 2nd floor Conference Room B.

a. Roll Call of Board Members

Ms. Kim Ward called out the Board member roster to certify that there was a quorum. Acting Chairman Adams acknowledged a quorum with six of the eight board members present and presided throughout the meeting.

b. Public Comments

There were no public comments.

ACTION ITEMS

ITEM 2. Consent Agenda

Acting Chairman Adams stated that this is the first meeting to consolidate a list of items that are of routine in nature and may be acted on in a single motion unless requested otherwise by a member of the Board. This is similar to the H-GAC Board of Director's meeting, as a Consent Agenda. Acting Chairman Adams asked for any corrections, additions, or deletions to the Meeting Minutes for November 15, 2022 and to approve routine operations of the Geospatial Software License Renewal. There were no corrections to the Meeting Minutes.

Judge Spenrath made a Motion to approve and Judge Duhon seconded the Motion. The Board of Managers voted and approved all Consent Agenda items.

ITEM 3. Financial Report

Mrs. Jean Mahood presented the Balance Sheet for the month of December for her first report. The total cash for the 911 District as of December was \$7.6 million with a small grant receivable amount of \$14,364. The accounts payable to H-GAC was \$1,278,829 which gave a fund balance of \$6,375,390. Mrs. Mahood presented the Income Statement for the second report stating that the total revenue of \$4.2 million and total expenses around \$2.9 million gives the District a net income of \$1,338,737 as of December. Mrs. Mahood stated that this is a preliminary report which is based on the first closing of December. There might be changes as we continue to close fiscal year 2022.

Acting Chairman Adams asked for a Motion to approve the December 2022 Financial Report. Judge Duhon made a Motion to approve and Judge Spenrath seconded the Motion. The Board of Managers voted and approved the December 2022 Financial Report.

ITEM 4. Fiscal Year 2023 Strategic Plan and Budget

Ms. Kim Ward took a moment to welcome our two new Board members, Judge Bobby Seiferman and Commissioner Brandon Decker. She reported that back in December of 2022 the H-GAC Board of Director's approved a budget package for the agency which included the District's budget. However, Texas Health and Safety Code, Sub-Chapter H, requires the Board of Managers to approve the District's budget every fiscal year.

The first item Ms. Ward presented was the District's accomplishments in Fiscal Year 2022. The key accomplishments include maintenance of call handling equipment in 23 call centers, maintenance of the 911 database to 99% overall matching of Automatic Location Identification data to road data, improved the 911 data quality, provided high resolution Aerial Imagery, Location-based routing deployment by T-Mobile and AT&T, and completed assessment of 911 system and provided the findings and recommendations to the Board of Managers.

Ms. Ward presented a comparison from the 2022 to 2023 fiscal year budget. The biggest difference between the two is the grant fund that was awarded in fiscal year 2022 for the deployment of Next Generation services.

In addition to the routine services that the District provides, the fiscal year 2023 budget provides for language line translation services, maintenance of the call handling equipment, emergency medical dispatch resources for the call centers that participate, ongoing maintenance of location and mapping data, and improving data for call routing. This fiscal year will include publishing a Request For Proposal to start replacing call handling equipment. She anticipates bringing the results of the Request for Proposal to the Board in May.

Acting Chairman Adams asked for a Motion to approve the fiscal year 2023 plan and budget in the amount of \$5,174,722. Judge Duhon made a Motion to approve and Judge Spenrath seconded the Motion. The Board of Managers voted and approved the fiscal year 2023 plan and budget.

ITEM 5. Adoption of the 9-1-1 Service Fee

Ms. Kim Ward stated that as per the District's Statute the Board of Managers is required to adopt the 9-1-1 service fee of \$0.50 per month for each access line. Unless there is a legislative change, the amount for the wire line and VoIP landline will not change. Ms. Ward requested approval to adopt the 911 service fee of \$0.50 cents per access line to be imposed by the District in accordance with Chapter 772, Sub-Chapter H, of the Health and Safety Code, for fiscal year 2023.

Acting Chairman Adams asked for a Motion to approve the 911 Service Fee. Judge Spenrath made a Motion and Judge Duhon seconded the Motion. The Board of Managers voted and approved the adoption of the 911 service fee.

ITEM 6. Election of 2023 Chair and Vice Chair

Mr. Chuck Wemple asked for any nominations to elect for the position of Chairman and Vice-Chairman. Judge Duhon nominated Commissioner Adams to take the role of Chairman and Judge Spenrath as Vice-Chairman. There were no other nominations.

The Board of Managers voted and approved Brazoria County Commissioner Stacy Adams as Chairman and Wharton County Judge Phillip Spenrath Vice-Chairman.

INFORMATION ITEMS

ITEM 7. FY 2022 Geo-Spatial Database Status Report

Ms. Ward reminded the Board that she reported at the last Board meeting that Liberty County was in the process of getting their road name structure changed to meet the Next Generation 911 call routing requirements and the work continues in this report. Ms. Ward assured once the process and changes are made, the percentages for the county will go back up. As far as Waller County, it is the District's understanding that there is an annexation in progress. Once that is complete, the percentage will go back up. She answered questions pertaining to the report. No further action was taken.

ITEM 8. FY 2022 PSAP Call Statistics

Ms. Ward presented the call statistics report stating that our 911 calls for fiscal year 2022 total 311,181. She stated that this is a decrease of approximately 25,000 calls from 2021. The decrease in calls could result in no calls to 911 for non-emergency incidents. There was an increase in calls to the administration lines for non-emergencies and increase in text calls to 911. Ms. Ward expressed no concerns regarding the statistics as the public is educated that the 911 line is only for emergency-related incidents. No further action was taken on this report.

Chairman Adams adjourned the meeting at 11:30 a.m.

TEXT TO 911 CONTROL CENTER SERVICES CONTRACT EXTENSION

Background

In 2018 the GCRECD executed a contract with West Safety Solutions Corporation (now dba as Intrado Life and Safety Solutions, Corporation) for a three-year period to provide Text-to-911 Control Center Services. This service allows for the delivery of text calls to 911 to all 23 Public Safety Answering Points. The contract allowed for two one-year period extensions at same price and terms.

Current Situation

The contract will expire July 17, 2023. Staff is requesting to extend the contract with Intrado Life and Safety Solutions, Corporation, for a period of one-year same cost and terms.

NEXT GENERATION 9-1-1 EQUIPMENT AND SERVICES

Background

On June 30, 2022, the Gulf Coast Regional 9-1-1 Emergency Communications District (GCRECD) received a Next Generation 9-1-1 Federal Grant fund in the amount of \$3,777,763. The purpose of this grant is to support the District transition from legacy system to Next Generation 9-1-1 technology capable of interoperability to better serve the communities and improve emergency response times. The state had imposed a deadline on expending the funds as December 31, 2024.

Current Situation

On January 27, 2023, the GCRECD released a Request for Proposal (RFP) seeking qualified contractor for the following services:

- Provide and implement market-ready solutions for Next Generation 9-1-1 call handling equipment at the 23 Public Safety Answering Points (PSAPs)
- Implementation of a Next Generation 9-1-1 Emergency Services Internet Protocol network (ESInet) and Next Generation Core Services (NGCS)

Four proposals were received and evaluated by staff and the Assistant Director of the Walker County Public Safety Communications Center. The team assessed the submissions based on several criteria, including qualifications and experience, methodology and approach, past performance and references, and pricing. The top two vendors and their proposed technologies for the projects, ranked in order of preference, are as follows:

- 1. AT&T Services, Inc.
- 2. Motorola Solutions Connectivity, Inc.

The evaluation committee conducted a demonstration and interview from each vendor regarding their proposed solution and determined that the AT&T Services, Inc. is the best option based on several factors, among which are:

- 1. AT&T is currently the network provider for GCRECD, with existing infrastructure covering all eight counties. This means that there is no requirement to construct new infrastructure even if another provider is selected.
- 2. AT&T's Viper solution for replacing call handling equipment is the same system being used at the PSAPs today. This minimizes the need for extensive training and allows for smoother transition for 9-1-1 call center staff.
- 3. AT&T Viper solution offers language translation for text calls, while Motorola's plan to provide this service is not expected until 2024
- 4. Price. The cost breakdown for call handling and Next Generation network is as follows:

Legislative Update

HB 3290/SB 1858 – Next Generation 9-1-1 Service Fund

Representative Ryan Guillen (R-Rio Grande City) / Senator Kelly Hancock (R-N. Richland Hills)

- Allows for the transfer of any amount available from federal money provided to this state from the Coronavirus American Rescue Plan Act of 2021 (ARPA Funds) or from any other federal governmental source.
- The Comptroller is responsible for the distribution of the funds.
- Funds can only be used for the deployment and reliable operation of Next Generation 9-1-1 service, including the cost of equipment, operations, and administration.
- Allows for the transfer of money from any state governmental source.
- The Commission on State Emergency Communications is responsible for distribution of funds as it does today with wireless funds. The funding amount will be based on the population of the area served by the District.
- Funds from the Coronavirus American Rescue Plan Act of 2021 must be distributed by August 31, 2024.
- Extends deadline for funds to be spent from December 31, 2024, to December 31, 2026.
- Bill effective date September 1, 2023.

HB 9 – Development and Funding of Broadband and Telecommunications Services

Representative Trent Ashby (R-Lufkin)

- Creates the Texas Broadband Infrastructure Fund.
- Bill provides funding for Next Generation 9-1-1 Service Fund.
- Funding does increase from \$0.50 to \$0.85. For clarification, this addition covers the delta between the existing funding and proposed new funding.
- Funds will be distributed annually no later than September 15th of each year.
- Bill effective date January 1, 2024, if the constitutional amendment is passed.
- Funding for Next Generation 9-1-1 will expire September 1, 2035.

SB 838 – Relating to School Districts and Open-Enrollment Charter Schools Providing Silent Panic Alert Technology in Classrooms (Alyssa's Law)

- Creates requirement for each school district and open-enrollment charter schools to provide each classroom with silent panic alert technology that allows for immediate contact with district or school emergency services agencies, law enforcement agencies, health departments, and fire departments.
- Sent to Governor Abbott for Signature April 27, 2023.
- Bill effective date September 1, 2023.
- Schools have until 2024 2025 to implement.
