1. CALL TO ORDER

Board Chair, Brazoria County Commissioner Stacy Adams called the meeting to order at 11:07 a.m. on Tuesday, June18, 2024, in H-GAC's Conference Room D at 3555 Timmons Lane in Houston.

2. APPROVAL OF MINUTES FROM DECEMBER 19, 2023, MEETING

After a cursory overview of the December 19, 2023, minutes, Board Chair Adams called for approval of the minutes. Trustee Owens made a motion to approve the minutes. Council Member Branson seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval.

3. APPROVAL OF FINANCIAL STATEMENTS

Board Chair Adams called on Secretary/Treasurer Christina Ordonez-Campos to provide a financial report for the Corporation for Regional Excellence. Mrs. Ordonez-Campos presented the financial statement from 1/1/2024 to 05/31/2024. According to the balance sheet Mrs. Ordonez-Campos provided, the corporation had a healthy cash and investment balance of \$1,016,619. Ordonez-Campos discussed sponsored events such as Texas Municipal Sponsorship, Workforce, and Wells Fargo Water Quality initiatives. Ordonez-Campos emphasized the importance of having specific wording in the application to determine how excess funds will be handled and ensuring compliance with IRS regulations for our 501c3 status by accepting only approved projects. The treasure highlighted the need to remain in good standing with the IRS and expressed the importance of financial transparency and accountability within the organization. Council Member Branson moved to approve the financial statements. Council Member Arnold seconded the motion. Board Chair Adams called for a vote, which resulted in unanimous approval.

4. INTERNAL PROCESS

Staff member William Matthews provided an update on the internal process for the Corporation of Regional Excellence. He shared with the Board that an application has been created to share with any H-GAC members interested in utilizing the Corporation. Matthews went on to give an overview of the application, detailing its features and benefits. The Board expressed appreciation for Matthews' work on the application and commended him for his dedication to improving the internal processes of the Corporation. They discussed potential ways to promote the application.

5. MISCELLANEOUS BUSINESS

Board Chair Adams then called upon Mr. Wemple to discuss any other business. The President Wemple outlined various strategies that can be implemented to improve outreach and engagement with the community. He emphasized the importance of collaboration and communication among team members to achieve common goals and objectives. Wemple concluded his report by reiterating his appreciation for the dedication and commitment shown by the staff members and encouraged everyone to continue working towards the success of the Corporation for Regional Excellence.

There being no further business, Board Chair Adams adjourned the meeting at 11:39 a.m.

A RESOLUTION OF THE BOARD OF DIRECTORS OF **H-GAC CORPORATION FOR REGIONAL EXCELLENCE APPROVING A FISCAL SPONSORSHIP AGREEMENT** WITH THE CITY OF BELLAIRE, TEXAS

WHEREAS, H-GAC Corporation of Regional Excellence (the "Corporation") is a nonprofit corporation organized for charitable purposes pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"); and

WHEREAS, the Corporation's purposes include receiving contributions that support the programs and services of Houston-Galveston Area Council ("H-GAC") from entities that will only contribute to 501(c)(3) organizations; and

WHEREAS, the City of Bellaire, Texas (the "City") is a member of H-GAC which wishes to renovate Evergreen Park, a park owned by the City, to provide an all-inclusive playground open to children of all abilities and to provide recreational activities and open space for citizens of the City and others in the region (the "Project") and has asked the Corporation to act as its fiscal sponsor to collect contributions for the Project; and

WHEREAS, the Board of Directors of the Corporation (the "Board") has determined that the Corporation's participation in the Project as fiscal sponsor to the City in collecting contributions for the Project is in furtherance of its charitable purposes; and

WHEREAS, the Board has reviewed the terms of a Fiscal Sponsorship Agreement between the Corporation and the City relating to the Project (the "Agreement") and has determined that such terms are acceptable to the Corporation;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF H-GAC CORPORATION FOR REGIONAL EXCELLENCE THAT:

The Board hereby approves the Agreement in substantially the form 1. presented to the Board.

- 2. The President is authorized to execute the Agreement and deliver it to the

City.

4 Each of the President and Secretary-Treasurer is hereby authorized to take all such actions as may be required, necessary or convenient, to effectuate the transactions contemplated by the Agreement, including the filing of a Form 1295 as promulgated by the Texas Ethics Commission.
