The presiding officer, Chair David Robinson called the Transportation Policy Council (TPC) meeting of October 27, 2023 at 9:30 a.m. to order.

## ITEM 1 & 2 CERTIFICATION OF QUORUM AND INTRODUCTIONS

Chairman David Robinson recognized Ms. Allie Isbell, H-GAC, for the Certification of the Quorum and she conducted the Roll Call of the TPC membership. Fourteen (14) members comprise a quorum. A quorum was declared present and recorded on the Roll Call, which is included with these Minutes as Attachment 1.

Mr. Raborn requested approval of the establishment of the Select Committee on Planning Area and Composition and Appointments to the Select Committee. A lengthy discussion occurred after the presentation and included an explanation by Mr. Chuck Wemple regarding Proposition B. Chair Robinson asked for a motion. A motion was made by Mayor Kevin Cole and seconded by Mayor Joe Zimmerman. ## ITEM 9. PROPOSED ADJUSTED URBANIZED AREA BOUNDRY, MR. CRAIG RABORN/MR. PRAMOD SAMBIDI, H-GAC

Mr. Craig Raborn, H-GAC gave the Council an overview of the Urbanized Area Adjustment Basics. The adjusted urbanized area adjustment is conducted every 10 years and follows the Decennial Census. The purpose is to smooth out irregularities, maintain administrative continuity and encompass growing fringe areas with residential, commercial, or industrial significance. The impacts change roadways' Functional Classification and funding eligibility, federal or state funding allocation, performance measures, targets and reporting targets. The adjustment also affects urban/rural designation of Critical Freight Corridors and may impact MPO Planning area. This has not changed since 1974. Mr. Raborn also described Key "nontechnical" definitions which included Urban Area (Census), Urbanized Area (FHWA), Adjusted Urbanized Area (FHWA) and Metropolitan Planning Area (FHWA). Mr. Raborn introduced Mr. Pramod Sambidi, H-GAC who gave a presentation on the 2020 Census Urbanized Areas criteria. Mr. Sambidi elaborated on the Historic Census Urbanized Area 1970 to 2020 and gave specific information on the authorization by state and local officials to cooperatively adjust Urban Area boundaries and informed the Council of the potential MPO recommendations and informed the Council the Urbanized Area is growing and we are reaching outside the MPO County boundaries. Mr. Sambidi concluded his presentation with detailed information using maps as illustration. Mr. Raborn concluded the presentation by reviewing the maps presented by Mr. Sambidi. A lengthy discussion occurred after this presentation.

#### ITEM 10. PROJECT SELECTION PROCESS UPDATE, VISHU LINGALA, H-GAC

Mr. Lingala told the Council the 88 projects had been reviewed under the Regional Goods Movement Investment Category. 40 projects scored 50 points in the evaluation scoring that moved on to the Benefit Cost Analysis phase of the process. 38 Benefit Cost Analysis responses were submitted and 2 projects were withdrawn from consideration. Mr. Lingala concluded his presentation recapping the Benefit cost scoring and next steps in the process. The presentation was followed by a discussion.
