I. <u>OVERVIEW</u>

Per Umbrella Contract 582-12-13254, the Texas Commission on Environmental Quality (TCEQ) requested Public Outreach support from the Houston-Galveston Area Council (H-GAC) for E&W Bacteria TMDL project, with activities for all elements of Public Outreach including, but not necessarily limited to:

- Identifying and Reserving Facilities for Meetings and / or Events;
- Providing a Facilitator for Any Meetings (As Needed);
- Providing Support for Organizing and Advertising Meetings and / or Events;

Information Requests:

- Has TPWD provided any numbers / estimates on the total of different animals: wildlife, feral hogs, etc.?
- Are there federal BMP for silviculture? Yes, but not necessarily for private industry. Cutting / allowances for cutting?
- Is there an organized program to promote resources for private landowners? Yes Soil Board has some programs like this.
- Develop a good Fact Sheet for circulation.
- Why would this group benefit from joining the BIG?

Questions and Comments:

- "Wet Event" is monitoring that takes place within two days of rain; "Dry Event" is outside of two days from rain. The standard on the map is modified based on flow (the curved red line).
- Feral hogs are not considered "wildlife" by TPWD.
- More monitoring is needed in the upper portion of the East Fork. Private property monitoring? Winter's Bayou (sp?) and East Fork. Perhaps teaming up with an institution of higher learning.
- Need to add some Soil Board program information for private landowners. Soil Board tries to provide lots of CEU-earning programs to reach out to new audiences.
- Potential to do a "Watershed Stewardship" award for folks doing the right thing nominated by others. PR for local businesses?
- Would like to see more clarity / specifics in the 9 element table, specifically under implementation.
- How do we capture the successes of other programs and duplicate them? Potential opportunity for targeted program case studies for future scalable implementation?
- Specific areas of Sam Houston National Forest are no hunting areas Winter's Bayou (sp?) and Scenic Creek (??).
- SHNF is seeing significant illegal dumping of chemicals.
- SHNF would like to see more incentive programs for hog control. Bounties?

Meeting Outcomes:

- Group voted to change name from the Agriculture, Silviculture and Wildlife Workgroup to Natural Resources Workgroup.
- Group reviewed available data from the TMDL study.
- Group provided comments on data needed for future meetings
- Group given I-plan examples related to Monitoring and Research to review prior to next meeting.



• Group reviewed Time-Line and discussed plans to vote on whether to recommend to the Coordination Committee to join the BIG or develop an I-Plan during the next meeting.
