

# **Transit Subcommittee Purpose**



- Provide guidance related to the implementation of regional transit coordination pilot projects that were identified in the regional transit coordination action plan;
- Assist with tasks related to the development of regional transit planning initiatives that focus on identifying opportunities for expanding transit services in the region for all, as well as improving the efficiency and effectiveness of the current regional transit system;
- Promote regional coordination among existing and future public and private transportation providers, social service and health and human service agencies.



# Subcommittee Bylaws Highlights



- Maximum 18 members (9 transit, 3 Local Governments, 4 Social Services, 2 Citizen and Business Interests)
- Members and Alternate Members One year term
- Officers One year term; may serve up to two years consecutively
- Vacancies must be filled by TAC
- 50% is a quorum



# 4.2a. Regional Public Transportation Coordination Plan

# Background of the Coordination Plan

- Started in 2006 by TxDOT and is updated every 5 years
  - Federal coordination planning is required every 5 years
- FTA 5310 funding requires a coordinated regional plan
- Gulf Coast Region (16) has the same boundaries as the H-GAC 13-county region
- The Regional Transit Coordination Subcommittee (RTCS) is the entity that oversees the development and approval of the coordinated plan
  - Is the Regional Coordination Council (RCC) for our region
- H-GAC has and will conduct the study with staff resources, supplemented by consulting assistance
  - RTCS is integral to the process



# What Does The RPTCP Accomplish?

- Identify existing public transit and human service transportation in the region
- Consider regional transportation gaps and identify level of transit needs
- Strongly engage public for input
- Develop programs that enhance regional collaboration and remove boundaries for travel



# What Have the Coordination Plans Achieved?

- Harris County Rides
- Mobility Links
- General Transit Feed Specification (GTFS) support for smaller agencies
- Greater Regional Collaboration



# Additional Projects in Process

- Regional Transit Connectivity (i.e. fares) (ongoing)
- Regional Transit Information Study (underway)
- Regional Bus Study (starts mid-2025)
  - Originally recommended by High-Capacity Transit Task Force, RPTCP recommended expansion to all 13 counties in region



# RPTCP Current Update Highlights

- Grant application submitted to TXDOT March 2025
- Strong public outreach and engagement for a large region and post-COVID
  - Focus groups, in-person and online meetings
  - Website and online survey(s)
- Enhanced gap and transit needs analysis
- Will procure consultant for public outreach and designing gaps/needs analysis



### Role of RTCS

- Review reports/presentation of H-GAC staff at each meeting starting in July 2025
- Comment and feedback concerning reports
- Approval request for Final Report anticipated in July or August 2026

- Kickoff: June 2025
- Interim Phase: July 2025 January 2026
- Final Phase: February 2026 September 2026

- Kickoff: June 2025

- Final Phase: February 2026 September 2026

- Interim Phase: June 2025 January 2026
- Final Phase: February 2026 September 2026
  - Identify and prioritize unmet needs
  - Develop goals and strategies
  - Prioritize potential projects
  - Draft and final report

# Introduction - Free Fare Friday

- Commute Solutions celebrated its 30<sup>th</sup> anniversary with H-GAC this September
- Purpose of campaign was to encourage commuters to try transit and create a mode shift to reduce vehicle miles traveled across the region and improve the region's air quality.
- To incentivize the mode shift, fares would be covered by federal funds through H-GAC's Commute Solution program, providing commuters with an opportunity to try transit at no cost.



# **Partnering Transit Agencies**

- Commute Solutions partnered with 4 transit agencies:
  - The Woodlands Express
  - Conroe Connection
  - Harris County Transit
  - Fort Bend Transit
- Riders did not have to pre-purchase tickets, or register in advance



## **Overall Results**

- Grew overall awareness and education about commuting options in our region
- Ridership during non-free fare days were higher during month of September
- Compared to September 2023, transit agencies saw a 15% increase in ridership!
- Trends in ridership continued after the campaign
- Improved partnerships with local transit agencies



## Planning for 2025

- Opportunity to grow number of participating transit agencies
- Opportunity to include more days of the week
- Start communicating about campaign earlier
- Opportunity to continue educating and spreading awareness that public transportation can be a viable commuting option

## 4.3b. Regional Transit Ridership Update

## Background

- During the pandemic, H-GAC staff conducted a monthly survey of the effects of COVID-19 on regional transit agencies
  - Service adjustments
  - Mitigation efforts
  - Ridership
- Survey was ended at end of 2021 at agencies' request
- Subcommittee still saw value in monitoring regional ridership trends
- Current survey is conducted quarterly, collects monthly ridership as well as information about major service changes



## **Key Findings**


Regional ridership (all modes) continues to recover:

Year	2019	2020	2021	2022	2023	2024
Boardings	90,086,534	53,844,212	47,641,830	61,139,810	72,239,788	78,071,798
Share of 2019	100.0%	59.8%	<b>52.9</b> %	67.9%	80.2%	86.7%

- Local bus and demand response continue to show the most recovery; park and ride shows the least
  - METRO local bus ridership has almost fully recovered
  - METRO park and ride carried only 45% of 2019 ridership
  - Fort Bend Transit saw increase in P&R ridership (new service)




## Regional Fixed-Route Ridership Trends



METRO carried 98% of the region's fixed-route ridership in 2024




## Regional Non-Fixed-Route Ridership Trends



METRO carried 86% of the region's non-fixed-route (e.g. ADA paratransit, demand response, microtransit) in 2024

# AREA AGENCY ON AGING OLDER AMERICANS ACT TITLE III TRANSPORTATION SERVICES GRANT

For demand/response transportation designed to carry older individuals (60+) from specific origin to specific destination upon request. Older individuals request the transportation service in advance of their need, usually twenty-four (24) to forty-eight (48) hours prior to the trip. Trip purposes include:

- Medical Services
- Essential Shopping
- Senior Centers

H-GAC will pay Contractors on a unit rate reimbursement basis for services rendered.

Target Population, Service Area and Delivery



### **Target Population**

Individuals 60 years of age and older with special emphasis on service to those living in rural areas, with greatest social and economic need, minorities, severe disabilities, limited English speaking ability, and with Alzheimer's disease or related disorders

#### **Service Area**

The provider agrees to provide services identified in this Scope of Services in the Houston-Galveston Area Agency on Aging region: Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties.

#### **Service Delivery**

The provider must serve the entire county area identified and not just parts of the county area
