1. Introductions and Certification of Quorum

Roll call was read and attendance documented. Quorum has been met.

2. New Subcommittee Member Orientation Re-Cap – 10 minutes Mr. Patrick Mandapaka (H-GAC) will provide update.

Mr. Patrick Mandapaka provided a brief re-cap of the New Subcommittee Member Orientation provided earlier. He explained TPC, TAC, and how the subcommittees interact with them. Discussed the proposed "Investment Category Definitions," such as manage and expand categories, and proposed "Total Project Costs" to include the entire project development cycle. Mr. Beckom addressed questions throughout the presentation. Adam acknowledged some comments received from the subcommittee work group.

6. Regional Safety Program Update – 10 minutes Stephan Gage provided an update on the Regional Safety Campaign, regional vision zero policy, and performance measures.

Mr. Stephan Gage provided an overview of the Regional Vision Zero Policy and historical context with TxDOT, City of Houston, and Harris County Vision Zero efforts. Highlighted how the regional safety campaign and performance measures interact with Vision Zero. Stephan responded to questions throughout the presentation.

7. Congestion Management Process (CMP) – 10 minutes H-GAC staff will present active transportation related strategies within the CMP for discussion.

Alan Rodenstein provided a status update regarding the CMP. Alan provided a brief background and definition of congestion management. The purpose of the CMP is to identify congestion, mitigate congestion through implementation of management strategies, and evaluate the effectiveness of mitigation strategies. The CMP encompasses eight strategies. A draft report will be provided to the subcommittee with comments due in early January 2021. Mr. Rodenstein responded to questions throughout the presentation.

- Required by Federal Highway Administration
- Original written in 2007 with updates in 2013 and 2015
- Based on objectives of Regional Transportation Plan
- Develop metrics and identify problems
- Will be used for added capacity projects



Defining the CMP Process

Three key elements:

Identify congestion and its causes (in region)

Apply variety of mitigation strategies to improve system

Evaluate strategies' effectiveness and adjust accordingly



Public Comment Process

- 45-day public comment period started on November 22
- 115 + comments received from groups and individuals posted on website
- Bike Ped Committee very active commentator



Comment Summary

- Generally supportive towards overall approach of CMP
- Many comments emphasizing increasing role of active transportation
- Additional comments encouraging greater emphasis on multimodal solutions
- All comments will be addressed as we work to finalize the document
