9. UNITED PLANNING WORK PROGRAM AMENDMENT

BACKGROUND

The 2022-2023 Unified Planning Work Program (UPWP) describes the regional transportation plans and programs, and the transportation-related air quality planning activities that will be undertaken during the fiscal years 2022 and 2023. The current UPWP was adopted by the Transportation Policy Council (TPC) on August 27,2021.

CURRENT SITUATION

The Unified Planning Work Program (UPWP) is a two-year plan that runs from October 1,2021-September 30,2023. However, the UPWP does have a yearly close out date each year in September where H-GAC Transportation closes out completed projects, or carries forward projects that are still ongoing, or that are due to start in the next fiscal year.
