BRIEFING

The meeting started with a roll call to determine the members and/or alternatives present.

PUBLIC COMMENTS

No public comments were presented to the subcommittee.

ACTION ITEMS

Item 2 – Previous Meeting Summary

The last TIP Subcommittee meeting was the meeting held on May 5, 2021 as the meeting scheduled for June 2021 was cancelled. Members were referred to the May meeting summary posted on the H-GAC Website and asked to forward any corrections to Adam Beckom.

Item 3 – Development of the 2023-2026 Transportation Improvement Program Overview

Adam Beckom provided a brief report on the development of the 2023-2026 TIP document. This included an account of the background of the TIP program and a preview of the process and timeline for the completion of the new program.

Item 4. – Call for Project Development Update and Active Transportation Recommendations

Two members of staff gave presentations on this item. Vishu Lingala discussed comments on the call for projects that were received over the last month, while Susan Jaworski reported on the evaluation criteria for Active Transportation projects as proposed by the Bike-Ped Subcommittee.

(a) **Vishu Lingala**: The comments received are being reviewed by staff. Furthermore, comments that have policy implications will need to be referred back to the TPC for guidance. Responses to the comments will be provided to the Subcommittee in the August 2021 meeting.

The comments received touched on topics such as:

- Shifting funds from undersubscribed investment categories to Active Transportation.
- Adjusting evaluation criteria to permit rural projects compete better against urban projects.
- Change to score weights given to multi-modal project criteria.
- Applying safety criteria to reflect severity and not just total numbers.
- How connectivity to jobs applies to rural areas?
- How to define transitions between rural, suburban, and urban areas
- Potential benefit of changing the threshold definition of a major project.
- Transit reliability and the Expand project category.
- The Resiliency Matrix.
- (b) **Susan Jaworski**: The Bike-Ped Subcommittee recommends a split of 80% for Planning Factors and 20% for the BCA. Other recommendations include incorporating a sliding scale for the planning factors and the consistent use of the H-GAC ACE tool and the Regional Crash data for qualifying measurements.

Planning Factors: Broken up to 5 categories:

- Connectivity 39% (Max Score 62 points)
- Safety 25% (Max Score 40 points)
- Equity 24% (Max Score 39 points)
- Barrier Elimination 8% (Max Score 13 points)
- Innovation 4% (Max Score 6 points)

Each category was described in detail and supported by the rationale for recommended scoring plan.

<u>Benefit Cost Analysis</u> – The 2018 Call for Projects had 3 CBA Templates. Recommendations by the Ped-Bike Subcommittee are:

- Remove (discard) the delay benefits template;
- Revise the 2018 safety benefits template;
- Replace the 2018 emissions benefits template with improved version

Item 5. – FY 2022 Unified Transportation Program

Adam Beckom gave an update on the development of the FY 2022 UTP which is the statewide 10-Year Plan produced by TXDOT. A virtual public meeting is scheduled for July 7, 2021 and a public hearing for August 2, 2021. The UTP will contain a list of projects for the entire state and will include projects for the H-GAC region. The UTP will also outline the funding allocations for the next ten years. H-GAC staff will review the allocations when the draft document is available and will provide comments as necessary.
